Analysis of Equal Meals Tax Authority for Virginia Counties

Fiscal Analytics prepared the following estimate of additional meals taxes potentially available to counties if the General Assembly granted them the same taxing authority as cities in Virginia. Methodology used CY 2008 Virginia food and drink taxable sales adjusted by a ratio derived by comparing to actual meals taxes collected in localities. These adjusted sales were then multiplied by the highest applicable tax rate levied in the PDC in which the locality resides. For example, in PDC 8 the highest current meals tax rate is four percent, therefore the model applies a four percent potential rate to all localities adjusted food and drink taxable sales in PDC 8. Any amount from an existing county meals tax was netted from the total derived using the highest regional tax rate. In addition, the meals tax revenue from the 36 largest towns was also netted from county taxable sales. See **Appendix 1** for the complete meals tax estimate by locality.

Results: Additional \$225 million in meals taxes could potentially be generated by Virginia counties.
