# VACo issues preliminary summary of Gov. Timothy M. Kaine's proposed 2009-2010 budget recommendations

VACo has released its preliminary summary of Gov. Timothy M. Kaine's proposed 2009-2010 budget recommendations. The updated and full length version was e-mailed by VACo on Dec. 30, and is available on the Web (www.vaco.org).

The Web document highlights budget recommendations impacting local governments and includes key locality-by-locality spreadsheets.

The outline below targets only a handful of important recommendations.

#### **Budget Shortfall**

On Wednesday, Dec. 17, Gov. Kaine announced a revised 2009-2010 shortfall of \$2.9 billion. The shortfall may increase during the 2009 legislative session.

#### Gov. Kaine's key revenue measurers:

\*(\$71.6 million) in FY 2010 by eliminating the planned teacher and support staff salary increase.

\*(44.7 million) in FY 2010 by delaying a 2 percent state and state supported local employee pay raise.

\*Doubling the state Cigarette Tax to 60 cents per pack. The new funding will support Medicaid payments.

#### **State Job Eliminations**

more than 1,500 state government positions supported by the General Fund. More than 1,000 employees will lose their jobs.

Additionally, VDOT intends to eliminate approximately 900 positions.

### Proposed Budget Reductions Impacting Local Governments

In addition to the actions outlined below, counties and cities are required to comply with the previously enacted \$100 million Aid to Locality Reductions - \$50 million in FY 2009, and \$50 million in FY 2010.

### **Public Education**

Proposed public education reductions equate to greater than 9 percent. (The 9 percent figure compares Gov. Kaine's proposed FY 2010 spending against the adopted FY 2009 budget – adopted last spring).

\*(\$340 million) in FY 2010 to cap state funding for administrative support positions (non-instructional positions). The reduction equates to a 36 percent reduction of this classification or 13,000 state-funded positions. In the final analysis the state intends to fund one support position for every 4.03 instructional positions.

\*(\$55.8 million) in FY 2010 by eliminating the Lottery Funds for

school construction grants.\*
\*(\$27.5 million) by eliminating the school construction grant program.

### **Compensation Board**

\*(\$43.4 million) in FY 2010 by implementing across-the-board reductions of 7 percent for offices of sheriff and the commonwealth's

## CTB revised 2009-2014 draft transportation program available on Web

The Commonwealth Transportation Board (CTB) is completing an unusual mid-year revision of the Fiscal Years 2009-2014 Six-Year Improvement Program in response to the declining transportation revenues. The revision details \$1.3 billion in anticipated cuts to highway, public transit, rail, bicycle, and pedestrian projects and programs in response to a \$2.6 billion reduction in overall state and federal transportation revenue.

Additional reductions to the program are likely to follow as the recently announced December revenue reduction is addressed.

Reductions to administrative programs and other services will account for more than \$1 billion in cost cutting measures.

The draft program and lists of projects impacted by these reductions are available online at VirginiaDOT.org and DRPT.Virginia.gov.

### Fluvanna wins NACo green competitions

The National Association of Counties' (NACo) announced today that Fluvanna County, Va. is being nationally recognized for its leading efforts in promoting energy and fuel efficiency among their county employees and residents.

Fluvanna County won both the Change the World, Start with ENERGY STAR Campaign and the Drive \$marter Challenge in the small county category. The contests were sponsored by NACo, the U.S. Environmental Protection Agency (EPA) ENERGY STAR program, the Alliance to Save Energy, Office Depot and AutoZone.

Two hundred seventeen Fluvanna County residents and employees pledged to change 2,047 light bulbs in the Change the World, Start with ENERGY STAR Campaign while 225 people pledged in the Drive \$marter Challenge. As a result, Fluvanna County will receive 1,000 free compact fluorescent light bulbs (CFLs) to distribute throughout the county next year, courtesy of Office Depot. Fluvanna County will also receive 1,000 free bottles of fuel additive to distribute next year, courtesy of AutoZone.

Sixty five counties from 26 states participated in one or both of NACo's 2008 green county competitions which ran from July 1 to Nov 30.

Through the Change the World, Start with ENERGY STAR Campaign (www.energystar.gov/changetheworld), 7,135 county employees and residents throughout the country pledged to replace 72,199 incandescent bulbs or fixtures in their homes with a compact fluorescent light bulb (CFL) that has earned the government's ENERGY STAR label.

In the first year of the Drive \$marter Challenge, 5,964 county employees and residents participated to improve gas mileage and reduce emission of pollutants.

"The active participation in this year's green competitions exemplifies the commitment of our nation's counties to energy efficiency and environmentally friendly living," said NACo Executive Director Larry E. Naake. "We appreciate our partnership with Office Depot, EPA, AutoZone and the Alliance to Save Energy to promote energy efficiency in county governments."

Office Depot is also a founding sponsor of NACo's Green Government Initiative, which began in 2007. AutoZone is a supplier through the U.S. Communities Government Purchasing Alliance (www.uscommunities.org).

### Gov. Kaine announces \$500,000 in farmland preservation grants

Gov. Timothy M. Kaine recently revealed the distribution of \$500,000 to 11 Virginia localities to preserve farmland within their boundaries through local Purchase of Development Rights (PDR) programs, which compensate landowners who permanently preserve their land by voluntarily placing a perpetual conservation easement on it.

"Farmland preservation remains a priority for Virginia at both the state and local level," Gov. Kaine said. "Even with our budgetary restraints, we will continue to support PDR programs in every way we can. My Renew Virginia plan includes initiatives to protect our environment, and these PDR programs do exactly that."

Twenty-one local PDR programs exist in Virginia, seventeen of which have some level of local funding currently available. This is the second time that the Commonwealth of Virginia has provided state matching funds for certified local PDR programs.

Ten localities received \$49,900 each: The counties of Albemarle, Clark, Fauquier, Goochland, Isle of Wight, James City, Northampton, Rappahannock, and Spotsylvania plus the City of Virginia Beach. Cumberland County received \$1,000.

Grant applicants had to report how much funding was available for their local PDR programs as of Oct. 17, and the state funds matched that amount up to \$49,900 per locality. Currently, localities report more than \$43 million in non-state funding available for PDR programs, but state matching funds in 2009 are limited to \$500,000 total.

# B. Clayton "Clay" Goodman III chosen as Roanoke County's next chief executive



The Roanoke County Board of Supervisors appointed B. Clayton "Clay" Goodman III as county administrator on Dec. 16. Goodman succeeds John Chambliss, Roanoke County's

assistant county administrator who took over chief executive duties when long-serving administrator Elmer Hodge retired on June 30.

Goodman has more than 30 years of experience in local government, 19 of which were spent working for localities in or near the Roanoke Valley. Since December 2003, Goodman has served as county administrator of Montgomery County. Prior to his move to Montgomery County, Goodman worked as town manager of Vinton from April 1993 to November 2003 and city manager of Buena Vista from August 1988 to March 1993. He held similar positions in Georgia and West Virginia.



Chairman Richard Flora says the Board was impressed with Goodman on many levels including his years of experience, his ease in communicating with people and his strong ethics.

"Roanoke County was extremely fortunate," Flora said. "We had qualified and experienced candidates who applied for the position. After interviewing Clay it became clear he was the right person for the job. He is well respected throughout the region and beyond, knows our community, and will lead our county forward."

Goodman is equally excited to begin work in Roanoke County and says he is impressed with the excellent government services that the Roanoke County Board of Supervisors and Roanoke County staff have developed. "Roanoke County is known for its innovative and effective local government services, and I pledge to strive to continue, enhance, and strengthen these services by working with the citizens, Board of Supervisors, and staff," Goodman said.

Goodman is a native of Christiansburg. He received a Bachelor of Arts in Political Science from Virginia Tech in 1977 and a Masters of Public Administration from West Virginia University in 1980. He will begin work in Roanoke County within 90 days of his hiring. Goodman's salary is \$152,000 a year.

Goodman, who turned 54 on Dec. 16, and his wife, Connie, have a grown son and daughter who are graduates of William Byrd High School. Both graduated from college and are building their careers. He and his wife look forward to making their home in Roanoke County.

## Mullen in as interim county administrator



Louisa County officials have named County Attorney Dale G. Mullen as interim county administrator to fill in for C. Lee Lintecum, who recently announced his retirement.

Mullen, who will take over the county helm in January, was hired in September as county attorney. He previously served as chief prosecutor and special assistant United States Attorney, investigating and prosecuting health-care fraud cases.




Hatcher holds a Bachelor's Degree in Accounting with a Business Administration minor from Strayer University in Washington, D.C.

It's hard for Teresa Phillips to imagine today that for years Bath County did it the old-school way with paper and pencil and a map on the wall. Not when the county now is the proud home to a new Enhanced 911 dispatch center that's one of the finest in the Commonwealth.

"It's a whole different world," said Phillips, who is the county's 911 administrator.

In the past, dispatchers would pick up the phone to answer a 911 call, write the information on a piece of paper and use their index finger as a guide to find the location on a map. And if they were lucky, the standard caller ID box would register a number.

It required tremendous skill and experience of dispatchers to relay the information to emergency responders in a timely manner.

But that changed in late August when the E-911 system went live, complete with new equipment that allows dispatchers to see mapping information, phone numbers and addresses as well as gives them a place where they can type the details of the calls.

"It's so nice to answer a line and instantly have information come up," Phillips said. "We went from nothing to everything all at once."

The new 911 center, which measures 40x30 feet, was a vision that took some time to fulfill. For nearly a decade, the county recognized a need for a new facility. However, it wasn't until 2006, the year Bonnie Johnson became county administrator that the project became a reality.

"We began to look for alternatives after we stopped a project that was going to be more costly than we had budgeted," Johnson said. "We made a decision that a modern 911 center was in the best interest of the county and with the help of many, many people, we began the early stages of building a new facility."

Bath County officials decided to completely renovate an old garage that's

behind the sheriff's office. The garage had also been used as storage and office space.

The renovation, which included water-sewer, roof work and a gutting of the building, cost about \$300,000.

"We wanted to create a 911 center that was first-rate in every respect, equipment, training and personnel," Johnson said. "But we also wanted it to blend in with the historic courthouse. So many people have helped us get to the point where this center can function as a high-tech center and also reflect the historic fabric of the community."

Johnson again stressed that there were many who made the center possible, including the Bath County Board of Supervisors; Circuit Court Judge Humes J. Franklin, Jr.; Jerry Rexrode, member of the Highland County Board of Supervisors; Sheriff Larry Norfleet; former Sheriff Charles T. Black; former

### VML/VACo Finance elects officers for 2008-09

Robert E. Claytor, director of Fiscal Services for Rockbridge County, has been elected president of the Virginia Local Government Finance Corporation (VLGFC) by its Board of Directors. # CTB sets public hearings for updating six-year improvement program



The Commonwealth Transportation Board (CTB) has scheduled five public hearings to be held around the state in January so that citizens may review potential revisions to the Six-Year Improvement Program for Fiscal Years 2009-2014. This mid-year revision of the fiscal year 2009-2014 program is in response to transportation revenue reductions of more than \$2.6 billion resulting from the downturn in the economy.

CTB members will host the hearings, and representatives of the Virginia Department of Transportation (VDOT) and the Virginia Department of Rail and Public Transportation (DRPT) will be present to provide information and answer questions.

"We are holding this unusual mid-year revision of the six-year program because of the significant changes in the official transportation revenue estimate," said Secretary of Transportation Pierce Homer. "While this revised plan cuts \$1.2 billion from our six-year program, we know that additional cuts of approximately \$400 million will be necessary before this plan is brought before the CTB in January."

These reductions are a result of reductions in the official state transportation revenues and in addition to \$1.1 billion in cuts made last June when the six-year plan was approved. All transportation agencies are making other reductions in the programs and services they provide.

attorney, and 10 percent for offices of the commissioners of the revenue, treasurers, directors of finance and circuit court clerks.

\*Amendments to the budget propose changing the distribution of excess fees collected by Clerks of the Circuit Courts. Currently, localities retain two-thirds of the fees and the Commonwealth receives one-third. The proposed budget flips the distribution for FY 2010 by appropriating two-thirds to the state and one-third to localities.

### HB 599 funding

\*(\$22 million) total in FY 2009 and 2010 for HB 599 payments. The FY 2010 reduction equates to a 7 percent cut against FY 2009 payments.

Comprehensive Services Act (CSA) \*(\$500,000) in FY 2009 and (\$500,000) in FY 2010 by eliminating funding for grants to localities intended to encourage localities to create

community based services. \*(\$700,000) in FY 2009 and (\$1.3 million) in FY 2010 by reducing the number of children placed in out-of-state residential facilities.

#### Medicaid

\*(\$10.8 million) in FY 2010 in general funding and (\$2 million) in non-general funding by eliminating the State/Local Hospitalization (SLH) program.
\*(\$5.84 million) in FY 2010 in General Funds and (\$5.84 million) in Non-general Funds by delaying implementation of 200 mental retardation waiver slots that were scheduled to be released on April 1, 2009.

#### **Social Services**

\*(\$1.2 million) in FY 2010 by reducing the family foster care rate increase to 6 percent in FY 2010. The 2008 Appropriation Act increased the foster care rate by 15 percent in FY 2009 and an additional 8 percent in FY 2010. This strategy would lower the FY 2010 increase from 8 percent to 6 percent.

### **Transportation**

The CTB began re-programming transportation funding, including the six-year improvement program, on Thursday, Dec. 18. (Please see the related story in this edition of County Connections about the CTB's proposed program changes and associated public hearing dates.)

### Central Appropriations/Virginia Retirement System

Language in the budget affecting actuarial assumptions of local government pools: In the second year, as an alternative to the employer contribution rates certified by the VRS Board of Trustees pursuant to [the Code of Va.], rates paid to the VRS on behalf of employees of participating political subdivisions may, at each participating employer's option, be based on the results of the June 30, 2007 actuarial valuation of assets and liabilities assuming an investment return of eight percent, a cost of living increase of three percent, and an amortization period of 30 years.

County Administrator Claire Collins; Building Official Andy Seabol; County Attorney Michael Collins; the Bath County Service Authority; the Wireless Board; Planning Director Sherry Ryder along with the Planning Commission and the Board of Zoning Appeals; consultants and contractors including Spectrum Design, the Timmons Group, Lionberger Construction, and BARC Electrical Cooperative.

This distinguished group and the public were invited to the open house in November and were awed by the center's capabilities.

"I think there was a lot of pride at the center that afternoon," Phillips said.

The potential of the new facility to help avert trauma and injury were demonstrated when emergency responders arrived in minutes at the scene of a construction accident that involved a man and a concrete truck. Thankfully, the injuries were minimal, but the 911 center had done its job in to



help reduce response time and deliver help where it was needed.

"We think we have a fantastic tool and already it has proven to be just that," Johnson said. "We have a lot of tourists in Bath County, some get lost or need gentle assistance. They can call 911 for any reason and we can help them. Also our population is an aging one and we're spread out over 540 square miles with mountains. This system will allow us to cover more ground much, much quicker."

The E-911 system also can field

wireless calls and will include a citizens' alerting system called CodeRed, which Phillips hopes will be implemented very soon. The alerting system can target and notify people in a specific area of an emergency like flooding. It can also help spread the word when a child or elderly person is lost.

A grant application was approved by VDEM that is paying for the first two years of the alerting system.

"This is a building and a center that welcomes you and makes you feel comfortable," Johnson said.
