# The President's Post

#### One more way to serve

Elected county officials across Virginia often wear more than one hat as part of their duties and responsibilities. Planning District Commissions,



hospital boards, appointments to state boards of local interest are but a few of the opportunities for county officials to further serve the interests of their constituents and bring the local perspective to regional and statewide bodies. VACo can help.

The six Virginia members of the Local Government Advisory Committee (LGAC) to the Chesapeake Executive Council are appointed by the Governor to represent the Commonwealth; currently, four of those six members have strong VACo connections. Supervisors Ruby Brabo (King George County) and Janine Burns (Mathews County), and Larry Land (VACo staff), were appointed to LGAC by Governor McAuliffe last fall; I was reappointed by the Governor, and have served on LGAC since my initial appointment by Governor Mark Warner. It is Virginia's turn to chair LGAC, and Janine Burns was elected earlier this month to chair for the coming year. Ruby Brabo continues to serve as vice chair of LGAC's Virginia delegation.

LGAC meets quarterly around the Chesapeake Bay watershed, joined by local elected officials from Maryland, Pennsylvania and the District of Columbia, as well as EPA staff from the Chesapeake Bay Program, which provides funding for LGAC activities.

# VACo asks Governor McAuliffe to modify or eliminate state's seizure of local fines & forfeitures



VACo is working in advance of the General Assembly's reconvened session on April 15 to reduce or eliminate a budget amendment that expands the number of localities subject to state seizure of local fines and forfeitures. VACo sent a letter on Monday, March 16 asking the Governor to send down an amendment for the reconvened session that will reduce any transfer of local fines and forfeitures to a minimal amount this year. VACo also asked the Governor to work with localities to eliminate this mandate in the next proposed budget.

The amendment request concerns the state's seizure of a portion of local fines and forfeitures, a practice begun by the 2012 General Assembly and determined by the State Inspector General in 2013 to be legally unjustified. The practice continues because language authorizing it remains in the Appropriations Acts.

The 2015 General Assembly approved a budget amendment altering the current formula and greatly increasing the number of localities forced to donate a portion of their fines and forfeitures to the state (from five jurisdictions to 33 next year - a more than 500 percent increase). For our member counties, the policy change moves from impacting one county to 16 counties next year. The amendment also increases the amount of fines and forfeitures taken by the state over three years.

VACo understands that these local dollars are not recognized in the HB 1400 conference report and thus no state spending depends on this local money. VACo is requesting that the Governor send down an amendment to reduce the current amendment's impact by changing the amount collected by the state to the total collected by the District Courts less 90 percent (as opposed to 65 percent in the approved budget). Making this change would decrease the number of affected communities from 33 to 3 and cap the amounts going to the state to no more than \$25,000 in FY 2016. VACo is advocating for complete repeal of the mandate in next year's budget.

Discussions to include representation from the headwaters states of West Virginia and New York are underway. There are 1800 or so units of local government, and 600-plus mostly volunteer organizations, in the watershed, all trying to work together, somehow, to help restore the Chesapeake Bay.

It is a daunting task, but one that has economic, as well as environmental, benefits. Expanding public access to the Bay may mean installing a new boat ramp or trail that will help increase tourism, thereby adding new dollars to the local economy. Tree planting and riparian buffers bring a lot of "bang for the buck," reducing storm runoff, lowering energy costs, meeting national ambient air quality standards. But they also encourage collaboration among governments, nonprofits and individual citizens to get the job done. # Frederick County hires new Administrator

Brenda Garton is the next County Administrator in Frederick County, it was recently announced. Garton begins her tenure on May 18 and replaces longtime County Administrator John R. Riley, Jr., who retired in January.

It is only the second time since the late 1970s that Frederick County has filled this vacancy.

Garton currently holds the top administrative job in Gloucester County, a position she's been in since 2008. She also served as County Administrator in Orange County (1993-2002) and Prince George County (2002-2008).

Frederick County received 41 applications and the Board of Supervisors conducted interviews with six candidates. Garton was selected from three finalists.

Garton began her career as a mathematics teacher in Albemarle and Orange counties. She is a certified public accountant and has worked as a manager in an accounting firm. She worked as controller and manager of plant administration for Edgcomb Metals located in Troy, Virginia.

Garton earned a master of education degree and a bachelor of science in education degree from the University of Virginia. She is married to Accomack County Administrator Steve Miner.



# **Arlington County Manager Donnellan to retire**

Arlington County Manager Barbara M. Donnellan announced on March 13 that, after serving the Arlington community for nearly 32 years, she is retiring.


"It has been my honor and pleasure to serve Arlington County," said Donnellan. "While I feel in my heart that I could lead this organization for many more years, it is the right time for me to retire and start a new chapter in my life. We have an excellent leadership team in place, and I have every confidence that I will leave Arlington in great hands."

Donnellan's last day on the job will be June 30, 2015. County Board plans to name Deputy County Manager Mark Schwartz as Acting County Manager before conducting a national search.

#### Named County Manager in 2010

In October, 2010, the County Board named Donnellan County Manager. Under Donnellan's leadership, Arlington County has successfully implemented nationally-recognized Smart Growth planning policies and continued the sound financial policies that have earned the County its triple-triple-A bond rating for many years.

She has worked on several key public/private partnership projects for the County, including: Ballston Garage; E-Trade; Shirlington redevelopment; Gates of Arlington; US Airways; Washington Capitals; and Rosslyn BID development.



"Barbara has been the consummate professional County Manager," said Mary Hynes, chair of the Arlington County Board. "She has kept her eye on the needs of Arlingtonians — residents and businesses — and given her heart, her intellect, and her passion to serving this community for more than 30 years. All five County Board members are tremendously grateful to her."

The County Board plans to name Deputy County Manager Mark Schwartz as Acting County Manager and will embark on a national recruitment for a new Manager. The search will be coordinated by Board Members Jay Fisette and Libby Garvey. "We are confident that Mark will do a great job and provide strong leadership continuity for Arlington," said Chair Hynes.

#### Regional leadership

Donnellan is a leader in the Metropolitan Washington Council of Governments (COG), which brings together area leaders to address major regional issues in the Washington Metropolitan Region. She currently serves as chair of COG's Chief Administrative Officers Homeland Security Executive Committee. In Oct. 2014, she received COG's 2014 Visionary Leadership Award, a prize that recognizes top government officials for their outstanding contributions to metropolitan Washington and their home jurisdictions.

Three governors have appointed Donnellan to the Board of Directors of the Virginia Resources Authority (VRA) and she is a current Board Member. In 2013, Leadership Arlington awarded Ms. Donnellan its Community Impact Award for her "visionary guidance and dedication to Leadership Arlington and the Arlington Community." In 2009, Leadership Greater Washington presented Ms. Donnellan its highest honor —the Fannie Mae Volunteer of the Year Award, honoring her for her role in expanding the Youth Leadership Greater Washington program through enhanced planning, fundraising and recruiting. She also has served as a volunteer for Arlington County Meals on Wheels and for other community boards.





# **DEQ** convenes study group on stormwater

The Department of Environmental Quality has convened a special Stakeholder Advisory Group (SAG) to consider additional amendments to Virginia's Stormwater Management Act during the 2016 General Assembly.

SAG held its second meeting on March 16. Six more meetings are scheduled between April and September. SAG's chief objective is to recommend legislative changes that will streamline and clarify provisions in Virginia's laws relating to stormwater management. Virginia's three chief statutes containing stormwater requirements are the Stormwater Management Act, the Erosion and Sediment Control Law and the Chesapeake Bay Preservation Act.



Despite various pieces of legislation enacted by the General Assembly over the past 10 years to integrate and streamline stormwater provisions in those three statutes, there continues to be ambiguities and apparent conflicts in language that have confused not only local stormwater managers, but key DEQ staff responsible for overseeing Virginia's stormwater programs.

SAG's chief objective will be to finally solve these problems once and for all.

SAG is comprised of representatives from local government (including VACo and the Virginia Municipal League), along with agriculture, the development and engineering communities and environmental organizations.

The Stormwater SAG's next meeting is scheduled for Friday, April 17, 10 a.m. to 4 p.m. at the DEQ Piedmont Regional Office in Henrico County.




## VACo files comment on possible new rules for animal shelters

An organization known as the No-Kill Advocacy Center (NKAC) has petitioned the Virginia Department of Agriculture and Consumer Services (VDACS) for a new rule-making that will require public and private animal shelters to maintain more detailed records relating to when and how each animal is taken into custody.

The petition also requests that more detailed records be maintained relating to the "kinds of care and treatment each animal received, including veterinary treatment, the disposition of each animal, and if the animal was killed, (and) when and why the animal was killed."

In reaction to NKAC's petition, 607 comments have been filed with VDACS. One commenter is VACo. In a letter sent to VDACS on March 13, VACo expressed concern about how counties would be fiscally and administratively affected by this rule-making, especially if it results in the prohibition on, or additional restrictions on, the ability of public animal shelters to administer euthanasia as a final resort after all other alternative remedies have been pursued.

# Visit Wise County and Interstate #101 Car

# Step back in time... Visit the 101 Car in Big Stone Gap, Virginia

Interstate Railroad Private Car #101 has a long and illustrious history. Built in 1870 for the South Carolina & Georgia Railroad, the car and the railroad were acquired by Southern Railway in 1899. It was then rebuilt and placed into service as Office Car #117.

In 1912, Southern swapped the car to the Virginia & Southwestern Railroad in Bristol, Virginia, for a similar car owned by the V&SW. It became V&SW #100 and was assigned to Bristol for the next four years.

In January, 1916, President H.L. Miller of the Interstate Railroad approached Southern Railway, V&SW's new owner, regarding the car. A deal was struck, and the car became Interstate Car #100. The purchase price was \$3,500.

As Interstate #100, the car was used extensively for inspection trips and off-line trips until 1924, when the railroad acquired another second hand office car from Southern Railway. The "new" car was given the treasured number of 100, and the old wooden car was renumbered to #101. The newer car was subsequently sold by the Interstate in 1936, and car 101, was retained for official use thereafter.

In 1959, this well-traveled vehicle was retired and transported from Interstate's headquarters at Andover to Dorchester Lake on Black Creek in Wise County, Va. for use as a hunting cabin. These properties were subsequently purchased by Humphrey's Enterprises, who donated #101 to The Gap Corporation in 1988. A successful community based fundraising effort resulted in the car being moved to Big Stone Gap where it was restored to its present condition and placed in service as the Lonesome Pine Regional Tourist Information Center.

The car is an excellent example of typical passenger car construction for the late 19th century. As built, it contained an observation room, two state rooms, a dining area, facilities for the porter and a kitchen area. Most of the original fixtures are intact, including the lavatories, lighting fixtures and even the speedometer in the rear observation area.

Every effort has been made to retain the original appearance of the car, including the paint scheme and several fixtures that had to be fabricated from original drawings. The only departure from a faithful restoration has been the trucks (wheel sets) which are of a more modern design that the originals. Given the rarity of such components, this concession can be easily forgiven.

With the restoration complete, the car is poised to enter its new career, one that will soon span three centuries.

#### **About Big Stone Gap and Wise County**

During the 1870s, much was published about the mineral and timber resources of the Appalachian Mountains. General John Imboden focused on Three Forks as the location for industrial development, touting it as the "new Pittsburgh of the south." The town, which was then being called "Mineral City" was incorporated as Big Stone Gap in 1882.

Many developer's flocked to Big Stone Gap. These included Rufus Ayers, the Goodloe and Wood brothers, the Slemp and the Fox family.







John Fox Jr. wrote about his experiences in "The Gap" and the surrounding region in his 12 novels and 45 short stories. He became the most poplar American novelist of his time and immortalized Big Stone Gap in his novel "The Trail of the Lonesome Pine." In modern times, Big Stone Gap is best known for a series of novels by hometown author Adriana Trigiani. In addition to the two best-selling authors, the town has produced the private secretary to President Calvin Coolidge, a governor of Virginia, numerous artisans and musicians, a Grammy-winning recording studio, two NFL running backs and many others who have contributed to our state, nation and world!



#### Office of Intermodal Planning and Investment Announces Designated Growth Area Grant Assistance Program Extension and New Details about HB2 Needs Assessment Opportunities

The Office of Intermodal Planning and Investment (OIPI) recently launched a <u>technical assistance program</u> to provide support for localities interested in designating growth areas in their comprehensive plans per the current Urban Development Area (UDA) legislation (§15.2-2223.1). In response to concerns regarding the application deadline, the office is extending the application period for this direct on-call assistance for 5 months. Applications will now be accepted through August 31, 2015.

OIPI is also increasing flexibility in how designated growth areas are being included in the VTrans2040 Multimodal Transportation Plan (VMTP) needs assessment, which will serve as the CTB's first screening criteria for projects submitted for HB2 funding. Under the HB2 legislation, projects considered for funding will have to meet a transportation need as defined in the statewide plan for Corridors of Statewide Significance, Regional Networks or UDAs.

Through research conducted throughout the fall of 2014, OIPI identified many localities with designated growth areas that appear to meet the objectives of the UDA legislation. These designated growth areas may be village centers, suburban activity areas, economic development hubs or any other kind of strategic policy areas designated for future growth that are UDA-like areas without being formally designated as UDAs. In order to maximize the opportunities for localities to receive funding under HB2, OIPI will interpret any designated growth areas that have a comprehensive plan reference to the UDA legislation as qualified for HB2 screening, even if they are not named as UDAs. Previously designated and newly designated UDAs will of course also qualify to apply for this funding.

The Office is asking that localities who want their growth areas to qualify for HB2 transportation funding to add this code reference by October 1, 2015 to ensure adequate time for processing prior to the call for HB2 project nominations. UDAs and UDA-like designated growth areas with the proper code reference submitted after October 1 will still be included in the VTrans2040 Needs Assessment in an ongoing fashion; however they will not be considered in the first round of HB2 project screening.

This flexibility increases the opportunity to coordinate local transportation planning and land use decisions regardless of the locally selected name for these designated growth areas. This enhanced opportunity for coordination, both through the assistance program and the availability of transportation funding to promote UDAs through HB2, will help localities enable development that supports more efficient use and management of our transportation system.

The Office encourages localities to assess if they have any UDA-like areas that meet or are close to meeting the requirements of the UDA legislation, and if so to consider using the assistance program to help update their designated growth areas and/or add this code reference to maximize future funding opportunities. # VTRANS 2040 MULTIMODAL TRANSPORTATION PLAN KICK-OFF ANNOUNCEMENT - SPRING 2015 -

In April 2014 the Office of Intermodal Planning and Investment (OIPI) began work on VTrans2040, the Commonwealths guiding policy for long-range statewide transportation plans and programs. For the first time, VTrans2040 will include two complementary documents. First, the VTrans2040 Vision document, which includes an updated Vision, Guiding Principles, Goals, and Objectives. The Vision document reflects the priorities and concerns of the Administration and includes the input we've received from you and other stakeholders across the Commonwealth. This material has been presented in draft to the Commonwealth Transportation Board (CTB) and will be available for public review soon.

econd, the VTrans2040 Multimodal Transportation Plan (VMTP) will identify the multimodal transportation needs and recommendations for 2025, as well as a discussion of potential future scenar ios for 2040. It will replace the 2035 Virginia Surface Transportation Plan, which focused on highway and transit systems but did not address other modes. The VMTP will provide a multimodal needs analysis, including a statewide assessment of multimodal system maintenance and safety needs based on recently completed agency analyses, and an assessment of 2025 projected operational and capacity needs for Corridors of Statewide Significance, Regional Networks and Urban Development Areas. This needs assessment is a critical input to the HB2 project rating process per the 2014 legislation. At this time, we are kicking off the second phase of the VTrans2040 process and plan to start collecting data and gathering your input to better inform the final VMTP.

As shown in the project schedule on the following page, the development of the VMTP Needs Assessment includes a constant and consistent outreach effort to ensure that our planning partners across the Commonwealth are working closely with us to develop a vision for the future of transportation. These outreach efforts will ensure that each region's unique characteristics are specifically incorporated into the final VMTP. More information regarding the scenario development for 2040 will be forthcoming.



NACo releases model ordinance and application checklist to help counties comply with new FCC Order on wireless facilities siting: On March

5, NACo released materials to help counties comply with the Federal Communications Commission's Order on

wireless facilities siting, which takes effect on April 8.

The new Order will require counties to comply with new rules that will impact their planning and zoning authority. NACo worked with several industry and local government groups to assist counties on the requirements of the new Order.
