On January 4, VACo and VML cosponsored the 2017 Finance Forum, which provided insight from speakers with diverse expertise on the fiscal issues pressing localities in light of Governor Terry McAuliffe's budget proposal and the coming General Assembly Session.

Betsey Daley, Senate Finance Committee Staff Director, spoke first, providing an overview of the budget. She noted the Governor's proposal reflected net revenue and spending reductions, highlighting the Rainy Day Fund as a source to cover \$567 million of the two-year budgetary shortfall. Budgetary reductions to address the shortfall included removing the December 2016 pay increases, across-the-board agency savings, additional lottery proceeds for K-12, and higher education cuts. Major proposed spending covered the following areas: growth in the Medicaid forecast; growth in the Children's Services Act; the state's share of a 1.5 percent bonus for state employees, state-supported local employees, SOQ-recognized teaching and support positions; and mental health services. Daley pointed out potential areas where the General Assembly may make changes to the Governor's budget, such as potentially replacing the proposed bonuses with salary increases and restoring targeted cuts, such as the reduction proposed for GO Virginia. Daley also noted other likely topics of discussion during the 2017 session, including the Commonwealth's role in assessing local financial stress, possible legislation on short-term rentals (Airbnb), the potential for tax reform, and retirement and pension reform.

Jim Regimbal, President of Fiscal Analysis Ltd., presented on the new budget's impact on localities. While Daley provided a general overview of the budget, Regimbal's analysis focused on the aspects most relevant to localities. He noted the state's underfunding of K-12 education—when adjusted for inflation and population, current per-pupil direct aid funding is approximately \$600 less than in 2009. Regimbal highlighted the decreased state support for many locally-administered mandated programs, a situation due in part to growth in General Fund revenue increasingly failing to match rising Medicaid costs. He stated that the Commonwealth must take up more funding responsibility or provide localities with capacity to generate the revenue themselves. Here, Regimbal sees an opportunity, or rather the necessity, for a modernized tax code.

Ann Battle Macheras, Vice President of Regional Research and Economic Education at the Richmond Federal Reserve, gave an overview of economic growth in the United States and Virginia. On a national scale, Macheras demonstrated the economy's moderate growth with historic and projected figures for real GDP and labor force statistics. In comparison, Virginia's economy has maintained growth rates close to national levels, slowing down more recently; however, Macheras noted that the data could improve with revisions.

Other speakers included Tim Ryan, from the Greater Williamsburg Incubator, and Amanda Jarratt, from Franklin-Southampton Economic Development. Each highlighted their respective localities' business incubators and centers to support local entrepreneurs. VACo's Gage Harter and VML's Nancy Chafin briefly included tips to stay up to date with legislation during the upcoming General Assembly Session.

# Goochland County appoints McGee as County Attorney

The Goochland County Board of Supervisors is excited to announce the appointment of Tara A. McGee as Goochland County's new County Attorney.

McGee comes to Goochland County with more than 25 years of legal experience, 18 years of which are in the field of local government law. McGee most recently served as Senior Assistant County Attorney for Chesterfield County. Prior to Chesterfield County, McGee was associated with Williams Mullen as a Litigation Associate. McGee is an active member of the Local Government Attorneys Association of Virginia (LGA), serving on the LGA Board as a Director At-Large, Secretary, and currently as Treasurer. In addition, McGee has recently served as Adjunct Faculty to the Masters in Public Administration Program at Virginia Commonwealth University.

Goochland County Board of Supervisors Chairman Robert H. Starting with this issue, we are introducing a new Q&A Feature that will profile a VACo member each month. Henrico County Manager John Vithoulkas is the first. Get to know John and watch this space for more profiles.

**Q1.** You have been serving on the state Commission on Employee Retirement Security and Pension Reform. One of the topics discussed has been the issue of compensation for state employees and the need to recruit millennials and other younger staff to succeed employees who are ready to retire. What drew you to working in local government?

**JV:** I had a professor in college who talked me out of going to law school and he sent me to work an internship at the City of Richmond. This was the late 1980's. After that internship, I was hooked on serving in the public realm.

Q2. What trends have you seen in the local workforce during your time in local government?

**JV:** In my opinion, the local government workforce is more engaging, less bureaucratic and more driven to serve than at any other time in my public service career. This workforce is incredibly dynamic and we now have four generations of employees serving together. Those generational perspectives offer some incredible opportunities for quality and efficiency gains.

Q3. What strategies do you think localities can use to encourage young workers to see public service, especially at the local level, as a viable career option?

**JV:** I believe that younger workers are driven by a sense of purpose that we have an obligation to fuel. I made a commitment to a gentleman who gave me my first break in local government many years ago to "pay it forward" by doing for many what he did for me. To this end, since becoming county manager in Henrico, the county has hired over 250 student interns and now a good number actually work for the county. In some areas of the organization, we are actually growing our own workforce.

**Q4.** You are a product of Henrico County Public Schools and a graduate of JR Tucker High School. You know Henrico County so intimately. How does that knowledge serve you as County Manager? What is it like to lead your home county?

JV: It's incredibly humbling. I love my home, Henrico, and have given the county my all. I will do that until I can give no more. Along the way, I have had some incredible memories. One that stands out involves my mother calling me in the office after a friend called her to let her know of an occurrence within the county. The conversation involved my mother scolding me and saying, "now Johnny (in Greek it's Yianni) – you had better fix that problem because I don't want any more calls from my friends." Our Board of Supervisors has very high expectations. In this county, I must meet their expectations as well as those of mama V.

**Q5.** You earned a bachelor's degree in political science from Virginia Commonwealth University and a master's degree in public administration from the University of North Carolina at Charlotte, but you joined Henrico County as a budget analyst. How did you get into the finance side of local government?

**JV:** Early in my career, I realized that the one place where you could understand the entire organization was within the budget office of a locality. The first budget I worked on was for Gaston County, North Carolina and through a number of years, I realized that I have total clarity in the financial realm.

But at the end of the day – everything fiscal must be simple. What I excelled at - I believe – was explaining the underlying financial picture, or developing financial plans that made sense to the average person.

**Q6.** What advice would you give to new county administrators?


JV: Trust your people. Follow your heart. Stay away from the gray.

**Q7.** What are some challenges facing your community in the next ten years?

**JV:** Just like many communities, Henrico is aging and becoming more diverse. This creates some incredible opportunities for outreach and citizen engagement that we will meet. Maintaining our public infrastructure will continue to be difficult as the state divests more and more of its responsibilities to local governments. With sound fiscal planning, and conservative budgeting, those challenges will also be met. Finally, development and redevelopment of our community requires a business friendly approach that our workforce must project every time there is an interaction with a citizen. We will continue to meet this challenge by hiring the best of the best to work for our county.

Ultimately, the challenge for all of us in local government is working to create that sense of place, community – that the resident and business can feel proud to call home. It's not complicated – it just takes much hard, good, consistent work.

# Local Officers and Employees - Statement of Economic Interest, Financial Disclosure and Real Estate Disclosure forms due by January 15

The Conflicts of Interest and Ethics Advisory Council has circulated revised forms and guidance for the January 2017 filings. Prior to assuming office or taking employment, each person listed below must file their required disclosure form. Thereafter, they must file annually on or before January 15. Guidance on filing out the forms can be found on the Council's website, found at <a href="http://ethics.dls.virginia.gov/filing-resources.asp">http://ethics.dls.virginia.gov/filing-resources.asp</a>. Local officials file paper forms with the clerk of their governing body. Please note that the lists below only list mandatory filers; your locality may require additional persons to file.

#### The following local officials are required to file the State and Local Statement of Economic Interests per § 2.2-3115:

- Members of the Board of Supervisors
- Members of the City Council
- Members of the Town Council, if the town has a population exceeding 3,500
- Members of the school board
- Persons holding positions of trust appointed or employed by the governing body if the governing body has passed an ordinance requiring them to file
- Persons holding positions of trust appointed or employed by school board if the school board has adopted a policy requiring them to file
- Members of the governing body of any entity established in a county or city with the power to issue bonds or expend
  funds in excess of \$10,000 in any fiscal year if the governing body of the appointing jurisdiction has required them to
  submit this form

#### The following local officials are required to file the Financial Disclosure Statement per § 2.2-3115:

- Members of the governing body of any entity established in a county or city with the power to issue bonds or expend funds in excess of \$10,000 in any fiscal year unless required to file the Statement of Economic Interest by the governing body of the appointing jurisdiction
- Nonsalaried citizen members of local boards, commissions, and councils if the governing body has designated them to file.

#### The following local officials are required to file the Real Estate Disclosure per § 2.2-3115 (G):

- Planning commission members
- Members of board of zoning appeals
- Real estate assessors
- County, city, or town managers
- Executive officers
