Money Committees Release Budgets



On February 5, the House Appropriations and Senate Finance Committees met to present their respective budget proposals. The <u>House</u> <u>Appropriations Committee</u> and <u>Senate Finance Committee</u> released the full text of their budget amendments on February 7, and the full House and Senate will vote on their respective budgets on February 9. Traditionally, the next steps in the budget process are that each chamber will reject the other's budget and budget conferees will be appointed to begin negotiations on a conference report.

While neither committee directly increased the official revenue estimates, both added resources to the general fund budget through policy adjustments and nongeneral fund transfers to the general fund.

The Senate Finance Committee added \$73.2 million General Funds (GF) primarily by increasing the tax amnesty program revenue estimate by \$31.3 million; increasing available ABC profits by \$15.7 million; and providing additional transfers from nongeneral fund sources (such as \$5.9 million from the Emergency Medical Fund, \$3.9 million from the Trauma Center Fund, and \$3.1 million from the UVA/MCV teaching hospitals). The House Appropriations Committee added \$81.1 million in GF resources primarily by using \$43.4 million in nongeneral fund VRS payments by higher education institutions and teaching hospitals for operating expenses; increasing available ABC profits by \$20.4 million; and reverting \$10 million in capital planning funds and other miscellaneous balances and transfers.

The House also spent down the \$16.1 million introduced budget unappropriated balance to \$1.9 million, while the Senate left \$14.5 million. The Senate also sets aside a \$40 million unspent revenue reserve. In addition, the Senate budget contains language that diverts 50 percent of any statutorily undesignated year-end revenue surplus for deposit to the Rainy Day Fund.

Linked here is a preliminary overview of the key elements in both budget proposals of interest to local governments. As was reported in the days leading up to the budget release, both the House and Senate have sought to make employee compensation a priority, but differ in their approaches to teacher salary increases. VACo staff will review the text of budget amendments and will provide more details as the budget process continues.

Governor McAuliffe addresses more than 250 attendees at County Government Day

Governor Terry McAuliffe addressed more than 250 county elected officials and staff during VACo's County Government Day.

He encouraged leaders to "get into the game" when it comes to education. The Governor told the capacity crowd that there are 36,000 cyber jobs open today with an average starting salary of \$88,000. The Governor said that this is a huge jobs opportunity for parts of the Commonwealth that have lost jobs and tax dollars in furniture, textiles, tobacco and coal.

The Governor also highlighted his administration's economic development efforts, including the recent announcement of Nestle USA relocating its U.S. corporate headquarters to Arlington County. The move will create nearly 750 new jobs.

Remembering Richard W. Glover 1934 - 2017



Henrico County is honoring the memory and service of longtime Brookland District Supervisor Richard W. Glover, who died on February 2 at his home in Glen Allen at the age of 82.

Mr. Glover had begun his 29th year of service as Brookland's supervisor. He was the Board of Supervisors' longest-serving active member and was selected unanimously by his colleagues last month to preside as chairman in 2017.

In appreciation for Mr. Glover's service, County Manager John A. Vithoulkas ordered the Henrico flag to remain at half-staff at all county facilities through sunset Friday, February 10.

"It is with a very heavy heart that I report to you the passing of Mr. Richard W. Glover, who served as the Brookland District Supervisor for 29 years," Vithoulkas said in an email to county employees. "Mr. Glover had a passion for our County, the Brookland District, all things planning and zoning, and youth athletics. He was driven by his faith and his commitment to his family. He demanded much from us, and we are all better public servants because of him."

Mr. Glover's passing came about two weeks after the death of longtime Supervisor David A. Kaechele, who served the Three Chopt District from 1980 through 2015.

"This has obviously been a difficult time for all of us," Vithoulkas added, "but in the days and weeks ahead, please think of our recent losses and take the opportunity to do something good within our community. Do this from your heart — do it for Dick and Dave."

Mr. Glover was a native of Victoria and a veteran of the U.S. Navy who attended Virginia Commonwealth University and J. Sargeant Reynolds Community College. He joined the Board of Supervisors in January 1988 after having served on Henrico's Planning Commission from 1984 to 1986.

He was recognized for his expansive knowledge of Henrico and attention to details of the county budget. Among the many projects he championed were the Cultural Arts Center at Glen Allen, the Glen Allen Stadium at RF&P Park and Greenwood Park, which is under development.

Mr. Glover's résumé includes six appointments as chairman and four as vice chairman of Henrico's board. He also held positions on many national, statewide and regional governmental organizations, including the National Association of Counties' Community, Economic and Workforce Development Steering Committee, the Virginia Association of Counties' Economic Development and Planning Steering Committee and the Richmond Regional Planning District Commission. He also served on the county's Board of Social Services.

Mr. Glover was a lifetime member of the Hermitage High School Band and Auxiliary Boosters and the Glen Allen Youth Athletic Association and Hall of Fame. His survivors include his wife, Joan Sadler Glover; sons Gerald W. Glover and R. Joseph Glover; daughters Donna G. Parrish and Karen G. Glasco; and 11 grandchildren.

GASB has issued guidance for state and local governments to address asset retirement obligations related to tangible capital assets. Statement No. 83, *Certain Asset Retirement Obligations*, sets guidelines for determining the timing and pattern of recognition for liabilities and corresponding deferred outflow of resources related to asset retirement obligations. This guidance would enhance comparability of financial statements by establishing uniform criteria for governments to recognize and measure certain retirement obligations. The requirements are effective for reporting periods beginning after June 15, 2018.

GASB has also issued a proposed implementation guide that is intended to clarify or elaborate on statements the board has issued on state and local government financial reporting. The guide addresses questions related to topics such as accounting for pensions, cash flow statements, the reporting entity, certain investments, external investment pools, fund balances and tax abatements.

COUNTY CONNECTIONS

Visit Northampton County and the Eastern Shore Wildlife Refuge



Located at the tip of the Delmarva Peninsula, this area is one of the most important avian migration funnels in North America. Each fall, like colorful clockwork, the refuge is the scene of a spectacular drama as millions of songbirds and monarch butterflies and thousands of raptors converge on their voyage south. Favorable weather patterns push migrating species through the area in waves. Clouds of tree swallows swirl overhead and flame orange and black-winged monarch butterflies float aloft. Protected habitats such as these provide critical stopover areas where birds and butterflies can rest and feed before resuming their arduous journey.

The refuge has a state of the art visitor center with interactive exhibits and a wildlife viewing area, foot trails, wildlife observation platforms and a photography blind.

Tips to Protect Businesses Should A Disaster Strike: Protecting data and applications and handling IT downtime and data loss



Winter temperatures have arrived in much of the nation and businesses need to be prepared for disruptive events such as power outages and connectivity lapses caused by snow, ice and freezing rain.

Natural and man-made disasters happen, but if businesses haven't planned for a worst-case scenario, now is the time to establish the critical processes for your business when it comes to IT backup and disaster recovery.

According to Security Week research, the total volume of data loss at enterprises has increased more than 400 percent over the past few years and continues to increase as a result of the rise of big data, cloud computing, and BYOD policies in the workplace.

A comprehensive business resilience plan is an important step toward disaster preparation for all businesses. The business continuity plan, which includes the disaster recovery plan, preserves the continuity of critical components during a disruption, and resumes all functions afterward. - **4. Develop a plan.** Include "IT Assets Inventory," data protection procedures and contingency plans, notification/ activation schedules, a list of roles and responsibilities, a list of resource requirements and details about training provisions. Also include maintenance and backup/recovery testing schedules.
- 5. Identify a trusted IT partner. Nearly half of all small businesses find it difficult to have a dedicated IT department, but to help ensure IT needs are being met, look to a solution provider to help meet your company's needs; their expertise and tools allow you to focus on your business.
- 6. Understand the cloud's benefits. Virtualization technologies can make backup and disaster recovery vastly faster, cheaper and easier.
- **7. Implement the plan.** If your c-suite executives understand the consequences of system disruptions, you can win their support and funding for contingency policies.
- **8. Test the plan.** Play devil's advocate by coming up with all the scenarios that might cause your business plan to fail due to IT problems. When you know the threat or understand the risks to your business should a failure happen, it will be much easier to plan for them and quickly recover.
