 - American Red Cross Cardio Pulmonary Resuscitation for the Professional Rescuer (CPR-PRI).
- Knowledge of water rescue methods; lifeguarding and first-aid practices and techniques; swimming pool safety; and, principles and processes for providing customer service including setting and meeting quality standards for services, and evaluation of customer satisfaction.
- Ability to be courteous, while enforcing pool rules, with patrons.

Locations available are Jamestown Beach Event Park, Chickahominy Park Pool Concessions, Upper County Park Pool Concessions, Little Creek Reservoir Park, James City County Marina and Veteran's Park (f.k.a Mid County Park). Selected applicants will be assigned to a designated location, but may be required to work at other locations. Applicants should be willing to work flexible schedules, which may include weekend, early morning, late evening, and holiday hours.

Responsibilities:

- Assist customers at the counter and over the telephone; collect fees (dependent on park location); and direct patrons to park areas.
