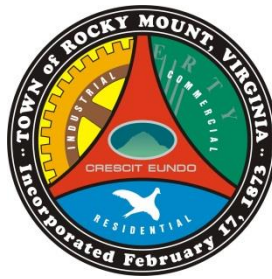

## Water Plant Superintendent

The Town of Rocky Mount is seeking an individual to serve as Water Plant Superintendent who is passionate about delivering the best quality water possible to its residents, businesses and industries. Rocky Mount is a growing, thriving community dependent on great water to attract, retain and serve residential and commercial customers.

Rocky Mount Water Plant is an award-winning surface water, river-fed conventional treatment plant with coagulation, sedimentation, and dual media filters, capable of drawing 2 million gallons per day from the Blackwater River. Built in 1981, the plant has recently completed upgrades in its electrical, pumping, SCADA, bleach chlorination, fluoridation and HVAC systems. The plant and grounds are well maintained by a dedicated and experienced staff of five, including the superintendent. Current average water demand is approximately 45 percent of maximum capacity. The Town has 2.4 million gallons of water storage spread across five tanks to provide adequate flow and pressure for nearly 380,000 linear feet of town-maintained water pipe. Works with the Public Works department to repair, maintain, replace and upgrade critical water service components. The Water Department must perform hydrant flushing and valve exercising on a regular schedule. The incumbent is leaving for a regional waterworks after nine years with the town. The Town of Rocky Mount is currently working with the Western Virginia Water Authority to connect its 12-inch Franklin County/Route 220 line with the Town's system to serve as a back-up supplier and to facilitate WVWA future expansion to serve new areas of Franklin County.

The superintendent must hold a current valid Virginia Class I Water Treatment Operator's License. The preferred candidate must demonstrate excellence in reporting and writing, and must have familiarity with Microsoft Office, geographic information systems and SCADA systems and components. Franklin County residency required within 12 months.

The position is Grade 22 within the Town's pay plan. Pay commensurate with experience and training. Excellent employee benefits include health insurance, paid leave, holiday bonus and Virginia Retirement System.
