The Security Specialist works closely with the Director of IT and other IT personnel to develop and maintain the cyber security posture for Montgomery County. Essential duties include but are not limited to:

- Monitor systems and networks for vulnerabilities and provide patches/fixes using GFI LanGuard.
- Monitor and maintain SIEM tool (Splunk) for cyber threat detection and reconnaissance.
- Support system and network engineering efforts, including firewall configuration, and provide technology infrastructure recommendations pertaining to cyber security.
- Provide Active Directory support and LDAP implementations as well as manage security certificates.
- Support the Identity and Access Management (IAM) program and implementation with the intranet and internet development.
- Provide periodic summary level security reports for management and detail reports to assist IT staff.
- Develop and maintain technical documentation, troubleshooting guides, and the IT knowledgebase.
- Support the IT Department's cyber security awareness program.
- Work closely with others to develop and maintain the County's Information Security Plan.
- Participate in development of a comprehensive information security policy suite for the County and assist in development of an incident response plan.
- Work closely with Information Technology applications to ensure that the data business applications create and manage is protected.
- Analyze security impacts of application and software changes and changes to technology infrastructure.
- Provide support for the Help Desk and Operations staff as needed.

Requires education or training equivalent to an associate's degree in computer engineering, computer science, or a closely related field, and five years related experience in technology operations, preferably network engineering. Cyber security certification, such as CompTIA Security+ preferred but not required; the County will support efforts to obtain cyber security certification, such as CISSP. The Cyber Security Analyst should have effective written and oral communication skills and possess exceptional ability to collaborate effectively on cross-functional projects.
