VDOT is responsible for building, maintaining and operating the state's roads, bridges, tunnels and ferry systems. Through the Commonwealth Transportation Board (CTB), VDOT also provides funding for airports, rail and public transportation. VDOT's Infrastructure Investment Division has an exciting opportunity for (2) Program Management Specialists to assist with development and management of the Department's capital

improvement program, the Six-Year Improvement Program (SYIP). This position will support the Agency, CTB and Secretary of Transportation in the selection, development and monitoring of construction program projects funded through the state's nationally recognized prioritization system known as SMART SCALE, as well as other state and federal funding programs in the SYIP.

This position will provide direction, guidance and analysis of statewide financial and business processes related to the SYIP, including transportation project development and delivery. Responsibilities include working with a diverse group of business partners to efficiently deliver transportation projects; participating in the SMART SCALE project selection and monitoring processes; collecting, analyzing and interpreting project and financial data from multiple sources to ensure the efficient use of funding to support project delivery; and preparing reports and conducting analysis to support development and implementation of policies, processes, and procedures related to the financial life-cycle of projects. This position will also review and analyze project data to recommend adjustments in financial and/or project management systems and perform other special assignments as directed by Agency management to support VDOT and division goals and objectives.

This position is eligible for telework opportunities; availability, hours, and duration are at the sole discretion of the Department Manager in accordance with VDOT's Teleworking policy.

Additional vacancies may also be filled from this recruitment.

In addition to a rewarding work experience, VDOT offers core benefits including competitive health and life insurance programs, pre-tax spending accounts, and leave programs. Employees participate in a State Retirement Plan; a tax-deferred Retirement Savings Plan with employer-matching provisions is also available. Employees are eligible for participation in a Short and Long Term Disability Program after one year of employment. Knowledge of state and federal planning practices and regulations. Knowledge of VDOT programs, policies, project prioritization, and programming and scheduling tasks. Ability to adjust to complex changes and help implement programmatic policies, procedures, and short and long term goals. Ability to meet deadlines, handle assigned workloads with minimal oversight, and to proactively propose solutions to identified issues.

Experience in capital budgeting, including working with financial data and transportation project development and programming processes and procedures preferred. Experience in transportation funding, transportation planning, and/or transportation project development processes to include project management, financial, and policy considerations. Experience in Preferred Qualifications data collection and ability to analyze, research and interpret financial and project data. Ability to follow written and oral instructions and to communicate effectively orally and in writing. Skill in the use of computers and software applications to include Microsoft Office applications and financial or project management software, such as Microsoft Project. Experience with automated and project data management systems. Ability to manage multiple tasks. Experience working as a part of collaborative efforts with multidisciplinary teams or with staff outside of direct work unit.
