The successful candidate will also become the primary position responsible for the representation or eventual representation of the local Department of Social Services ("DSS") in all litigation before the Culpeper County Juvenile and Domestic Relations District Court. The DSS litigation includes protective orders, relief of custody, abuse and/or neglect, emergency removal, preliminary removal, foster care plans, child in need of services, and petitions seeking termination of parental rights. The scope of the work may also include administrative appeals of abuse/neglect findings.

The successful candidate must possess a Juris Doctorate from an accredited law school, a license to practice law in the Commonwealth of Virginia, and be in good standing with the Virginia State Bar. Being licensed to practice law in the Commonwealth of Virginia and having actively practiced law for at least five (5) years is required. At least three (3) years professional legal experience representing municipal clients is required. Prior experience in representing DSS is required. Additional experience serving as a guardian ad litem is preferred.
