### New Kent County's "Casual Day for a Cause"

It has been said that "charity begins at home," but what does it mean? Some would say that one must take care of their immediate family first, but others would say that good acts must be started for those who are dear and close to us. Launching a campaign from that standpoint seems difficult but it is exactly the idea behind the County of New Kent's "Casual Day for a Cause" program.

"Casual Day for a Cause" is a fun voluntary event, implemented by the County's former County Administrator that builds camaraderie in the County offices and raises funds for charitable organizations based in New Kent or for causes supported by County employees. On these days, jeans, sneakers and a more casual approach to dressing, although never potentially offensive to others, are allowed. These casual days are administered by Human Resources staff and are observed on Fridays, beginning the week before Memorial Day and continuing through Labor Day. Other Casual Days are declared by the County Administrator as deemed necessary. Casual Day is simple to conduct and very popular with employees. Participation is very easy - if you choose to dress down, you must make a donation - and it requires nothing at all from the County.

"Causes" are those suggested by County employees and range from Relay for Life (American Cancer Society), to the New Kent Social Services Food Pantry. In the past five years the New Kent Humane Society, New Kent Christmas Mother, Lee National Denim Day (breast cancer), American Diabetes Association, and many more organizations have benefited. While there is no minimum or maximum donation amount required, over 15 weeks in 2009 alone, New Kent County employees donated almost \$3,000 to charity.

New Kent Human Resources reports that "Casual Day for a Cause" helps to increase employee morale while raising money for some great causes. The relaxed atmosphere and increased comfort of casual clothes are also felt to result in increased productivity during the "dog days of summer."

While this isn't the first Casual Day program in existence, this model works extremely well for New Kent County and we think it will for other localities as well. Where some businesses may offer a Friday "casual day" to their employees, they could go the extra step by giving back to their community too.
