## Governor Northam speaks at VACo County Government Day

VACo President and King and Queen Supervisor Sherrin Alsop encouraged the crowd of more than 200 County officials to make February 8 their day.

“I know you’re excited to start your legislative experience,” Alsop said. “Please be sure to talk about the important legislative issues we’ve discussed. Today is our day – County Government Day.”

County elected officials and staff from all over the Commonwealth convened in Richmond to hear Governor Ralph Northam speak and to be briefed by VACo staff on the most pressing issues. County officials then went to the Capitol and advocated on behalf of their localities.

Governor Northam spoke about jobs, education, transportation and called the opioid crisis the biggest challenge in the Commonwealth. “One point I’d like to make is you don’t need a four-year college education to get a good high-paying job,” Governor Northam said. “There are jobs in cybersecurity, unmanned aerial systems, biotechnologies, artificial intelligence, data collection, data analysis – these are the jobs of the 21<sup>st</sup> Century. We need to make sure we prepare our youth for these jobs.”

VACo staff reported on issues ranging from budget amendments to the gutting of local authority to education funding to solar to public safety to FOIA and transportation.

VACo thanks all its members who participated in the legislative process and made a difference for Virginia’s Counties.

## STAFFORD APPOINTS NEW COUNTY ATTORNEY

Stafford County announces the appointment of Rysheda M. McClendon to the position of County Attorney. Rysheda McClendon has served as Deputy County Attorney for Stafford County since 2015 and worked in the County Attorney office for seven years. She will replace retiring County Attorney Charles L. Shumate on March 1, 2018.

“Stafford County is advancing in many areas – economic development, needed improvements to our infrastructure, meeting the service needs of an expanding population and much more. Rysheda McClendon has both the legal expertise and the institutional knowledge to guide us as Stafford continues to progress,” said Chairman of the Board of Supervisors Meg Bohmke. “She has been an integral and outstanding member of the County Attorney team for years, and we look forward to continuing to work with her in her new role.”



Ms. McClendon has had many accomplishments during her tenure in the County Attorney’s Office. She was the draftswoman of the County’s successful 2011 redistricting ordinance which adopted new election district boundaries and polling place locations. Ms. McClendon drafted a shared radio services agreement for emergency and public safety services that resulted in approximately \$285,000 in annual savings. She developed and presented a new system of methodology to assist the Board, Planning Commission and County staff with analyzing proffers under new legislation.

“I am familiar with the growing pressures placed upon the County’s infrastructure. I believe innovative ideas and multidisciplinary approaches are necessary to address those needs. I am forward thinking and offer my experience, dependability, and firsthand knowledge to aid the County in handling upcoming issues,” said future County Attorney Rysheda McClendon. “It is my privilege to serve Stafford County and the Board of Supervisors, and I thank them for this opportunity, as well as my predecessor Charlie Shumate, from whom I have learned a great deal.”

Ms. McClendon holds a Juris Doctor from the University of the Pacific McGeorge School of Law, as well as a Bachelor of Arts in Interdisciplinary Studies from George Mason University.

# Stafford County appoints Interim Supervisor

The Stafford Board of Supervisors recently announced the appointment of Thomas C. Coen as Interim George Washington District Supervisor. Coen was sworn in on February 7 and takes the seat vacated by former Supervisor Robert "Bob" Thomas, Jr., who is now in the Virginia House of Delegates. Coen will serve as Interim Supervisor until the Board holds a special election in November to fill the remainder of the George Washington District term. The winner of the special election will be sworn in after the election.

"We had seven very qualified applicants who were willing to step up and serve us during this time of transition. We are very grateful for their interest," said Chairman of the Board of Supervisors Meg Bohmke. "After much discussion, interviews with the three most qualified candidates, we have decided to appoint Tom Coen. Based on Mr. Coen's prior experience with Stafford County with the Planning Commission and other boards and commissions in the county as well as with the schools, where he is a U.S. Government teacher at Colonial Forge High School. Mr. Coen has demonstrated a dedication to the community and an understanding of our challenges and goals."



At its January 23, 2018, meeting, the Stafford Board of Supervisors, pursuant to Virginia Code § 24.2-226, authorized a special election to fill the George Washington District seat. The special election will be held on the same day as the general election, Tuesday, November 6, 2018. The winner of the special election will serve out the remaining term of the George Washington District supervisor's seat, which ends on December 31, 2019. Virginia Code § 24.2-228 requires the Board to appoint an interim supervisor for the George Washington District seat within 45 days of the vacancy occurring.

Candidates were asked to submit a completed application package by noon on February 2, 2018. The application package required a resume, a Board Bank Application, a Certificate of Candidate Qualifications, and a letter of interest which addressed the following three questions:

- Why are you seeking an appointment with the Board?
- What involvement have you had within the Stafford community?
- What leadership qualifications do you possess?

Selected candidates were interviewed by the Board of Supervisors during the closed session at a Special Board Meeting. The Board agreed to evaluate the candidates on specific criteria: prior service to Stafford County on committees, board and commissions; their financial knowledge and career expertise; their ability to work with others; their engagement in community organizations; the length of time they've spent in the George Washington District and Stafford County; their leadership positions; and other factors. The Board voted immediately following the interviews to appoint Thomas C. Coen.

Coen has served on the Stafford Planning Commission for four years and is the former chairman. He was also a member of the Stafford County Public Schools Capital Improvement Plan Advisory Committee and has been a U.S. Government teacher at Colonial Forge High School since 1998. He has also coordinated Student Government Day with the Board of Supervisors and Stafford Government for seniors in Stafford high schools for 17 years. Mr. Coen has a Master of Arts in Political Science from American Military University, a Master of Arts from George Mason University and a Bachelor of Science in Government from Suffolk University.

## Financial Facts

GASB issued an Invitation to Comment to seek feedback to assist its efforts to develop a revenue and expense recognition model for state and local government accounting. The objectives for the model are:

- To create a more robust framework to address a wide range of transactions.
- To improve the comparability of how transactions are accounted for and reported by governments.
- To provide more useful information to users of financial reports.

Two potential models are discussed in the invitation. An exchange/nonexchange model would include a classification process based on the existing definition for exchange transactions. The other would be a performance obligation/no performance obligation model to include a tentative definition of a performance obligation. # Visit Carroll County and Puckett Cabin



At Milepost 189.1 in Carroll County, you will find Puckett Cabin. This cabin is the former home of Orlean Hawks Puckett, whose story of strength and goodwill has survived generations.

Born in North Carolina, Orlean Hawks Puckett received little formal education before she married John Puckett at about age 16. They settled close to his family near Groundhog Mountain in Patrick County. Her first child was born in 1862 but died a few months later of diphtheria. Of her twenty-three subsequent pregnancies, none of the children born living survived more than a few days, possibly as a result of Rh hemolytic disease.

Orlean Puckett and her husband moved in 1875 to a nearby farm in Carroll County, where he built a two-story log house. She first served as a midwife in 1889, when no doctor or other midwife could be found for a neighbor. Puckett soon began traveling around the region, sometimes up to twenty miles distant, to deliver babies. She never charged for her services and became known throughout the area for her compassion and skill, having never lost a mother or baby during the more than 1,000 deliveries she attended.

Orlean moved from her home in 1939 because of the construction of the Blue Ridge Parkway. However, she died three short weeks afterward. A small cabin on her property was preserved by the National Park Service, and is known to be Puckett Cabin. Continuing her legacy of care, the Orlean Hawks Puckett Institute, in Asheville, North Carolina, works to promote and strengthen child, parent, and family development. Her story to many is a perfect picture of the strength of Appalachian women in the 1800's and the early 1900's.
