

Assistant Recreation Supervisor

\$11.87 / hour; Part-Time Temporary positions available (up to 28 hours / week)

James City County Parks and Recreation seeks responsible individuals to assist with overseeing the comprehensive REC Connect Before and After School Program and Summer Camp to include daily program schedule planning, activity leadership, and record keeping. Work schedule includes year round employment and is Monday – Friday between 7:00 a.m. - 9:15 a.m. and/or 3:30 p.m. – 6:00 p.m. during the school year and Monday – Friday 7:00 a.m. -6:00 p.m. during the summer with an occasional evening and/or Saturday.

Responsibilities:

- Organize, lead, teach, and oversee a variety of recreational activities such as arts and crafts, sports, outdoor games, educational program components, etc. for children ages 5-14; supervise participants on field trips; plan daily activity and snack schedule; and coordinate family involvement
- Implement and ensure compliance with State-licensed program rules, regulations, and procedures
- Assist Recreation Supervisor with the effective supervision of assigned staff; assist Recreation Supervisor with maintaining program within budget limitations; keep accurate records/statistics and completes necessary site paperwork; report all accidents, incidents, and disciplinary actions to supervisor; and, act as Site Supervisor in absence of the Recreation Supervisor
- Ensure a safe environment and proper use, inventory and upkeep of site facilities, vehicles, supplies, and equipment; develop and enforce site rules; open, close, and secure facility daily

Requirements:

- Any combination of education and experience equivalent to 48 semester hours of college credit coursework; some experience in staff management, instructional procedures and practices, and working with children of different ages and abilities, preferably in a recreational, state-licensed, or educational setting; some supervisory experience preferred
- Must possess, or be able to obtain within 30 days of hire, a valid Virginia driver's license and have an acceptable driving record based on James City County's criteria
- Must possess, or be able to obtain within 60 days of hire, certification in Cardio Pulmonary Resuscitation (CPR) for the Professional Rescuer certification, First Aid certification, and Medicine Administration; training in passenger van safety and county sponsored OSHA training
- Must obtain a minimum of 24 hours of staff training and development through in-service training, individual study, classroom training, seminars or conference annually
- Post-offer criminal history, sex offender and Child Protective Services registry checks conducted.
- Drug and tuberculosis test required.
- Considerable knowledge of stages of growth and development, safety and health practices of different age groups and abilities, different types of demographics and associated needs, and planning different recreational activities; knowledge of principles and processes for providing customer service; and, knowledge of leadership techniques.
