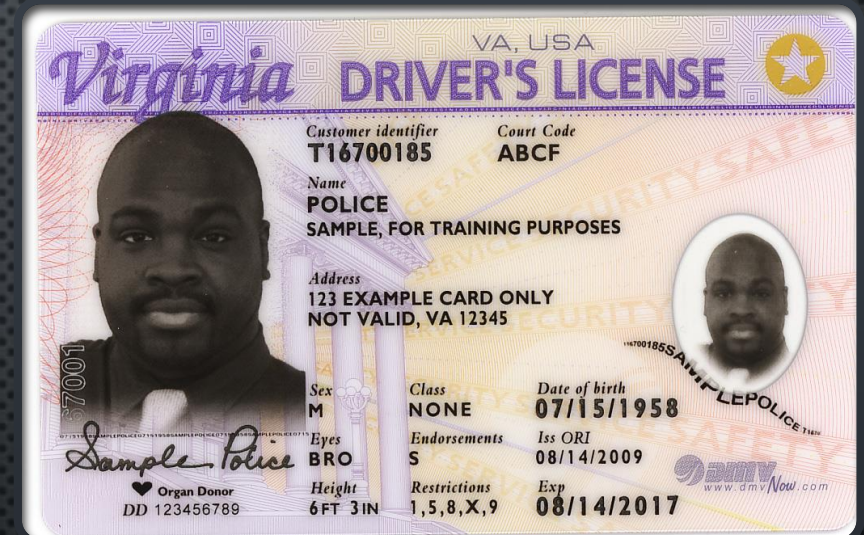

OTHER STEPS HAVE BEEN TAKEN TO IMPROVE THE INTERACTIONS WITH LAW ENFORCEMENT

- DMV WILL PLACE A RESTRICTION CODE OF '9' ON THE FRONT OF THE DRIVER'S LICENSE OR IDCARD. THE CODE IS DEFINED ON THE BACK OF THE LICENSE OR ID CARD AS "INTD" FOR INTELLECTUAL DISABILITY AND "ASD" FOR AUTISM SPECTRUM DISORDER. THIS IS CONSISTENT WITH THE CURRENT DMV PROCESS FOR INSULIN DEPENDENT DIABETICS, SPEECH IMPAIRED INDIVIDUALS, AND HEARING IMPAIRED INDIVIDUALS WHO REQUEST THE APPLICATION OF SPECIAL INDICATORS ON THEIR CREDENTIALS. THIS INFORMATION WILL ONLY DISPLAY ON VCIN AND LAW ENFORCEMENT TRANSCRIPTS.
