### Stephen W. Bowen Elected VACo President for 2019-2020

The membership of the Virginia Association of Counties elected Nottoway County Chairman Stephen W. Bowen as 2019-2020 President during VACo's 85<sup>th</sup> Annual Conference in Bath County. Bowen and other newly elected officers started their terms at VACo's Annual Business Meeting on November 12.

Bowen succeeds Wythe County Chairman Timothy A. Reeves, Sr., and becomes the second President from Nottoway County. C.S. Hooper, Jr., served as VACo President in 1970.

"I am humbled and honored to be elected VACo President and to have the opportunity to serve the association," Bowen said. "I was born and raised in Nottoway County on a tobacco farm where I developed a passion for mechanics. I graduated from Newport News Shipbuilding Apprentice School as a Journeyman Welder and later became a Master HVAC and Plumber Technician. I like working with my hands and fixing things. This will be my approach as VACo President."

Bowen parlayed his technical skills into a career in hospital facility operations. During his more than 30-year tenure at Piedmont Geriatric Hospital, Bowen learned the importance of government decisions and how they impact hospitals and health care for Virginians.



Bowen was first elected to the Nottoway County Board of Supervisors in 2008 to represent the Burkeville area where U.S. Route 360 meets U.S. Route 460 - the "Crossroads of Virginia."

Bowen also serves on the Nottoway County Planning Commission, the Nottoway County Planning Council, the Piedmont Geriatric Association, and the Piedmont Regional Jail Authority. Bowen actively supports VACo's mission and is a proud graduate of the 2012 Certified County Supervisors' program. He has served as Chairman of the VACo Nominating Committee and the VACo Economic Development and Planning Steering Committee.

Bowen enjoys his church, Pisgah Baptist, and has served many years as Chairman of the Deacons, Sunday School Director and President of the Lunenburg/Nottoway Gideons. Bowen loves working on the family farm with his three adult children, wife of 31 years and granddaughter.

"These are exciting and challenging times for Virginia's Counties," Bowen said. "Legislatively, we are fighting to get equal taxing authority, more state education funding, and connecting underserved and unserved areas with broadband. I will continue to fight for these necessary and vital goals. I look forward to this opportunity and can't wait to get started."

"Steve has a passion for public service and understands the different governing dynamics around the state," VACo Executive Director Dean Lynch said. "He has a strong understanding of County issues and believes in our legislative program. We are excited to have Steve Bowen as our next President."

### State Board of Elections Moves Forward with Plans for Early Voting, Election Security Standards

The State Board of Elections took action on November 18 on two significant initiatives stemming from legislation enacted in 2019 – the implementation of "no-excuse" absentee voting and the establishment of security standards for local information technology systems that interact with the state's voter registration system. Both efforts will require additional resources for localities to implement; VACo will continue to advocate for state assistance to counties in elections administration.

#### **No-Excuse Absentee Voting**

Legislation that passed in 2019 authorizes voters to cast absentee ballots in person during the week prior to the election (from the second Saturday preceding the election through the Saturday immediately preceding the election) without needing to provide one of the statutory excuses for voting absentee, beginning with the November 2020 election. Absentee in-person voting for voters who qualify under the existing list of excuses will be available from the 45th day preceding the election until the beginning of the "no-excuse" period.

The 2019 legislation also directs the State Board to report on its plans for implementation, to include recommendations for any additional legislation that might be needed. In preparing the draft report, which was approved by the State Board on November 18, the Department of Elections held several meetings with stakeholders, including VACo; VACo encouraged the Department to take a flexible approach to implementation that would allow localities to establish satellite voting locations in a manner that best fits locality needs.

Among the report's key recommendations are the following:

- The report does not recommend that the state dictate the placement of satellite early voting locations (such as by requiring a certain number of satellite locations per number of registered voters). It does suggest transferring the authority to establish satellite locations from the local electoral board (as provided in the 2019 legislation) to the local governing body, similar to the local governing body's existing authority to establish polling places by ordinance.
- The report recommends the establishment of public notice requirements in the event of a change in satellite locations; these requirements would be more flexible than the notice requirements for a change in a polling place and would permit notice to be made via the locality's website or a newspaper of general circulation.
- The report recommends that legislation be adopted to require some uniformity in the hours of operation for satellite voting locations, whether by requiring all the satellite locations within a locality to have the same hours of operation, or by requiring the same hours of operation for all satellite locations statewide.
- The report recommends expanding the "no-excuse" absentee period to 45 days in order to minimize voter confusion (under the 2019 legislation, prospective absentee in-person voters need an excuse from 45 days before the election until two Saturdays before the election, and an excuse would still be required for absentee voting by mail at all times).

VACo's comments to the State Board expressed appreciation for the Department's willingness to consider local governments' perspective in drafting the report, and for the flexibility provided to localities in establishing satellite locations. VACo noted that extending the "no-excuse" absentee period during the 2020 session may be challenging for some counties, as localities have used the additional time afforded by the 2019 legislation's delayed enactment to plan and budget for one week of early voting and may have to revise these plans in a compressed time period in order to accommodate 45 days of early voting. Accommodating even the eight days of early voting envisioned in the 2019 legislation will require additional resources from localities that need to establish satellite locations, which must be equipped with pollbooks and voting machines and staffed by officers of election.

#### **Security Standards**

At the November 18 meeting, the State Board also adopted security standards for the local technology systems that interact with VERIS, the state voter registration system. Authority to establish these standards was incorporated in legislation enacted in 2019; at the request of VACo and VML, language was added to the legislation requiring consultation with a workgroup of local IT professionals in developing the standards, as well as general cost estimates for their implementation. This workgroup met throughout the summer to discuss proposed standards, which address IT governance, physical security, password management, training, and incident response, among other areas. The standards as adopted by the State Board may be found in the Board's meeting packet beginning on page 74.

Detailed information on the implementation of the new standards will be provided by the Department of Elections in the near future. As a first step, localities were asked earlier this fall to conduct two self-assessments by the end of the year in order to establish a baseline, which will shape local elections security plans. The Department of Elections recognizes that it will be difficult for localities to be in full compliance with all standards by fall 2020, and plans to use the results of the self-assessments to assist localities to the extent Department resources allow, such as by providing templates for required policies or other in-kind assistance.



### VACo Releases 2020 Legislative Program



After months of steering committee meetings, lively debate and participation through the Association's legislative process, VACo adopted its <u>2020 Legislative Program</u>. The Legislative Program is organized according to VACo's Steering Committees.

### State General Fund Collections Continue Strength in October; "Money Committees" Meeting This Week



Governor Northam announced last week that state General Fund (GF) revenues continued to demonstrate "solid growth" in October. Total GF collections increased by 9.6 percent in October, and on a fiscal year-to-date basis, total revenue collections have grown by 8.5 percent, comfortably ahead of the forecast of 1.2 percent growth. Individual income tax withholding collections have increased by 5.7 percent on a fiscal year-to-date basis, outpacing the forecast of 4.2 percent growth; this continued steady growth is welcome given that withholding collections narrowly missed their forecast in FY 2019. Nonwithholding collections continue to outperform the annual estimate, with collections up 20.7 percent on a fiscal year-to-date basis; however, October is not a significant month for nonwithholding collections, and Secretary of Finance Aubrey Layne strongly cautioned both House Appropriations and Senate Finance during his presentations in October that there is significant uncertainty about how nonwithholding collections will perform during the all-important final quarter of FY 2020. Sales tax collections in October, reflecting September sales, also continued to perform well, growing by 8 percent on a fiscal year-to-date basis.

Governor Northam followed the positive revenue report with an additional piece of good economic news for the Commonwealth on November 19, announcing that Virginia's seasonally-adjusted unemployment rate has dropped to 2.6 percent. The Bureau of Labor Statistics estimates that between October 2018 and October 2019, total seasonally-adjusted nonfarm employment increased by 0.7 percent statewide, reflecting a gain of 29,600 jobs, with increases in employment in nine of the state's ten metropolitan areas.

This week the "money committees" are holding their annual retreats, which provide an opportunity for members to receive briefings on general economic conditions and topics that are expected to play major roles in budget deliberations in the upcoming legislative session. Members of the House Appropriations and House Finance Committees met November 19 and 20, and the Senate Finance Committee will hold its retreat later this week. House Appropriations staff, although expressing similar concerns about the uncertainty surrounding individual income tax nonwithholding collections, expect FY 2020 GF revenue growth of 3 percent; under these projections, the state would conclude FY 2020 with \$428 million in additional revenues to address approximately \$90 million in agency-identified needs. Due to continued uncertainty about the possibility of an economic slowdown in the near future, staff recommends depositing any surplus FY 2020 revenues not otherwise required for the current fiscal year into the state's cash reserves. (The budget outlook presentation may be found at this link.)

Appropriations staff expect similarly modest but steady growth in GF revenues in the upcoming biennium, projecting growth of 3.1 percent in FY 2021 and 3.4 percent in FY 2022. Mandatory spending items identified by staff total \$2.15 billion over the biennium and include expected commitments such as growth in the Medicaid forecast, growth in the Children's Services Act, rebenchmarking of the Standards of Quality, funding of Medicaid waivers associated with the state's settlement with the Department of Justice, and costs associated with inmate medical care. High-priority spending items identified include funding for Commonwealth's Attorneys' staff, election security positions at the Department of Elections, additional deputy court clerks, broadband investments, workforce development, and potential deposits to the Water Quality Improvement Fund; this list totals \$662 million over the biennium.

The Joint Advisory Board of Economists (JABE) met on October 17, and the Governor's Advisory Council on Revenue Estimates (GACRE) will meet November 25; these recommendations will be factored into the revised revenue forecasts that will be presented to the money committees on December 17 along with the Governor's proposed biennium budget.

### Virginia Retirement System (VRS) Sets FY 2021-2022 Employer Contribution Rates for Political Subdivisions



On November 19, the Benefits and Actuarial Committee of the VRS Board met to review actuarial results for political subdivision retirement plans, the Virginia Local Disability Program (VLDP), Local Health Insurance Credit (HIC), and Other Post-Employment Benefits (OPEB). As with the State and Teacher plans, the recent lowering of the System's assumed rate of return (ROR) from 7.0% to 6.75% resulted in the actuarial staff mostly recommending increases in employer contributions for the various plans. Employer contribution rates will vary by political subdivision, but in aggregate, the average contribution rate will increase from 7.60% to 8.33%.

As previously reported, VRS uses the actuarial valuations for employer contribution rate setting on odd years in advance of the next biennium. The more conservative forecast for ROR had the biggest impact in the recommendation to raise employer contribution rates. Even though over 60% of local pollical subdivision plans have a funded status greater than 90%, with more than 35% of plans funded at over 100%, \$3.3 billion in aggregate unfunded liabilities remain. The recommended increases reflect changes in funding policy from 2013 that seek to amortize unfunded liabilities and improve the long-term fiscal health of the System.

The Health Insurance Credit contribution rates for constitutional officers, social service employees, and general registrars were recommended for approval at 0.36%, 0.38%, and 0.39% respectively. The contribution rates for VLDP Teachers and VLDP Political subdivisions were recommended for approval at 0.47% and 0.83% respectively. These rates represent modest decreases for HIC rates and modest increases for VLDP.

Contribution rates for political subdivisions participating in the LODA Fund were recommended at \$695.18 per eligible full-time-employee (FTE). This represents a decrease from the previous rate of \$705.77 per eligible FTE mainly due to a decrease in Department of Human Resource Management (DHRM) healthcare premiums. However, these costs are expected to rise in subsequent years and such changes will likely be reflected in future rate setting.

Each political subdivision will receive its valuation and contribution rate from VRS in January, based on its individual experience and population covered. Final contribution rates will be available at the conclusion of the 2020 General Assembly and will take effect on July 1, 2020 for FY 2021-2022. Despite the recent contribution rate increases resultant from the changed ROR, over the past ten years average employer contribution rates (including the defined contribution component) for local political subdivisions have been decreasing. This indicates the long-term health of these plans and the long-term savings resultant from pension reform. More information on VRS rate setting can be found here.

### 2019 Annual Report on the Condition and Needs of Public Schools in Virginia

On November 14, the Virginia Board of Education (VBOE) met and reviewed their annual report to the Governor and the General Assembly on the condition and needs of public schools in Virginia. In addition to detailing VBOE's proposed revisions to the Standards of Quality (SOQs), the report provides a useful overview of the state of K-12 education across the Commonwealth. The report highlights many of the challenges school divisions face as well as the extraordinary efforts made by localities to ensure that an educational program of high quality is continually maintained.

VBOE is required by <u>code</u> to submit an annual report by December 1 that includes but is not limited to, a complete listing of the current SOQs and changes recommended by VBOE, an overview of the accreditation status of schools, and reporting requirements of local school divisions. The recent revisions to the SOQs prescribed by VBOE, the process in which they were prescribed, and their potential fiscal impact has been covered in detail <u>elsewhere</u>. However, some of the statistics mentioned in the report are worthy of mention.

The SOQs set the minimum educational requirements to be provided by local school divisions and funded by a combination of state and local school resources. The local share is determined by the Composite Index Formula

(LCI) which is adjusted so that the statewide average local share is 45 percent and the statewide average state share is 55 percent. While this occurs for SOQ funded responsibilities, the cost sharing formula does not reflect the actual prevailing costs of maintaining a high standard K-12 education system.

The VBOE report recognizes that local governments are funding a disproportionate share of the cost of K-12 education in Virginia. Every locality in Virginia funds its share of K-12 responsibilities in excess of the minimum standards as prescribed by the SOQs. In fact, the majority of public school funding in Virginia, 51 percent, is from localities. The state contributes 42 percent of public school funding, with seven percent from federal sources. In FY 2017-2018, Virginia localities invested \$4.2 billion above the required local effort for SOQ programs. These figures reflect the eight percent decrease in state support in real dollars since the 2009-2010 school year.

Despite the decrease in state funding, during the same period the total student population across the state increased by 5 percent, or 54,114 students, from 1,235,062 students in 2008-2009 to 1,289,176 students in 2018-2019. Furthermore, the number of economically disadvantaged students, English Learners, and students with certain disabilities has increased disproportionately. Economically disadvantaged students, (I.e. students who 1) are eligible for Free/Reduced Meals; 2) receive Temporary Assistance for Needy Families (TANF); 3) are eligible for Medicaid; or 4) identify as either migrant or experiencing homelessness) increased by 31 percent or 121,684 students. The number of English Learner students increased by 23 percent or 20,138 students and now represent eight percent of the total student population. Students identified with autism increased by 131 percent or 13,363 students, while students identified in the other health impairments disability category increased by 34 percent or 8,862 students. Additional resources are needed to ensure that these students achieve equitable and successful educational outcomes.

The revisions to the SOQs prescribed by VBOE specifically request that the General Assembly remove the recession era cap on state aid to support positions. Removal of the "support cap" would yield \$371.6 million in additional state funding to localities to help pay for positions currently funded entirely by local effort. VACo continues to urge the General Assembly to provide full state funding for public education in accordance with VBOE recommendations where such recommendations coincide prevailing local practice.

### New contract with Dominion Energy to purchase electricity will save counties money



The Virginia Energy Purchasing Governmental Association (VEPGA), a joint powers association of more than 170 local government entities (including 37 counties), has signed a new contract to purchase electricity from Dominion Energy for the period August 1, 2019 through June 30, 2022. While an Agreement in Principle was reached earlier this year, the final contract language was executed in late October and is in effect as of August 1, 2019.

Unlike residential and commercial customers, electricity rates for government entities are not regulated by the State Corporation Commission (SCC). VEPGA, created in 2002 pursuant to authority provided in the Virginia Code, negotiates multi-year electricity contracts with Dominion Energy on behalf of its members. Analysis by VEPGA consultants estimates savings to VEPGA members (in the aggregate) of millions of dollars each year.

According to VEPGA, the new agreement ... achieves approximately \$32.55 million in savings over the contract term, as compared to Dominion's original offer. It also provides for up to \$10 million in credits beginning in 2022, contingent on Dominion's spending over the contract term on "Grid Transformation" activities authorized by 2018 state legislation and approved by the Virginia State Corporation Commission.

### GOVERNOR'S EMS AWARD WINNERS ANNOUNCED AT THE 40th ANNUAL VIRGINIA EMS SYMPOSIUM

# Governor's Environmental Excellence Awards – Applications Due December 5

### Governor's Environmental Excellence Awards

Virginia counties are eligible to apply for the <u>Governor's Environmental Excellence Awards</u>, an annual program to recognize successful and innovative efforts that improve Virginia's environment. The program is administered by the Department of Environmental Quality (DEQ) in partnership with the Department of Conservation and Recreation (DCR). There are four broad categories of awards with multiple Gold, Silver and Bronze level award winners for each category along with some applicants earning Honorable Mention.

#### Award categories include:

<u>Sustainability Program</u>: DEQ considers environmental sustainability as meeting the needs of the present without compromising the environmental resource needs of future generations. This category is intended to provide recognition to organizations or facilities that can document the success of their sustainability program by providing evidence of:

A culture of environmental sustainability;

Recent accomplishments related to reducing their environmental footprint; and

A commitment to future sustainability-oriented actions.

**Environmental Project:** This category is intended to recognize activities or processes implemented by a facility or organization within the past five years that are directed at a single goal to improve the environment beyond what is required by regulation. Examples include, but are not limited to, projects aimed at reducing waste generation, water consumption or pollutant releases, increasing water reuse, green infrastructure, or use and access to clean energy; and adapting to the impacts of a changing climate.

**Land Conservation:** This category is intended to recognize exemplary land conservation work within the Commonwealth. Examples include outstanding land conservation easement or fee simple acquisition projects that permanently protected lands with high conservation values to the development of an integrated prioritized land conservation plan for an organization or agency region of coverage.

Virginia Outdoors Plan Implementation: This category is intended to recognize outdoor recreation accomplishments meeting the 2013 Virginia Outdoors Plan goals and objectives. Awards will be directed in three categories: trail development, public access to waterways including water trails, and other recreational uses and scenic resource recognition. In 2019 county winners included; Prince William County, Roanoke County and Chesterfield County. Information on previous winners can be found on the Award Winners page.




