The Tazewell County 911 Center falls under the direction of the Sheriff of Tazewell County and is an integral part of the Tazewell County Sheriff's Office, an Accredited Virginia Law Enforcement Agency, and the Center is an Accredited Virginia Office of EMS Emergency Dispatch Agency and a Member of the National Center for Missing & Exploited Children (NCMEC) Missing Kids Readiness Program. It is the designated Public Safety Answering Point (PSAP) for multiple paid, volunteer, and combination emergency service agencies throughout Tazewell County and its five incorporated Towns. The Center operates 24/7 processing 9-1-1 and non-emergency calls for service as well as dispatching 33 law enforcement, fire, and emergency medical response agencies. Its range of service covers approximately 544 square miles and serves a population of about 44,000 residents; the Center is one of the largest and busiest in Southwest Virginia and processes over 41,000 incidents and receives almost 100,000 calls annually. The 911 Center employs 24 sworn individuals in operational, technical, and administrative positions.

The 911 Director is required to work alongside regularly with the Tazewell County Administration Office and the Tazewell County Public School System, responsible for overseeing a \$2 million annual budget, and is expected to be a part of multiple boards, committees, community groups, and have a knowledge of local emergency services. The successful candidate will attend multiple trainings, including grant training, and be responsible for applying for and administering multiple grants.


