# **Crisis Communications** Workshop – A matter of when and not if

King George County Supervisor Ruby Brabo kicks off the event.

A County's stability and conditions can suddenly change. Weather and natural disasters, violence, health outbreaks, and public services outages are a few events that can cripple a County's ability to serve and protect its residents.

But with proper preparation, response and recovery - that crisis can potentially turn into hope. A County's crisis communications team can play a pivotal role in disseminating information and conveying resiliency and strength in a time of need.

That's one reason why over 30 County leaders attended the VACo Crisis Communications Workshop on December 3.

Attendees learned how King George County, pushed by the leadership and vision of County Administrator Dr. Neiman Young, reshaped its Emergency Operations Center to best respond to challenging events. Young talked about the County's new tenets of emergency operations such as "all employees are considered essential personnel" and "emergency response is the responsibility of general government employees (not just public safety officers)" in an event of a crisis. PRESENTATION

Rebel Tree LLC owner and public relations expert Miriam Dickler provided a checklist of helpful communications practices and processes when involved in a sudden crisis event. Dickler provided answers to the question, "The crisis is now. Eyes are on you. What next?" PRESENTATION

Attendees worked as a team and were challenged during lunch to devise a plan for different crisis events.


Chesterfield County Director of Communications and Media Susan Pollard spoke next about managing the smoldering crisis. Pollard defined the smoldering crisis as "a condition that is potentially damaging and of which someone in the organization has knowledge, or should, but does nothing." PRESENTATION

The workshop was hosted by King George County Supervisor Ruby Brabo, who also led the discussion on crisis communications by inviting attendees to share their stories. Many expressed a gained perspective on the issue and some even said they know how they would do things differently.

VACo thanks our host Ruby Brabo and the speakers for sharing their knowledge and expertise with our members. Be on the lookout for more workshops on communications in 2020.

# Workgroup Issues Recommendations on State Hospital Overcrowding



The workgroup established in 2019 Appropriations Act language to examine the causes of high usage of the state hospitals for individuals for mental illness and make recommendations for relieving these pressures issued its <u>report</u> on November 22. The workgroup met throughout the spring and summer to discuss the issues surrounding the census pressures on the state hospitals, which at times are operating at or above 100 percent of operating capacity, stressing the hospitals' ability to care for patients and often requiring individuals who are subject to a Temporary Detention Order (TDO) to be transported long distances to an available bed. (VACo reported on the group's discussions in <u>May</u> and <u>July</u> articles in County Connections.)

Legislation enacted in 2014 provides that the state hospitals serve as the "bed of last resort" for individuals subject to a TDO if no alternative placement is available before the expiration of an Emergency Custody Order (ECO). Since passage of the "last resort" legislation, state hospitals have experienced a 333 percent increase in TDO admissions. While the majority of TDO admissions are received by private hospitals, the share of TDOs admitted by private hospitals has decreased since the "last resort" legislation (as noted in the report, private hospitals point out that they are accepting larger numbers of voluntary admissions, which limits their ability to accept involuntary admissions). In an effort to relieve pressure on the state hospitals, the Department of Behavioral Health and Developmental Services (DBHDS) took steps over the summer to add 28 beds at Catawba Hospital, with plans to add 28 more beds pending approval of funding by the General Assembly.

The workgroup's report proposes a set of consensus recommendations, as well as several proposals on which the group disagreed. Among the consensus recommendations are the following:

- Support the continued implementation of STEP-VA, which requires a standard array of services to be offered at each Community Services Board and seeks to provide a comprehensive system of community-based care.
- Support the behavioral health redesign efforts underway at DBHDS and the Department of Medical Assistance Services, which would add several services that focus on prevention and early intervention for mental health crises to the package of services covered by the state's Medicaid program.
- Increase the use of Crisis Stabilization Units and mobile crisis services, and assess the Crisis Intervention Assessment Center model to determine how it might be used to provide relief for law enforcement.
- Support efforts to expand the behavioral health workforce.
- Establish a workgroup to examine the civil commitment process.
- Provide additional funding for private hospital beds for medically complex patients who need psychiatric
  consultation, and provide a specialized inpatient rate for hospitals serving individuals with intellectual or
  developmental disabilities.

Proposals included in the report that were the subjects of significant disagreement include extending the ECO period for individuals who require additional observation or treatment (for example, for individuals with an acute medical condition or individuals who are intoxicated) and expanding the ability to conduct TDO evaluations beyond Community Services Board employees or their designees to include hospital staff. Representatives from law enforcement, Community Services Boards, and private hospitals expressed concerns during the workgroup discussions that extending the ECO period would result in individuals experiencing mental health crises spending more time in law enforcement custody or in hospital emergency departments.

# Commission on Youth Adopts Package of Foster Care Recommendations



The Virginia Commission on Youth held its final meeting for 2019 on December 4. In advance of the upcoming 2020 General Assembly session, Commission members reviewed a series of proposed legislative and budget recommendations developed as part of an extensive study on foster care conducted earlier in the year. Commissioners had solicited public comment on a list of recommendations released in draft form in September. (VACo reported on the study, which may be found at <a href="this link">this link</a>, in an earlier County Connections <a href="article">article</a>). Among the issues identified in the study were the stresses in local departments of social services associated with high turnover among child welfare workers; the need to improve the kinship care system and the Fostering Futures program, which supports foster youth transitioning into adulthood; and the importance of reducing reliance on congregate care placements.

Recommendations adopted by the Commission include the following:

- Support an expansion of the Child Welfare Stipend Program with state dollars. This program, currently funded through federal Title IV-E dollars, supports social work students who commit to work at public agencies after graduation. In its current form, federal requirements stipulate that recipients must spend the majority of their time on IV-E-related work; these strictures limit the program's applicability in smaller departments, where staff may also be performing other child welfare-related duties. A state-funded version of the program would be more flexible in supporting these types of work arrangements.
- Support increasing the minimum salary for child welfare workers and adjusting salaries for current workers.
- Support the continuation of federal funding for Virginia's regional kinship navigator program and direct the Virginia
  Department of Social Services (VDSS) to develop a statewide program to provide information and resources to
  children and their relative caregivers. Direct VDSS to develop an expedited approval process for prospective kinship
  caregivers.
- Direct the Commission on Youth to establish an advisory workgroup to examine the issues involved in establishing guardianship as a permanency option.
- Direct VDSS and the Office of Children's Services to establish a grant program to assist local departments of social services with the recruitment and retention of foster families.

VACo submitted public comments in support of additional state resources to assist with the recruitment and retention of local child welfare workers and foster families, and suggested that the proposed expansion of the Child Welfare Stipend Program and the recommended grant program for foster family recruitment could be particularly helpful in this respect. Improvements to the child welfare system are expected to be a continued topic of discussion in the 2020 General Assembly session, as the state continues to work to implement the major changes to federal support contained in the Family First Prevention Services Act and respond to the recommendations of the December 2018 Joint Legislative Audit and Review Commission report on the foster care system.

### **Visit James City County and Freedom Park**

Freedom Park is James City County's most significant and prestigious historical and environmental protection project, but it has so much more to see and do.



As part of Virginia's Historic Triangle area, where history abounds, Freedom Park's story is unique to the area as it is home to one of the nation's earliest Free Black Settlements, dating from 1803-1850. Visitors can view three historically accurate recreated cabins that are furnished with items authentic to that period.



There's even more history to see - an 18<sup>th</sup> century cemetery; the site of the 1781 Revolutionary


War Battle of Spencer's Ordinary; and a 17th century domicile which is revealing much archaeological research of the early colonial period (1680-1730).

The Freedom Park Interpretive Center features exhibits of artifacts recovered during the construction of the park as well as an interactive kiosk highlighting the history and wildlife of the park, meeting space with a kitchen and fireplace, and an outdoor patio with a fireplace and grilling area. A nearby playground and picnic shelter offer additional opportunities for outdoor fun and social gatherings.



The Williamsburg Botanical Garden, which showcases more than 800 species of native vegetation, is a popular attraction of the Park. Admittance to the two-acre garden is free and members offer the community educational programs and special events throughout the year. Williamsburg Botanical <u>Garden</u>

A variety of trails wind their way through the 600 acres of forest passing historical sites, creeks, a swamp and open meadows. There are more than 20 miles of mountain bike trails, two miles of multiuse trails, a Living Forest Interpretive Trail and an award-winning one-mile ADA accessible multiuse paved trail. This paved trail has received three impressive recognitions:






