# JOB DESCRIPTION: Business Continuity Team Program Manager

# **General Statement of Duties**

The Business Continuity Team Program Manager is expected to be skilled at coordinating and facilitating collaborative meetings, public speaking, professional and technical writing, and have excellent communication skills. The Program Manager will both lead and support projects in a fast-paced team environment.

### **Essential Functions**

- Oversees grant administration of involving multiple funders, aligns and deploys resources, promotes community awareness of programs, and works closely with regional partners;
- Conducts extensive research in specific or general project areas;
- Writes and presents formal and technical reports, working papers, and correspondence;
- Develops strategies that are consistent with local goals;
- Evaluates problems, issues, and opportunities;
- Coordinates regional partners on a regular basis to deliver results for annual projects;
- Responsible for initiating, leading, and facilitating meetings;
- Works closely with the New River Health District, New River Valley Public Health Task Force, local government emergency managers, among other collaborators.
- Attends evening meetings as necessary;
- Performs other duties as assigned.

### Required Knowledge, Skills and Abilities

Experience in project management, public administration, public health, planning, and/or public relations. Creative problem-solving skills to gather relevant information and analyze data. Effective written and verbal communication skills. Ability to work independently or in a team environment as needed. Strong project management ability demonstrated. Experience in grant administration and familiarity with state and federal funding sources is preferred.

# Physical effort, dexterity, visual acuity, hearing, and speaking

The physical exertion requirements of this job are classified as sedentary work. In general, lifting or carrying tasks are not in excess of 10 pounds. A certain amount of walking and standing is often necessary to carry out job duties. The job requires normal visual acuity, depth perception and field of vision.
