Montgomery County Department of Social Services is seeking qualified applicants for the position of Family Services Specialist. Responsibilities include developing and implementing individualized service plans involving the application of casework methods and basic service level caseloads of Adult Protective Services, Child Protective Services, Foster Care and Adoptions. Determine, investigate, treat and prevent adult abuse, neglect and exploitation and provide intensive ongoing social services/case management to those over age 60 or 18 and older and incapacitated, to stop abuse, neglect and exploitation, maximize functioning and independence and prevent loss of life or health. Provide Child Protective Services ongoing to families and children who have been determined high risk for further abuse and neglect while working to continually assess safety, monitoring the home environment, ensure access to needed services and ensure that needs of the children and family are met.

Essential duties include but not limited to: interpret laws, policies and regulations as applied to specific area of responsibility. Monitor, coordinate and administer specific programs as assigned. Coordinate services within specific area of responsibility. Interview and assess client needs and other relevant factors such as education/skill levels, abilities, interests and support systems. Informs clients of related service programs rules/regulations and right to participate. Present cases to determine appropriate services and writes/implements service plans. Provide case management services to monitor compliance. Manage program waiting list. Complete necessary federal, state and local planning and reporting requirements. Conduct overall monitoring of programs in specific area of responsibility. Serves as resource to clients and the community in area of expertise. Work collaboratively with various community agencies, departments, and providers. Provides after hours on-call coverage and responds to emergencies in child/adult protective services and/or foster care.

Position requires a Bachelor's degree in Social Work or related Human Service field; valid Virginia driver's license with good driving record. Minimum salary \$37,705/yr. with excellent benefits (paid health, dental, and vision, flex spending, life, disability, retirement, wellness program).
