Virginia Beach is a full service, independent city with approximately 6500 full time employees and 950 in Public Works. The adopted FY 2021 budget for the Department (including enterprise and internal service funds) is slightly over \$201 Million.

The next Director will be expected to be a highly engaged leader working with the City Manager's Office, City Council and the community on a wide range of current and emerging issues and projects. The City of Virginia Beach is known for its highly professional, innovative staff sharing a commitment to ensuring that Virginia Beach remains a premier community and organization.
