

# Budget Amendments Introduced to Support County Priorities

VACo worked with legislators to introduce a package of budget amendments that address key issues of importance to local governments. House members were required to submit their amendments earlier than usual this year due to the compressed short session; the deadline for House amendments was January 8, and the House Appropriations Committee heard budget amendment presentations from House members who do not serve on the committee on January 18. Senators were required to submit their budget amendments by January 15, and the Senate Finance and Appropriations Committee held its budget amendment hearing on the afternoon of Thursday, January 21. The "money committees" are scheduled to report their respective budgets on Sunday, February 7, in advance of the expected adjournment of the 30-day regular session on February 11. Completion of the legislature's revisions to the Governor's budget is likely to be one of the tasks awaiting the General Assembly in the special session that is expected to be called in mid-February.

VACo is grateful to the patrons of its budget requests for their efforts to ensure that county priorities are under consideration as the budget process moves forward. A list of VACo's requested amendments, many of which are joint efforts with the Virginia Municipal League, is provided below.

Scores of amendments were filed in each chamber, including amendments that VACo supports that were introduced at the request of partner organizations. VACo will be highlighting several of these amendments in a future edition of Capitol Contact.

#### Eligibility for Virginia Telecommunication Initiative Funding

<u>Item 114 #10 (Hurst)</u>, introduced at VACo's request, would broaden eligibility such that a local government or other public entity could qualify for funding from the Virginia Telecommunication Initiative without a private sector



# VACo's Chris McDonald participates in the 2021 VSAE Political Outlook and Legislative Roundtable

On January 8, the Virginia Society of Association Executives (VSAE) held their Virginia Political Outlook and Legislative Roundtable. This annual event, held virtually this year, brought together political experts, lobbyists, and over a hundred other association executives for a morning of election analysis, political punditry, and discussions about the 2021 General Assembly session.

Dr. Robert Holsworth, Managing Partner of DecideSmart and a longtime Virginia political analyst, kicked things off, discussing the national election results from last fall, the months of legal challenges that ensued, and the sense of divide that continues to linger. His talk that morning was particularly poignant, coming just days after deadly riots at the United States Capitol. As he always does, Dr. Holsworth finished his talk by focusing on the future, expressing great interest in how a bellwether state like Virginia would react to the new Biden administration, particularly in the looming General Assembly elections this November.

Next came a panel discussion and Q&A about the 2021 legislative session and what it's like to lobby in a virtual environment. The panel was comprised of three lobbyists: Kyle Shreve, Executive Director of the Virginia Agribusiness Council; Dale Bennett, President and CEO of the Virginia Trucking Association; and Chris McDonald, Director of Government Relations for the Virginia Association of Counties. The three spent just under an hour discussing the challenges of government relations in a virtual world, most notably highlighting the effects the remote proceedings have had on public testimony, communications with legislators, and one-on-one interactions with staff and other lobbyists. All three agreed that rigorous preparation coupled with constant contact with your in-house teammates and your outside allies would be the keys to success this session.

As is the case every year, the 2021 VSAE Political Outlook and Legislative Roundtable offered a wealth of helpful information and unique insights, as well as a much-needed chance to take a deep breath before the General Assembly session kicked off. VACo is grateful to have had a chance to participate in this event and looks forward to the 2022 edition.



## VACo's Jeremy Bennett participates in 2021 VASS-VASBO Winter Conference Panel Discussion on Collective Bargaining

On January 11, the Virginia Association of School Superintendents (VASS) and the Virginia Association of School Business Officials (VASBO) held their annual winter conference. In conjunction with the start of the Virginia General Assembly's 2021 Legislative Session in Richmond, the virtual event offered a multi-session conference exploring budgetary and policy issues that directly affect the budget planning efforts of School Division Superintendents and their School Business Officials.


Event highlights included an analysis of Governor Ralph Northam's proposed budget by Jim Regimbal of Fiscal Analytics, a legislative panel of General Assembly members discussing potential legislative issues to be considered during the 2021 session, an overview of the impact of COVID-19 unemployment issues on school divisions by Chief Workforce Advisor to the Governor Dr. Megan Healy, and an update on the status of broadband access in Virginia by the Governor's Chief Broadband Advisor Evan Feinman.

Part of the conference also included a panel discussion on collective bargaining and its financial implications for school divisions. The panel was composed of three individuals broadly representing the types of local stakeholders that would need to be involved in any collective bargaining effort within a school division; Brenda Pike, Executive Director of the Virginia Education Association; Stephen DeVita, Divisions Counsel for Loudoun County Public Schools; and Jeremy Bennett, Director of Intergovernmental Affairs for the Virginia Association of Counties. The three discussed the legislation from the 2020 General Assembly session that beginning May 1, 2021, allows for collective bargaining for local government employees if authorized by a local governing body. The three discussed the issues, steps and considerations that localities need to be aware of before beginning this process, as well as the types of costs for which school divisions should prepare. Given that Virginia is one of only a handful of states with elected and appointed school boards that depend on the local governing body for local funding to schools, the three panelists agreed that any successful effort to engage in collective bargaining in a school division will require extensive communication and coordination between the local governing body, school board, and school board employees.

VACo is grateful to have been afforded the opportunity to participate in this event as well as for the ongoing efforts of VASS and VASBO to guarantee a high-quality public education for Virginia's students and looks forward to the 2022 conference.

# Visit Highland County and the Sounding Knob Fire Tower



It's easy to elevate your travel experience in Highland, but now you can get even higher. Over 100 steps up the Sounding Knob Fire Tower will give you a lasting memory – and maybe even some wobbly legs! How many mountain ranges can you see?

The tower was constructed in 1934 by the Civilian Conservation Corps, and then it was disassembled and removed from its original location on Sounding Knob in 2002. In 2017, it was restored by the generosity of Skip Jones and Steve Good. It now overlooks Monterey on top of Jack Mountain.

It is located up a gravel drive on Sounding Knob Road just 1.3 miles south of its intersection with Rt. 250. Enjoy one of the best views in Virginia from sunrise to sunset every day. The practice of social distancing is required, and please be sure to exit right when leaving Sounding Knob Road and entering Rt. 250. Vehicles with very low clearance may have difficulty with water breaks on Sounding Knob Road, but most vehicles have no issues.



# SMART SCALE

Funding the Right Transportation Projects in Virginia

### Commonwealth Transportation Board Release Draft SMART SCALE Scores

At its January Meeting, the Commonwealth Transportation Board (CTB) released scores for the fourth round of transportation projects to be evaluated under the SMART SCALE prioritization process. More than 400 applications were submitted by localities, metropolitan planning organizations, and other regional entities across the state, and 397 have been scored based on several key factors: safety, congestion reduction, accessibility to jobs and businesses, economic development, environmental impacts, and land use.

The funding request for this round of SMART SCALE totaled \$6.3 billion, signaling that there continues to be a significant need for investments to support transportation solutions. SMART SCALE applications are scored based on the benefit of the project relative to the cost. The funding available for this round of SMART SCALE totals \$1.374 billion: \$883.7 million for the District Grant Program and \$490.7 million for the statewide High Priority Projects Program.

Between now and June, there will be public hearings with each transportation district, at which the public may comment on the staff-recommended scenario and any potential revisions. Once projects are selected, they are fully funded through construction. The final Six-Year Improvement Program is scheduled to be acted on by the CTB in June 2021.

Appointed by the governor, the 17-member CTB establishes the administrative policies and approves funding allocation for Virginia's transportation system. More information on CTB meeting times access can be found <a href="https://example.com/here">here</a>.

partner. An additional amendment, Item 114 #3s (Edwards), would provide similar flexibility for proposals addressing telehealth or telelearning. Several related amendments, Item 114 #6h (Tyler), Item 114 #2s (Edwards), and Item 114 #9s (Lewis), would direct the Department of Housing and Community Development to establish a one-year pilot program in FY 2022 in which public broadband authorities could apply directly for VATI funding, with a cap of 10 percent of total funding available under the pilot program.

#### Recordation Tax Distribution to Localities

Item 273 #1h (McQuinn), Item 273 #1s (Hanger), Item 273 #2s (Deeds), and Item 273 #4s (Vogel) would make localities whole that would otherwise be affected by the 2020 General Assembly's action to dedicate \$20 million in state recordation tax revenues to Hampton Roads Transit. The amendment would direct \$20 million in additional recordation tax revenues to hold harmless those localities not served by Hampton Roads Transit that previously received distributions of these funds, which could be used for transportation or education needs.

#### Study of Local Fiscal Impacts of Mandatory Property Tax Exemptions

Item 114 #7h (Mugler) and Item 114 #4s (Stuart) would direct the Commission on Local Government to review the effects of mandatory property tax exemptions on local governments' finances and recommend methods to mitigate these potential impacts. The Commission would report to the Governor, the Joint Subcommittee on Local Government Fiscal Stress, and the "money committee" Chairs by November 1, 2021.

#### Hold-Harmless for Local Health Department Funding Formula Change

The Governor's budget would update the revenue capacity data in the Cooperative Health Budget funding formula, which would result in increased local match rates for some localities and decreased local matches for others. The Governor's budget includes hold-harmless funding in FY 2022 for localities that would be required to increase their local contributions. Item 302 #2h (Hudson) and Item 302 #1s (Deeds) would phase in the increased local match such that affected localities would contribute half of their required increase in FY 2023 and the full required increase in FY 2024, thus providing some additional time to adjust to the updated contribution requirements. The amendments also require reporting to appropriate legislative committee chairs on future updates to the funding formula (in addition to the introduced budget's requirement to report to the Governor).

#### Hold-harmless for localities for certain children's psychiatric residential costs

The Governor's budget reflects a change announced by the Department of Medical Assistance Services last fall that costs previously covered by Title IV-E for children in psychiatric residential treatment facilities may no longer be covered by Title-IV-E (which is a state-federal cost-share), and will instead be covered by Medicaid (which requires a local match in these settings). Item 292 #1h (Sickles) would exempt localities from the local match for the costs that would previously have been covered by Title IV-E.

#### Jail per diems

Item 69 #3h (Hope) would provide an increase for jail per diem payments to reflect the parallel increase in the Consumer Price Index since the current rates were set by the 2010 General Assembly. Jails are expected to incur significant costs to comply with new standards for behavioral health and medical care that are in the process of being adopted the Board of Local and Regional Jails at the direction of the 2019 Session of the General Assembly.

#### Reimbursement for general registrar and electoral board member compensation

Item 87 #3h (Tyler) and Item 87 #2s (Deeds) would restore full reimbursement for compensation for general registrars and electoral board members, which was included in the budget as passed in March 2020, but unallotted in April and not able to be restored during the 2020 Special Session. In fall 2019, the Department of Elections estimated that the state would reimburse 69 percent of registrar compensation and 81 percent of electoral board member compensation in FY 2020. Several similar amendments would restore full reimbursement for registrars' salaries and also provide a salary increase.

#### Stormwater Local Assistance Fund (SLAF) and Water Quality Improvement Fund (WQIF)

Item C-70 #1s (Hanger) and Item C-70 #2h (Bulova) provide an additional \$39,792,860 in bond authority for wastewater treatment plant upgrades driven by regulatory requirements from the Department of Environment Quality (DEQ) in order to meet the Chesapeake Bay Phase III Watershed Implementation Plan (WIP). This figure fills the gap between what is currently in the budget and what the DEQ's 2020 WQIF needs assessment calls for. Item C-70 #2s (Hanger) and Item C-70 #1h (Bulova) provide an additional \$50,910,884 in bond authority for the Stormwater Local Assistance Fund (SLAF) in order to meet Virginia's Phase III WIP. This figure fills the gap between what is currently in the budget and what the DEQ's 2020 SLAF needs assessment calls for.

### TRAINING ANNOUNCEMENT

#### Substantial Damage Estimator Training with Crisis Track

Co-hosted by the Virginia Department of Emergency Management and the Virginia Department of Conservation and Recreation

Following a flood event there are two distinct processes that happen to assess damage. One is to assess the level of damage to a residential or commercial structure to be affected, minor, major, or destroyed for the purpose of seeking a presidential disaster declaration which turns on federal grants and resources. The other process known as the substantial damage estimation process, has to do with the local government's requirement to determine if damages of a structure within the FEMA mapped floodplain met or exceeded 50% of the fair market value of the structure. This 50% threshold determines whether or not the property owner will be required by the local government to bring the structure up to all current codes, which includes floodplain compliance. There will also be discussion on implications of this requirement with regard to equity in recovery and mitigation.

Crisis Track is a web-based tool that VDEM has purchased for local use statewide that provides a solution for both assessments and has an interface with FEMA's substantial damage estimator tool. This is a resource to make both processes more streamline and to reduce the administrative burden of assessing damages.
