



## ‘Money Committees’ Release Budgets

The House Appropriations Committee and the Senate Finance and Appropriations Committee met on February 10 and reported their respective amendments to the Governor’s introduced budget. The Wednesday meeting marked a departure from the traditional “Budget Sunday” unveiling of the committee budgets, which was originally scheduled for February 7, but was delayed until later in the week and coincided with the transition to the special session called by the Governor to allow the legislature time to complete its work. The House and Senate started debating the respective committee proposals on February 12.

## Governor Announces Mid-Session Revenue Reforecast

On February 15, Governor Northam notified the chairs of the “money committees” that revenue collections had performed well enough to warrant a mid-session reforecast. General Fund revenues are now expected to increase by \$730.2 million over the biennium relative to estimates included in the December introduced budget - \$410.1 million in FY 2021 and \$320.1 million in FY 2022. The increase is largely attributable to continued strength in sales tax collections, which have grown by 6.5 percent on a fiscal year-to-date basis (the December introduced budget had predicted a 2.6 percent decline in FY 2021). Individual income tax withholding, the lion’s share of General Fund revenues, has underperformed thus far in the fiscal year, growing by 0.4 percent (the December budget had assumed growth of 2.7 percent in this revenue source). The reforecast does not adjust estimates for income tax collections, noting that “there are numerous unknowns on taxpayer behavior for filing, when significant rehiring may begin, and non-wage income gains last year.”

The additional revenues will now become part of the budget conference discussions, where they may ease in bridging differences between the two chambers’ respective proposals. However, House Appropriations Committee Chairman Luke Torian sounded a note of caution in his remarks to Committee members on Monday afternoon after a brief presentation on the additional expected resources, pointing out that state budget needs will continue after the enhanced federal support that has been provided to assist in the pandemic recovery comes to an end.

Dr. Millsaps has a Bachelor of Science degree from American University with a major in Political Science and History; a Master of Public Policy degree from Harvard University Kennedy School of Government; and a Ph.D. from West Virginia University in Policy Analysis and Political Science State and Local Government.

Near Mount Rogers and Whitetop Mountain, Virginia's two highest mountains, Grayson Highlands offers scenic views of alpine-like peaks more than 5,000 feet high. Facilities include a visitor center, campgrounds, and hiking trails leading to waterfalls and overlooks. Scenic horse trails and a horse camping area with electric and water hookups, stables and parking for trailers are available. The park provides year-round access to the Appalachian Trail and the Virginia Highlands Horse Trail.

The Virginia Certified County Supervisors' Program features a five-course curriculum, designed to maximize engagement and enhance scholarship. Each course begins with a six-hour topically driven, classroom session, followed by seven weeks of relevant reading assignments and 90-minute virtual sessions to discuss situation-based exercises. The final component of each eight-week course is a concluding six-hour classroom session, which includes a review of the reading and assignment material.
