The TJPDC office is in downtown Charlottesville, located in central Virginia at the foothills of the Blue Ridge Mountains. Approximately 250,000 residents live in the region, which is filled with history, scenic beauty and urban and rural living. The TJPDC, which also houses the region's Metropolitan Planning Organization (MPO), coordinates a wide variety of short-range and long-range urban and rural transportation, planning and community development projects, as well as regional housing and transit partnerships.

Experience with managing people and finances is essential. The ideal candidate should have a high capacity for successfully communicating with and managing staff; for ensuring positive professional development of staff; and for modeling such best practices. The ideal candidate should also be able to cultivate financial strength by identifying and leveraging funding opportunities, and implement solid business practices regarding financial management and agency budgeting.
