# Department of Taxation Releases Final Guidelines for Disposable Plastic Bag Tax



The Department of Taxation has released final guidelines for the administration of the disposable plastic bag tax. Legislation enacted in the 2020 General Assembly session authorized localities to adopt this tax by ordinance, beginning January 1, 2021. Pursuant to the 2020 legislation, the tax is to be administered by the Tax Commissioner, who was required to develop and make available guidelines for implementation of the tax.

Draft guidelines were released earlier this summer. The final guidelines will be subject to a 30-day public comment period through the <u>Virginia Regulatory Town Hall</u>, which will open September 27 and close October 27. The Department of Taxation has indicated that it does not expect to make changes to the guidelines, and they are planned to take effect October 28, 2021.

# Workgroup Considering Improvements to Involuntary Commitment Process

A workgroup convened by the Department of Behavioral Health and Developmental Services to consider potential expansion of the categories of professionals who may conduct evaluations of individuals for Temporary Detention Orders (TDOs) has concluded its meetings for the year and released a draft report. Currently, these evaluations, which occur when an individual is subject to an Emergency Custody Order, are performed by professionals employed or contracted by a Community Services Board (CSB) who meet certain training and licensure or education requirements, and determine whether an individual meets the criteria for inpatient commitment. If the individual meets the criteria, the evaluator conducts a search for an available bed; if no bed is available before the expiration of the eight-hour Emergency Custody Order, the state hospital is designated as the "bed of last resort."

A 2020 workgroup on the subject was directed by legislation enacted during the 2020 General Assembly session, which required the workgroup to review the current process for conducting evaluations, including barriers to timely completion of evaluations, and to develop a plan to expand the categories of individuals who may complete the evaluations. The 2020 workgroup considered two potential approaches – adding new categories of CSB employees who could be eligible to conduct evaluations, or expanding the pool of evaluators beyond CSBs by allowing emergency department clinicians to conduct the evaluations. There was no consensus on recommendations; although members of the workgroup expressed interest in expediting the evaluation process, in reviewing data from previous studies of the evaluation process, it appeared that the evaluation process is not typically the factor causing delays in the issuance of TDOs, as the vast majority of evaluations begin within two hours of notification. There were also concerns about non-CSB staff's familiarity with community resources and whether they may rely more heavily on hospitalization as a result, and the ability of non-CSB staff who may conduct an evaluation to fulfill the remaining elements of the process, including the bed search and attendance at commitment hearings.

Language in the 2021 Appropriation Act directed the Department of Behavioral Health and Developmental Services to continue the workgroup and report its implementation plan by December 1, 2021. This year, workgroup participants considered the two pathways discussed in the 2020 workgroup – expansion of evaluators within CSBs, and expansion of evaluators to emergency room clinicians – and also proposals to improve the quality of the ECO/TDO process (to include improving the patient experience), as well as enhancing administrative efficiency. The draft report includes the following recommendations from the workgroup:

- Improving the use of peer support services for individuals undergoing TDO evaluations, with a goal of improving the experience for the individual in crisis.
- Establishing a quality review committee for TDO evaluations, based on some concern about variability in the evaluation process at the local level.
- Developing crisis services that offer specialized care, such as alternative services for individuals with a primary diagnosis of dementia or individuals with intellectual or developmental disabilities. A separate workgroup is examining ways to divert individuals with dementia from hospitalization.
- Considering ways to enhance psychiatric treatment in emergency departments as a potential strategy to reduce TDOs or minimize time spent in inpatient hospitalization.
- Continuing improvements to the psychiatric bed registry system, which is intended to track available beds and is in the process of being redesigned.

The workgroup also discussed potentially allowing additional CSB staff to qualify as pre-screeners, provided that these individuals met certain criteria for education and experience. There was limited interest during this round of study in allowing emergency department clinicians to perform evaluations at this time.

A final report is due by December 1.

Backbone Rock Campground is a small campground situated along the beautiful Beaverdam Creek at an elevation of 2,100 feet in northern Johnson County. This developed campground is popular with those visiting the nearby Backbone Rock, a tunnel originally blasted through the rock ridge for the railway. The creek side location with popular swim area and lush forest surroundings make Backbone Rock Campground particularly desirable during hot summer months. With 10 campsites and an adjacent large Civilian Conservation Corps- built reservable pavilion with lawn, Backbone Rock is a great option for a group to reserve the whole campground for retreats and other events.

Backbone Rock Recreation Area is located along Beaverdam Creek in northern Johnson County. Backbone Rock gets its name from a spur ridge on Holston Mountain that abrubtly ends at a bend in Beaverdam Creek.

A tunnel was drilled through the rock in 1901 to allow railroad access between Shady Valley and Damascus, VA. Motorists pass through what is known as "The Shortest Tunnel in the World" as they travel along TN 133. In the 1930s The Civilian Conservation Corps (CCC) developed the recreation area for day use, constructing two picnic shelters and hiking trails that incorporated native stonework. The campground was added in the 1960s and rehabilitated in the mid 1990s.

If you are reading this right now, then you are inhaling and exhaling air, a simple yet sophisticated process of exchange that occurs approximately ten times every minute. # Cybersecurity: A Better Way to Test Readiness than Experiencing Reality

Let's face it, when it comes to some realities it is best to not experience them at all. No one wants to experience a fire in their home or a devastating earthquake, tornado, tsunami, or pandemic. Similarly, no one wants their privacy stolen or the critical assets of their organization threatened. While we would like to avoid risks altogether, we know that they are part of reality; and while nothing tests our readiness quite like reality, we will perform better if we properly prepare.

So, we prepare accordingly. We use risk management protocols to protect and defend against a variety of risks. An example of this is the auto-shutoff switches to our electrical breakers in our homes that prevent a surge in electricity which could cause a fire. We use seat belts to prevent injury from an auto accident. We also use incident response and recovery plans when risks do become reality. Conducting fire drills in schools, offices, and our homes help to prepare us if there is a fire and where we need to respond quickly to protect ourselves and others. We use documented playbooks and manuals sometimes when responding and recovering from a risk-turnedreality because emotions and anxieties can cloud judgement and impair decision making during the chaos of a crisis. It is for similar reasons that we have cyber simulations; we prepare for a reality that we hope never occurs. We prepare because we know the occurrence is very possible, and perhaps, very probable in today's world.

Our understanding of the probability of a cyber risk occurring is similarly high. We know that it is common practice to talk about an inevitable hack, phishing attack, data ransom, or even network sabotage. We also know from security officers, risk managers, and administrators in our community that counties, government agencies, and organizations are not as prepared as they would like to be for the cyberattacks threatening their operations, stakeholders, critical assets, and overall brand. For a variety of reasons (budget, staffing), counties lack fully tested incident response procedures and fully detailed operationalized playbooks ready for use to mitigate cyber threats and to adequately respond to attacks before they become a crisis. Consider the following list of threats. Are you prepared?

# American Rescue Plan: Opportunities to Fund Water Infrastructure Policies



VACo is pleased to announce an upcoming webinar on the American Rescue Plan and ways ARP funds can be used for water infrastructure priorities.

The American Rescue Plan Act (ARP) established the Coronavirus State and Local Fiscal Recovery Funds, an \$65.1 billion allocation for local government to use to respond to acute pandemic response needs, fill revenue shortfalls and support hard-hit communities. It also allows funds to be used for "necessary investments in water, sewer or broadband infrastructure.

This 1.5-hour webinar will provide an overview of the ARP, detail how funds can support stormwater and wastewater, share several examples of local government plans for funding, and a follow-up document with jurisdiction and national resources for additional questions. The webinar goals are to address questions, learn of examples, and consider funding projects that address long-standing water infrastructure needs.

The webinar is completely free to join and is scheduled for Tuesday, September 14 at 10am (EST). Speakers for the event include Diana Esher (EPA Region 3 Acting Director), Adam Pugh (NACo Associate Legislative Director), Carolyn Berndt (National League of Cities Sustainability Legislative Director), and Jasmine Gore (Mayor of Hopewell, VA and Local Government Advisory Committee Chair).



Each applicant can request up to \$50,000 to pursue a variety of projects that address these goals. # VDOT Virginia 2022-26 Strategic Highway Safety Plan Update Regional Meetings



The actions engage the **5** Es of the highway safety community: Education, Enforcement, Emergency Response, Engineering and Planning, and Everyone to reduce the impact of crashes on the lives of those travelling in Virginia.



**Tedd Povar**, retired Associate Director of the Virginia Institute of Government; **Dr. Sheryl Bailey**, Visiting Professor of Practice at Virginia Tech and former Chesterfield County Deputy County Administrator; and **Larry Land**, retired VACo Director of Policy Development, served as judges for this year's statewide competitive awards program.

### Henrico County and its Equity Ambassadors program won this year's Best Achievement Award.

"Equity Ambassadors is a wonderful program that has gained in popularity among Henrico County students over the past couple of years," Dr. Bailey said. "The students recognized a need for their voices to be amplified on issues of equality, and they took action to make it happen. Equity Ambassadors also provides students with opportunities to learn positive leadership. I speak for the judges when I say we are honored to give this program the Best Achievement Award."

The judges also selected a Best Small County Achievement Award (50,000 or less population) and a Best Large County Achievement Award. **Nelson County** and its **Blue Ridge Tunnel Rehabilitation and Trail Project** program captured the **Best Small County Achievement Award** while **Chesterfield County** and its **Innovation Bootcamp** program earned the **Best Large County Achievement Award**.

"Congratulations to Nelson County for winning its first-ever Achievement Award, and for such an excellent program," Land said. "The county turned an abandoned railroad tunnel built in the 1850s into a regional recreation asset. I'm sure traveling through the long, dark tunnel is quite a thrilling treat, and I look forward to experience it one day."

Povar, who has served as judge since the Achievement Awards inception in 2003, said Chesterfield County's winning program reflects an important criteria for the VACo Achievement Awards. "As judges, we look for how a county uses innovation or ideas to solve a problem," Povar said. "Chesterfield County's program is about teaching the process of innovation from start to finish. In fact, this program was created because one of Chesterfield County's core values is innovation. Congratulations to Chesterfield County for a tremendous program and for continuing to be a leader in the VACo Achievement Awards program."

**Chesterfield County** tops the all-time Achievement Awards list with 39. Chesterfield County has won an award in each year of the 19-year history of the program. **Henrico County** is second on the list with 34 Achievement Awards while **Loudoun County** is third with 25.

The VACo Achievement Awards is a competitive program open to local government members of the association.
