# Meg Bohmke Elected VACo President for 2021-2022

**RICHMOND (November 16, 2021)**— The membership of the Virginia Association of Counties elected Stafford County Supervisor Meg Bohmke as 2021-2022 President during VACo's 87<sup>th</sup> Annual Conference, which was held in Norfolk. Bohmke and other newly elected officers started their terms at VACo's Annual Business Meeting on November 16.

Bohmke succeeds Fairfax County Chairman Jeffrey C. McKay, and becomes the second President from Stafford County since 1935. Stafford County Supervisor Ferris M. Belman, Sr., led the association in 1999-2000.

"I'm honored to be elected by my colleagues to serve as President of VACo," Bohmke said. "I cannot wait to get started in advocating for our localities, and I look forward to continuing to work with leaders across the Commonwealth to improve our communities."

Bohmke was first elected to the Stafford County Board of Supervisors in November 2013 to represent the Falmouth District. She was elected Chairman by her fellow Board members for 2018 and again for 2020.

Bohmke previously served on the Stafford County School Board for four years starting in November of 2009. She and her family have lived in the Falmouth District for 16 years. Bohmke worked in public finance for 13 years, most recently for Prudential Bache Securities and Sutro & Company, where she structured short- and long-term municipal bond issues that were sold in the capital markets.

"Meg is a thoughtful leader who brings civility and respect to county governments," VACo Executive Director Dean Lynch said. "Meg's background in education, finance and other legislative issues will serve our association well. We are excited to have her as our next President."

Bohmke received her Bachelor of Science degree from Florida State University in 1981. She is a past elder in the Fredericksburg Presbyterian Church where she currently teaches Sunday School. Bohmke and her husband Dave have three children, Matt, Greg, and Natalie.

"I'm excited for this opportunity to serve localities and to work with my VACo colleagues," Bohmke said. "There is so much we have accomplished and can accomplish together. I know VACo well, and can confidently express that we are well-represented at the local level with outstanding leaders."

#### **Visit Charlotte County and the Charlotte State Forest**

CHARLOTTE COUNTY—Governor Ralph Northam recently announced the dedication of the Charlotte State Forest, opening the first publicly-accessible state land in Charlotte County. The 5,004 acre state forest is Virginia's 26th state forest in the Commonwealth. The Virginia Department of Forestry will sustainably manage the forest under Sustainable Forestry Initiative and American Tree Farm Standards, conserving key habitat areas and providing new public access to outdoor recreation activities.

"Virginia's state forests are critical to preserving environmental sustainability and a strong economy across the Commonwealth," said Governor Northam. "Charlotte State Forest will conserve wildlife habitats, enhance water quality, provide recreational opportunities for the public and support local economies. We look forward to enjoying this new outdoor asset."

The forest was owned by Governor Thomas B. Stanley, who served from 1954 to 1958, and the Stanley Land and Lumber Corporation prior to The Conservation Fund's purchase in 2019. It was used to provide shortleaf and Virginia pine, as well as white oak and hickory, to local mills for furniture.

Virginia's forests contribute \$21 billion annually to the economy and employ more than 108,000 workers. Charlotte County is located within the state's highest timber producing region. The river, stream and wetland resources on these forests drain into Kerr Lake, which provides drinking water to nearly 500,000 residents in Virginia and North Carolina.

"As Virginia's third largest industry, forestry plays an essential role in Virginia's economy," said Secretary of Agriculture and Forestry Bettina Ring. "Close collaboration between the Virginia Department of Forestry, The Conservation Fund, the Stanley family, and other public and private partners made this important acquisition possible and will ensure that it is sustainably managed for current and future generations."

"This property is a very special place. Its legacy of sustainable management for both timber and wildlife habitat, combined with its important water resources have made it an important location here in Charlotte County," said State Forester Rob Farrell. "Today we celebrate the future of Charlotte State Forest, its continued sustainability, its contribution to Virginia's economy, and its importance to the many individuals and families who will have the opportunity to enjoy recreational activities here."

"Ensuring the integrity of large forested landscapes and keeping them in sustainable management is one of the most important conservation strategies today," said The Conservation Fund Virginia State Director Heather Richards. "By continuing the legacy of three generations of the Stanley family and the Stanley Land and Lumber Corporation and creating Virginia's newest State Forest, we are safeguarding the forest's ability to provide vital climate, economic and ecological benefits for generations to come. We are grateful to our partners in the Commonwealth and the U.S. Forest Service, support from Virginia's U.S. Congressional delegation, and funding from the federal Land and Water Conservation Fund and the Richard King Mellon Foundation. Together, we made this wonderful outcome possible."

To acquire the forestland from The Conservation Fund, the Virginia Department of Forestry leveraged federal, state and private funding through the USDA Forest Legacy Program, the federal Land and Water Conservation Fund, agency mitigation funds, and additional Land and Water Conservation Fund Stateside grant funding.

"The United States Forest Service is pleased to support and partner with the Virginia Department of Forestry to protect this important and historic working forest that will provide wildlife habitat, abundant recreational opportunities, and timber resources through ongoing sustainable management," said Southern Regional Forester Ken Arney. "Forest Legacy projects can take several years to accomplish and require a high degree of commitment from partners and landowners. We applaud the amount of work that went into making this happen." ## "Money Committees" Hold Annual Retreats



The "money committees" held their annual pre-session retreats last week, with the House Appropriations and House Finance Committees meeting in Richmond on November 16 and 17 and the Senate Finance and Appropriations Committee gathering in Roanoke on November 18 and 19. These meetings traditionally offer an overview of state and national economic conditions and staff's revenue projections, as well as a preview of major budget pressures and key funding issues that will be considered during the upcoming legislative session. Common themes of the two retreats were the significant additional resources expected in the current fiscal year and over the biennium relative to the budget adopted in spring 2021, paired with notes of caution, as revenues are expected to return to more typical levels of growth in future years, and uncertainty remains regarding the future course of the coronavirus and macroeconomic forces such as labor shortages, supply chain disruptions, and inflation.

#### **House Appropriations**

In addition to the <u>staff presentation outlining revenue projections and key budget drivers for the</u> <u>upcoming session</u>, the House Appropriations Committee and House Finance Committee heard <u>a</u> <u>presentation from the National Conference of State Legislatures</u> on revenue trends among states and use of federal relief funds; a <u>staff briefing on progress in meeting Chesapeake Bay water quality</u> <u>requirements</u>; and <u>an update on several studies regarding compensation among state employees (in</u> <u>particular the Virginia State Police and the Department of Corrections workforce) and sheriffs' deputies</u>. Committee members also received a <u>presentation on a proposed National Slavery Museum in Richmond</u>.

Given continued strong growth in state General Fund revenues, House Appropriations Committee staff are projecting 5.2 percent revenue growth in FY 2022, a significant upward revision to the current forecast of an 8 percent decline. However, staff cautioned that recent revenue growth is "atypical," noting that growth since 2001 has averaged 4.2 percent, and reminding Committee members of the traditional volatility of nonwithholding collections, which represented nearly half of the FY 2021 surplus. Staff project General Fund revenue growth of 3.9 percent in FY 2023 and 3.6 percent in FY 2024 (these growth rates would be adding to the larger FY 2022 base, representing a projected increase of \$9.6 billion in available resources over the biennium above levels in the 2021 Appropriation Act). In addition to the significant expected increase in General Fund revenues, the state also retains \$1.1 billion in Coronavirus State Fiscal Recovery Funds from its American Rescue Plan Act (ARPA) allocation.

Although Staff Director Anne Oman pointed out that the General Assembly could theoretically fund all requests submitted by state agencies for the biennium (packages totaling \$2.1 billion in FY 2023 and \$2.5 billion in FY 2024), there are also \$2.7 billion in expected cost increases over the biennium for current programs. These required or high-priority items include rebenchmarking of the Standards of Quality; inmate medical costs in the Department of Corrections; aid to localities with police departments (which is required to increase along with General Fund revenue growth); the Medicaid forecast; continued implementation of crisis services and the Marcus Alert initiative as well as STEP-VA; implementation of changes to federal funding for foster care; and costs of supply chain disruptions for state procurement, among other items.

Staff strongly encouraged members to dedicate one-time revenues to one-time spending items, providing a menu of such potential uses, including paying down unfunded liabilities in the Virginia Retirement System state employee and teacher plans; addressing capital outlay needs; eliminating the requirement for certain retailers to make an accelerated payment of sales and use taxes in June each year; providing a taxpayer relief payment; recapitalizing the Literary Fund; setting aside a deposit for the Major Headquarters Workforce Grant (which is anticipated to be required in 2028); supplementing programs such as the Virginia Telecommunication Initiative and the Housing Trust Fund; and funding the development of business-ready sites or industrial site revitalization.

Other possible funding priorities identified by staff include the Board of Education's revisions to the Standards of Quality (which total \$812.7 million over the biennium), additional funding for workforce credentialing or community college access, compensation for public safety and mental health staff, additional Medicaid waiver slots, and tax reform.

One aspect of the biennium budget that will likely draw particular interest is K-12 rebenchmarking, traditionally a technical process that updates the components of the school funding formula. Preliminary figures for 2022-2024 rebenchmarking (currently estimated at \$233 million for the biennium, pending additional data updates to be included in the Governor's budget in December) indicate a significantly smaller cost than in previous biennia, in part due to the use of FY 2020 data for certain cost elements that were affected by pandemic-related school closures and may not be reflective of costs moving forward, notably pupil transportation, substitute teachers, and utilities. Staff suggested that legislators may instead wish to use FY 2019 data with an inflation adjustment as a base year in order to provide a more accurate reflection of costs for the upcoming biennium. The preliminary rebenchmarking estimate does include FY 2022 "no-loss" funding for enrollment as a placeholder, noting that post-pandemic enrollment is difficult to project. The preliminary estimate also reflects savings in VRS employer contribution rates for the teacher plan, as the plan benefitted from strong stock market gains, as well as an infusion of \$61.3 million in FY 2021. In addition to possible use of more representative data, staff's list of policy considerations for members includes continuing to use current VRS rates (rather than factoring in the savings associated with lower rates) in order to reduce the unfunded liabilities, as well as a reminder that federal pandemic relief funding includes a maintenance of effort requirement for state K-12 spending.

#### **Senate Finance and Appropriations Committee**

Members received <u>a presentation on the state and national economic outlook from Sonya Ravindranath</u> <u>Waddell of the Federal Reserve Bank of Richmond</u>, followed by <u>a panel discussion on workforce issues</u>. In addition to the <u>staff overview of state revenues</u>, members also received more detailed briefings on <u>K-12 funding</u> and <u>major issues in health and human resources</u>. Members also participated in breakout discussions of <u>rural economic development</u> and <u>issues in higher education</u>.

Similar to the House Appropriations Committee staff, Senate Finance and Appropriations staff anticipate a "significant upward adjustment" to the FY 2022 forecast, with revenues returning to more normal growth in FY 2023 and FY 2024. Staff project revenue growth of 5.1 percent in FY 2022, 3.8 percent in FY 2023, and 4.2 percent in FY 2024. Although staff anticipate significant resources available beyond the levels assumed in the current biennium budget, Staff Director April Kees encouraged caution, noting that recent revenue growth is anomalous, and uncertainty remains with respect to a resurgence of the virus, supply chain disruptions, inflation, and a lagging recovery in certain industries, such as leisure and hospitality. She strongly encouraged consideration of one-time spending items, such as using cash for capital projects, as a strategy to manage this uncertainty.

A key decision facing legislators that will affect General Fund revenues is the extent to which Virginia will conform to the tax-related provisions of the American Rescue Plan Act - for example, excluding grants to businesses under the Restaurant Revitalization and the Economic Injury Disaster Loan Advance programs from income taxes. Staff noted that fully conforming to the ARPA tax provisions would have an estimated revenue impact of \$101.6 million in FY 2022. Legislators also must decide whether to continue the current state income tax exemption for Paycheck Protection Program loan forgiveness and the deductibility of a fixed amount of business expenses funded by forgiven Paycheck Protection Program loan proceeds, as well as the existing income tax subtraction for grants made through the state Rebuild Virginia program.

Major budget pressures – what Senate Finance and Appropriations Committee Chair Janet Howell termed "bills in the drawer"— identified by staff include SOQ rebenchmarking; the Medicaid forecast; water quality funding; capital outlay; enhancing Medicaid waiver rates and adding more waiver slots; compensation proposals developed by workgroups examining pay structures for the Virginia State Police, Department of Corrections, and sheriffs' deputies; the Stormwater Local Assistance Fund; state hospital census reduction; the Housing Trust Fund; behavioral health facility compensation and staffing; reduction of VRS liabilities; and a one percent salary increase for state employees, state-supported local employees, and teachers, among other needs. Projected Medicaid spending in FY 2022 reflects a highly unusual reduction of \$653.7 million as a result of the enhanced federal match rate provided during the public health emergency, as well as decreased utilization and lower managed care rates. However, the forecast for the biennium reflects an expected return to more normal levels of spending growth, as the enhanced federal match rate expires; GF spending growth for the Medicaid program is projected at \$821.2 million over the biennium (reflecting annual growth of 18.5 percent in FY 2023 and 3.9 percent in FY 2024).

#### Next steps

The Governor's Advisory Council on Revenue Estimates (GACRE) will meet on November 22 to review the economic outlook for the current fiscal year and the upcoming biennium, and the Governor will present his revised forecast and proposed amendments to the budget for the current fiscal year (the "caboose" bill), as well as his proposed budget for the 2022-2024 biennium (which will include a six-year revenue forecast), on December 16.

# LOCAL GOVERNMENT ATTORNEYS HONOR CYNTHIA E. HUDSON

2021 FINNEGAN WHITING AWARD FOR DISTINGUISHED SERVICE

The Local Government Attorneys of Virginia, Inc. (LGA) awarded its highest honor, the Edward J. Finnegan/Elizabeth D. Whiting Award for Distinguished Service, to Cynthia E. Hudson, currently an attorney with Sands Anderson PC and formerly Chief Deputy Attorney General of Virginia and City Attorney of Hampton, at its recently concluded fall conference in Richmond, Virginia.

The Finnegan Whiting Award recognizes Cynthia Hudson for her significant and sustained contributions to Virginia local government law and LGA. The Award noted that her "knowledge of local government law combined with her expertise in public policy, makes her one of the most accomplished and well-respected attorneys practicing in Virginia's public sector today." In addition to her distinguished employment history, Ms. Hudson has served the Commonwealth of Virginia as Chair of the Governor's Commission to Examine Racial Inequity in Virginia Law, Co-Chair of the Governor's Commission on Diversity, Equity and Inclusion, and as a former President of LGA.

Just prior to her receiving the award, the President of LGA, Michelle R. Robl, announced that the LGA Board of Directors had added the name of Elizabeth D. Whiting to the title of the award. Ms. Whiting, who died in September, was an authority on local government law, a mentor to local government attorneys throughout the state, a former president of LGA, and a prior recipient of the Finnegan Award. The presenters of the Finnegan Whiting Award noted it was particularly appropriate that Ms. Hudson was the inaugural recipient of the renamed award as she, like Liz Whiting, "is beloved and deeply admired and respected for her remarkable career, her integrity and intellect, and her generous spirit."

#### VACo and VML Host Webinar on Opioid Litigation Settlement and Opioid Abatement Fund

Patient Na Opioids Signature

VACo along with VML hosted representatives from the Office of the Attorney General, local government attorneys, and law firms involved in litigation with opioid manufacturers and distributors for a webinar on October 25 to inform localities about participation in the \$26 billion national settlement with Janssen (a manufacturer of opioids) and several opioid distributors. Virginia stands to receive approximately \$530 million over the course of the settlement period, with the exact amount dependent on participation by local governments. Local governments must join the settlement by January 2, 2022, to receive funds; participation requires a locality to adopt resolutions approving a Memorandum of Understanding with the Commonwealth and entering into the settlement agreement.

Under the terms of the settlement, 15 percent of the funds will be distributed to participating localities and are not restricted in their use, 15 percent will be distributed to participating localities for abatement purposes, 15 percent will remain with the Commonwealth, and 55 percent will be deposited to the Opioid Abatement Fund, which was established in the 2021 legislative session.

The Opioid Abatement Fund, which will be administered by the Opioid Abatement Authority, will divide its funds as follows: 15 percent to participating localities, 35 percent to participating localities' regional partnerships, 15 percent to state agencies, and 35 percent for any of the preceding purposes or for administrative expenses. The statute creating the Authority states that its purpose is "to abate and remediate the opioid epidemic in the Commonwealth through financial support from the Fund, in the form of grants, donations, or other assistance, for efforts to treat, prevent, and reduce opioid use disorder and the misuse of opioids in the Commonwealth." The Honorable James Holland, Chair of the Chesterfield County Board of Supervisors, serves on the Board of Directors of the Authority.
