Montgomery County Emergency Services seeks Deputy Director of Emergency Medical Services to join our growing Emergency Services team. Reporting to the Director of Emergency Services, the Deputy Director of EMS Operations will be responsible for supervising six (6) full-time and twelve (12) or more part time emergency responders to provide lifesaving services in designated areas of the County.

Essential duties include but are not limited to: manage daily operations and staffing; prioritize and assign work; conduct staff performance evaluations; ensure staff training and development to required levels of certification; serve as a member of the departments' leadership team; maintain extensive knowledge (and certification/credentialing) of EMS and ALS techniques and equipment; perform records management compliant with local and state policies; may serve on various committees and/or as liaison to other EMS agencies, hospitals, skilled nursing facilities and other key organizations; provide and/or ensure emergency response with acceptable response times on a twenty-four hour basis; respond to questions/concerns and information requests from news media, community & civic organizations, officers, employees and superiors; prepare and forward purchase requisitions for needed materials, equipment and other supplies, and similar duties of a highly responsible nature.

Qualified candidate will possess Associate Degree in relevant field or equivalent combination of education and experience plus: Nationally Registered Paramedic, Virginia Paramedic certification, ICS 100, 200, 700, and 800, ACLS, PALS, PHTLS, AMLS, valid Virginia driver's license, and approved emergency vehicle operator's course (all required). Additional preferred qualifications include: Virginia Department of Fire Programs Firefighter I and II, Hazardous Materials Operations, ICS-300 and 400.
