The Journeyman - Traffic Signals position is a full-time career opportunity with benefits and a preferred hiring range of \$15.35 - \$17.65 per hour (equivalent to \$31,928 - \$36,712 annually). The ideal candidate for this position will perform work in the Traffic Division and have a desire to learn more about the trade through on-the-job training.

As a Journeyman - Traffic Signals, you will:

- Assist with preventative maintenance on traffic control devices and related systems;
- Assist with calls for service on equipment malfunctions, including identifying problems and taking appropriate action to resolve problems;
- Document service calls and problem resolutions;
- Assist with routine scheduled maintenance on traffic signal equipment;
- Maintain and repair school beacons;
- Assist with inspecting, programming, and activating traffic control devices upon completion of installation;
- Assist with wiring and installing electrical services for all traffic control devices;
- Assist with refuse collection, as needed;
- Be considered essential for departmental operations during inclement weather and assist with snow and ice removal;
- Perform all other related duties as assigned.

Minimum Requirements:

- High school diploma or GED and minimal experience in one of the building trades, or equivalent combination of education and experience.
- Valid driver's license with the ability to acquire an appropriate Commercial Driver's License within six (6) months of hire date.
- Possession of current Virginia Department of Transportation Basic Work Zone Safety Certification or the ability to obtain within six (6) months of hire, or as class scheduling permits per department approval.
- Availability and willingness to participate in a non-working hours stand-by program.
- Availability and willingness to participate in departmental operations during inclement weather.
