

# <u>General Assembly Adjourns, Will Return</u> <u>for Special Session to Finalize Budget</u>

The General Assembly adjourned on Saturday, March 12, as planned, but without completing work on revisions to the current budget and a budget for the upcoming biennium. Legislators agreed to allow the budget bills, as well as any other legislation pending in conference committees at the time of adjournment, to be carried over to a special session for further work. It is expected that the Governor will call the legislature back for a special session soon, although the planned date is unknown at this time.

At the time of adjournment on Saturday, 45 bills awaited final resolution; several of these bills have agreed-upon conference reports, but these agreements had not been approved by both chambers at the time of adjournment. Many bills are in conference because they have budgetary implications - notably the different approaches to elimination of the grocery tax represented by <u>HB</u> <u>90 (McNamara)</u> and <u>SB 451 (Boysko)</u> – and must be negotiated in tandem with budget discussions. In addition to the grocery tax legislation, several bills of interest to local governments are in conference and await resolution in the special session:

• <u>HB 563 (O'Quinn</u>) and <u>SB 473 (McClellan</u>) take differing approaches to meeting school capital needs. As passed by the House, HB 563 requires the Department of Education,

in consultation with the Department of General Services, to develop a data collection tool to assist school boards in determining the relative age of each school building and the amount of maintenance reserve funds necessary to restore each building. The bill also establishes the School Construction Fund to be used for awarding grants to local school boards for construction or renovation of expansion of school buildings, and dedicates otherwise-uncommitted casino gaming proceeds to the School Construction Fund. SB 473 also sets up a School Construction Fund and dedicates casino gaming proceeds to the Fund; the bill specifies maximum grant amounts for school boards based on school divisions' local composite indices.

- <u>SB 471 (McClellan)</u> modifies provisions governing use of the Literary Fund, including establishing a competitive program for subsidizing school divisions' loan closing costs, establishing an annual open application process for Literary Fund loans, creating a loan-add on to incentivize projects resulting in school consolidation, and setting interest rates that are benchmarked to a market index, with rates set on a sliding scale based on school divisions' local composite indices and capped for localities with the least ability to pay. The House added a reenactment clause to the bill, which was incorporated into the conference committee's report and agreed to by the House, but must still be approved by the Senate.
- <u>SB 490 (McClellan)</u> requires each school board to provide at least four specialized student support positions per 1,000 students (current standards require three of these positions per 1,000 students). The House version of the bill eliminates this language and instead incorporates staffing requirements for principals and assistant principals funded in the House budget.
- <u>HB 349 (Tata)</u> directs local departments of social services to provide six months of housing support for young adults aging out of foster care who decline to participate in the Fostering Futures program. As passed by the Senate, the bill contains language making its provisions contingent on funding in the state budget.
- <u>HB 653 (Wampler)</u> requires local boards of social services within each Department of Social Services region to collaborate to expand the pool of available foster homes and to facilitate approval of kinship foster parents. The Senate also added financial contingency language to this bill.

Bills that passed during the last week of the 2022 regular session are now before the Governor, who must take action by midnight on Monday, April 11, in advance of the April 27 reconvened session. VACo appreciates its members' advocacy on key issues of importance to counties in the two budget proposals and will provide updates on the special session as more information becomes available.



# Visit Albemarle County and the Albemarle County Courthouse

Location: 501 East Jefferson Street / Park Street

Built: 1761 – 1781

Style: Greek Revival

Architect: William Cabell

Contractor: William Cabell and John Moore

**Description:** The building faces south and is a two story red colored brick structure. The building is located on landscaped grounds in the center of Charlottesville. The south front has a large portico with four tall Ionic columns rising to a pediment at the roof line. The windows have stone headers. On the roof is a white colored octagonal cupola. The building has expanded northwards. The 1762 building was torn down and the building was enlarged in 1803. The architects were Willliam D Meriweather, Isaac Miller and George Divers and the contractor was John Jorday. An addition was constructed in 1859 and in 1879 to 1880, the courthouse was enlarged with the addition of the south wing with its Ionic portico. Renovation work was done in 1938. The architect was Milton Grigg and Flloyd Johnson. The building was renovated in 1963. The architect was Johnson, Crevan and Gibson. The building is located on the east side of Courthouse Square with the District Court along the west side.

\$100 million in federal funds now available to Virginia localities for drinking water infrastructure



The Virginia Department of Health (VDH) is now accepting applications for grants and loans to improve drinking water infrastructure. Federal funds made available through American Rescue Plan (ARPA) and the Bipartisan Infrastructure Law (BIL) covers the following types of projects for small and disadvantaged community waterworks:

- Facilities to improve drinking water quality
- Transmission and distribution: improvements in water pressure and prevention of contamination in infrastructure and lead service line replacements
- New sources to replace contaminated drinking water or increase drought resilience, including aquifer storage and recovery system for water storage
- Green infrastructure, including green roofs, rainwater harvesting collection, permeable pavement
- Storage of drinking water, such as to prevent contaminants or match water demands
- Buying of water systems and interconnection of systems
- New community water systems
- Constructing publicly owned treatment works
- Projects related to implementation of a nonpoint source pollution management program established under the Clean Water Act (CWA)
- Decentralized wastewater treatment systems that treat municipal wastewater or domestic sewage
- Management and treatment of stormwater or subsurface drainage water
- Water conservation, efficiency, or reuse measures
- Development and implementation of a conservation and management plan under the CWA
- Watershed projects meeting the criteria set forth in the CWA
- Energy consumption reduction for publicly owned treatment works
- Reuse or recycling of wastewater, stormwater, or subsurface drainage water
- Security of publicly owned treatment works
- Some stormwater infrastructure, lead remediation, and certain rehabilitations of dams and reservoirs are available for SLFRF funding



Zero Fare Grant Program for Public Transit Applications Due April 8, 2022

The Virginia Transit Association (VTA) is pleased to announce the third year of its Transit Zero- Fare for Working Families program, a competitive grant program designed to help needy families by promoting access to employment and job training through public transit. In total, up to \$500,000 will be made available to local governments, nonprofit organizations, and transit agencies.

The program is funded though Virginia's federal Temporary Assistance for Needy Families (TANF) block grant. This program will support projects that benefit persons that have a dependent child and are below 200% of the federal poverty level. Eligible projects include providing fixed route bus service, on demand bus service, public van pools, and other public transit services for TANF eligible persons traveling to and from work or job training.

The application window will open on Monday, March 14 with applications and cost estimate projections due by Friday, April 8 at 4:00PM. 


# 2022 Spring Resiliency Academy

# **2023 VATI Guidelines and Criteria Input Sessions**

DHCD will award grants to eligible applicants to provide last-mile services to unserved areas of the Commonwealth. The budget is subject to final approval of the 2022-2023 state budget and allocation of federal funds to be managed and awarded through the VATI grant making process.

## VACo and VML Host Webinar on Opioid Litigation Settlement and Opioid Abatement Fund

VACo along with VML hosted representatives from the Office of the Attorney General, local government attorneys, and law firms involved in litigation with opioid manufacturers and distributors for a webinar on October 25 to inform localities about participation in the \$26 billion national settlement with Janssen (a manufacturer of opioids) and several opioid distributors. Virginia stands to receive approximately \$530 million over the course of the settlement period, with the exact amount dependent on participation by local governments. Local governments must join the settlement by January 2, 2022, to receive funds; participation requires a locality to adopt resolutions approving a Memorandum of Understanding with the Commonwealth and entering into the settlement agreement.

Under the terms of the settlement, 15 percent of the funds will be distributed to participating localities and are not restricted in their use, 15 percent will be distributed to participating localities for abatement purposes, 15 percent will remain with the Commonwealth, and 55 percent will be deposited to the Opioid Abatement Fund, which was established in the 2021 legislative session.

The Opioid Abatement Fund, which will be administered by the Opioid Abatement Authority, will divide its funds as follows: 15 percent to participating localities, 35 percent to participating localities' regional partnerships, 15 percent to state agencies, and 35 percent for any of the preceding purposes or for administrative expenses. The statute creating the Authority states that its purpose is "to abate and remediate the opioid epidemic in the Commonwealth through financial support from the Fund, in the form of grants, donations, or other assistance, for efforts to treat, prevent, and reduce opioid use disorder and the misuse of opioids in the Commonwealth." The Honorable James Holland, Chair of the Chesterfield County Board of Supervisors, serves on the Board of Directors of the Authority.
