

## **Deputy Director for the Department of Family Services – Loudoun County, Virginia**

Located in Northern Virginia, approximately 45 minutes northwest of Washington, D.C., Loudoun County is a growing and thriving community of more than 420,959 residents (2020 est.), surrounded by the Blue Ridge Mountains and the Potomac River. Dulles International Airport, a major facility serving nearly 25 million passengers every year, is in the southern part of the County. The expansion of the D.C. Metro Silver Line into Loudoun County will enable transit-oriented, mixed-use developments with new and exciting living and dining options and allow residents to travel conveniently into and around the Washington, D.C. area. Loudoun's towns are known for their historic charm with downtown shopping districts that have restored buildings from the 1800's.

The Deputy Director position is available due to the promotion of the previous incumbent, and reports to the Director of the Department of Family Services. The Deputy Director will oversee all direct client service operations, provide the implementation of business plans, and assist with the development and implementation of the department budget, as well as the preparation and presentation of key agenda items to the County Administrator and Loudoun County Board of Supervisors. Loudoun County's Department of Family Services operates with an annual operating budget of \$31 million and the support of 212 FTE's to serve County residents and their families.

The ideal candidate would possess any combination of education and experience equivalent to a Master's degree in Social Work, Public Administration, or a related area with a minimum of six years of related work experience with increasing responsibility in a complex human services system, with at least two years in a supervisory or management role. Experience in local government, skills in clinical practice, and experience working with a culturally diverse workforce and community is preferred. Previous experience in a collective bargaining environment is a plus.

Loudoun County offers a hiring range of \$140,000 - \$170,000 depending on qualifications and experience. Additionally, the County offers an extensive and generous benefits package.
