
# Building Upon Strength

- Our **VALUES** can be summarized by the "7 Cs."




## Our Goal

Technology, best management practices and improved communication tools will also be used to build on DEQ's strong foundation.


# Four Initiatives

4. Commodity trading platform for mitigation


# One DEQ

- Balanced distribution of operations at CO and regional offices.
- Better utilize workforce, address regional increases in workload and provide surge capacity.
- Support, train and develop staff.



# PEEP

- Identify and implement technological improvements to foster transparency, collaboration and efficiency.
- Develop Critical Path Management schedule to track approval process to ensure timely decisions.



# Stormwater and Erosion Control Programs

- Create one comprehensive manual that is continuously updated to reflect evolving technologies and regulations.
- Provide training and certification program to reduce review.




# Commodity Trading Platform

- Develop trading platform for water-related commodities to provide transparency for permittees with regard to prices as well as supply and demand.
- Assist market in meeting demands of a strong economy.

\*UPDATE TANKER CRASH\*

- ▶ The 9,000 gallon capacity tanker designed with inner compartments; only one was compromised. VDEM evaluated a 1,250-gallon release
- ▶ Amount in damaged compartment estimated at 2,500 gallons (slow leak)
- ▶ Transfer of all compartments expected @ 6:30 p.m.
- ▶ Fire department, Roanoke Hazmat Team & state's emergency contractor provided containment for damaged tanker. ... [See more](#)
