INTRODUCTION:

Prince William County is seeking qualified candidates for the position of Director for the Office of Community Safety. This is a newly created role in Prince William County. The ideal candidate will be a courageous, innovative, and visionary leader with outstanding people, analytical and management skills. The successful candidate will have proven experience in community safety programs, with a specific emphasis on facilitating multi-sector collaborations.

The Director will work in the Office of Executive Management and will report to the Deputy County Executive for Public Safety. The Director will collaborate with community stakeholders to address community safety issues and concerns.

About this role:

The Director will be charged with leading our Community Safety Initiative (CSI), which will be a holistic, evidence-informed, equitable, and inclusive approach to improving safety and security in Prince William County. The Director will be responsible for fostering community collaboration and engagement, building trust, conducting in-depth assessments, determining strategic priorities, creating action plans, tracking performance, ensuring quality improvement, and sustaining success.

The CSI scope and activities will be far-reaching and expansive, to include participants from all sectors and solutions which involve prevention, intervention, diversion, and accountability. The Director will oversee Community Safety staff members and coordinate a Community Safety Initiative Advisory Committee.

Minimum Requirements:

We require a High School Diploma / GED and eight years of related experience.

Preferences:

The preferred candidate will have a Bachelor's degree, supervisory experience and eight (8) years of community safety experience. We seek a candidate with a demonstrated "track record" of working closely with key community stakeholders and who is community engagement oriented. They should

be politically astute, yet apolitical, within a highly political environment. This individual will be engaging and charismatic, but also a data-oriented and outcome-driven problem solver, with an explicit commitment to advancing equitable and inclusive community safety solutions.

Monday - Friday, 8:30am - 5pm, with flexibility required to attend evening meetings and occasional weekend events.
