“The Position”

Under general supervision, this position inspects construction on all types of public works projects, both publicly and privately funded new construction and existing improvements, including, but not limited to, grading, street improvements, concrete and brick sidewalks and aprons, ADA ramps, storm drains, underground utility systems such as water and sewer, and fire suppression systems to include flow testing. Conducts waterline pressure tests, bacteriological tests on newly installed water mains, sanitary sewer pressure tests, and manhole vacuum tests. Inspects repair and/or installation of outside utility companies such as gas, electric, and fiber. Ensures all work performed in the right of way conforms to City standards and specifications. Ensures dumpsters and PODS placed on City streets are in compliance. Monitors, enforces and may design and approve traffic control plans and pedestrian safety plans in place for construction work. Conducts pre construction meetings, reviews and approves as-builts, conducts site finals and approves bond releases.

Education, Experience and Credentials: A successful candidate will have a high school diploma or GED equivalent; three (3) years of experience in the construction inspection field or equivalent education, and/or experience. Candidates will have or be able to obtain within six (6) months certifications including but not limited to basic soil science, concrete and asphalt certifications, confined space entry and OSHA 10. Erosion & sediment control and/or stormwater inspector certification preferred.

Must have valid Commonwealth of Virginia Driver's License or a reciprocal state issued license that can be transferred to Virginia. Intermediate Traffic Safety Certification (VDOT) required or must obtain within 6 months.
