Fairfax County: Fairfax Connector Free Student Bus Pass Program

**Abstract:** 

The Fairfax Connector Free Student Bus Pass program launched August 2015 to address issues surrounding the deficit of late afternoon school bus service due to the later shift in school start times. This program allows all Fairfax County students (grades 7 – 12), including private and homeschool students, to ride Fairfax Connector for free from 5 AM – 10 PM, seven days a week, 365 days a year. The program now includes +Metrobus (Washington Metropolitan Area Transit Authority- WMATA) for five high schools, including one for students with special needs, without access to Fairfax Connector service. To date students have taken over 2.7 million trips on Fairfax Connector and Metrobus.

Need/Issue:

During 2010, Fairfax County Public Schools (FCPS) conducted a sleep study for high school students. The results indicated that students needed more time to sleep and FCPS adjusted high school start times to later in the morning. However, FCPS did not have the budget to purchase more school buses or hire additional drivers. As a result of the adjusted high school starts times to later in the morning, afternoon buses were limited to once per week. This lack of adequate transportation for students disenfranchised students who needed to stay late for

after school assistance, school clubs and sports, as well as other after school activities. Students who had a stay-at-home parent/guardian or who could afford a car, were at an advantage to other students who have neither. The ability to participate in extracurricular activities is critical to successful college applications, at all levels, and can set a student up for success later in life. Fairfax Connector had both capacity on buses and a flexible bus network that would allow students to ride for free, if structured correctly.

**Program:** 

The Free Student Bus Bass Program (FSBPP) was launched in Fall 2015 to all Fairfax County middle and high school students. Staff developed brochures, a flash pass (which expired annually), posters and promotional materials to get the program started. This included briefing middle and high school principals and educators to convince them that Fairfax Connector had a role in the transportation of their students. The FSBPP was met with skepticism, at first, as concerns over liability, safety, and use of the public buses we discussed. We shaped the program terms and conditions with the help of FCPS administration. As a result, students can ride using their student bus passes seven days a week from 5 AM - 10 PM, 365 days a year. There is no restriction on the pass otherwise. Students can use the buses to get to/from school, jobs, movies, meet-ups with friends, etc.

In 2016, the City of Fairfax asked that its CUE bus system be included in the program, so we

could provide seamless coverage between the City of Fairfax, which sits in the middle of Fairfax

County, and the County, and vice versa. In 2017, we began working to address a separate need

with Justice High School, which is at the eastern end of the County and did not have Fairfax

Connector service near campus but was instead served by WMATA's Metrobus. We worked

with Fairfax County Public Schools (FCPS) to establish a Memorandum of Agreement (MOA) and

with WMATA on a Memorandum of Understanding (MOU) to purchase specially programmed

and designed SmarTrip cards and to launch a pilot at Justice HS to use Metrobus in addition to

Fairfax Connector. It took approximately one year to finalize the interagency agreements and

launch the FSBPP Student Pass SmarTrip card and the Free Student Buss Pass + Metrobus

program. Staff reported regularly to the Fairfax County Board of Supervisors Transportation

Committee on the program successes. By 2021, the Board of Supervisors voted to expand the

+Metrobus program to 4 additional schools: Annandale HS, Falls Church HS, Marshall HS, and

Davis Center. These schools are in legacy WMATA Metrobus service areas with less access to

Fairfax Connector bus service.

Davis Center is unique amongst these schools because it caters to high-functioning students

with developmental and intellectual disabilities such as Autism and Down syndrome. Staff

adapted program materials into social stories and created an animated video customized for

students with special needs using best practices and feedback from the Principal at Davis

Center.

Staff regularly attend high school pyramid student events to educate parents and students and

distribute passes to those that are interested. Parents are provided with Free Ride Coupons to

ride with their student and practice riding the bus. Staff conduct travel training for students of

all abilities both independently and in coordination with WMATA Metrobus. Staff visits schools

at lunch time to promote the program.

All participating schools are provided with large format system maps and a customized display

for bus schedules and information. All materials are in English and Spanish including animated

videos. Materials are also inclusive so that all students regardless of gender, race, ethnicity or

ability can see themselves in the marketing materials. All materials were produced in-house. No

contractors were used for this program.

**Agency Role:** 

Staff needed to develop the entire Free Student Bus Pass program from the ground up. This

included gaining technical knowledge and specifics about the regional SmarTrip card and

"reverse engineering" the system to adapt it in such a way as to protect student privacy, while

giving complete control to the individual schools over the SmarTrip cards and continually

training students and administrators on how to maximize use of this technology.

Staff were also responsible for collaborating with legal counsel at multiple agencies (FCPS, FCPS

Transportation, and WMATA) to develop memoranda, systems, integration, testing, guidance,

and best practices. The Head of Marketing for Fairfax Connector served as the sole project

manager from 2015 – 2022, in addition to other responsibilities of marketing the system. In

2022, due to the overwhelming success of the program, the Board of Supervisors approved a

new position for a Student Bus Pass Program Coordinator.

FSBPP was a good faith effort put forth by Fairfax County to ensure transportation equity for

students in Fairfax County in accordance with One Fairfax. This has led to additional policy

changes such as "12 and under ride free with paying adult" (beginning May 1, 2023) so that any

child living in Fairfax County from birth to high school graduation will be able to ride Fairfax

Connector for free.

Costs:

Staff hours total 4,000 hours since the program's inception. This includes staff time, legal

counsel, outreach efforts, material design, program design, SmarTrip card and accounts

troubleshooting, elected official briefings, surveys, etc. Fairfax County DOT has also purchased

over 30,000 SmarTrip cards, at a cost of \$60,000 from WMATA. \$50,000 has been spent on the

printing of marketing materials and advertising in the schools. Costs for Fairfax Connector trips

are in-kind, while the +Metrobus program costs are \$2.00 per trip (approximately \$300,000).

Results:

To date, students have taken over 2.7 million trips on Fairfax Connector and Metrobus at no

costs to FCPS or students (see infographic), as this effort is fully funded within Fairfax County

Department of Transportation's existing budget. Prior to the COVID-19 pandemic students were

taking nearly 50,000 trips per month (March 2020). Ridership dropped precipitously as schools

closed. However, as of February 2023, student ridership has fully recovered to pre-Covid levels.

FSBPP continues to be a lifeline for Fairfax County students which account for nearly 7% of

Fairfax Connector overall ridership.

After the first year of the program, FCDOT polled students, parents, bus operators, school

counselors, and school administration early on to find out more about the impacts of the

program from all sides. The results were surprising. Students and parents loved the program,

teachers and counselors could better support at-risk students, and students who missed the

school bus could take Fairfax Connector and not miss the full day of school. Students felt more

"grown up" and "responsible," and loved that they could save money getting to jobs and see

friends. They could visit a family member across town to stay more connected. So many

students were so grateful for this new tool that they begged us not to take it away. Counselors

have reported students staying in school until they graduate because they do not want to lose

their student bus pass. We even surveyed our bus operators to determine if there were any

behavioral issues on the bus. Operators reported that while our regular customers were well-

behaved, the students were even better behaved than the regular passengers because they

knew they could lose their pass (and freedom) if they acted inappropriately. This feedback has

been consistent over the past eight years.

We have consistently described this program as having a "pebble in the pond" effect. That one

student who can stay after school for help or to participate in an extracurricular activity, is hired

for an after-school job, earns good grades, admitted to college or a trade school, which allows

them to support themselves and a family and live a better quality of life -- all because of a free

bus pass. The need to seek peer support by connecting with friends or being able to leave an

abusive household for a safe trip on the bus is also met. It is the improved comfort level taking

transit which allows them to live a car-free lifestyle because they know how to use the bus

system. Fewer cars on the road means less dependence on foreign oil, improved air quality, less

congestion, fewer crashes, accessibility to good jobs and healthcare. Transit savvy students lead

to transit savvy adults.

FSBPP has had such an incredible impact on families and students in Fairfax County and we are

pleased to see that it continues to grow and serves as a model for other transit agencies eager





The number of trips has rapidly increased in eight months since the Expansion of the program started in September of 2022




