FCDOT is seeking a motivated Network/Telecommunications Analyst I to provide first level technology support to the Transit Services Division for multi-user transit specific systems at various FCDOT facilities. Under the general supervision of a Network/Telecommunications Analyst II, this position will be responsible for supporting network operations, administering servers, and servicing hardware and peripherals. This position will also work with both county and contractor staff to provide application access, training, and end-user support.

Responsibilities include:

- Assisting with server administration and patch management;
- Serving as an Agency Access Control Administrator (AACA) for transit specific applications, such as CAD/AVL, transit planning, fleet maintenance, and revenue collection systems;
- Deploying and configuring various types of hardware and peripherals at user sites;
- Assisting in the installation of more complex software and equipment;
- Maintaining an inventory of agency hardware and software;
- Responding to and prioritizing requests from users to provide guidance and assistance;
- Providing basic one-on-one training to users; and
- Working as a member of the FCDOT IT team supporting the department.
