This senior level position offers the opportunity to contribute to the County's growth and development in a nationally recognized Smart Growth Community.

The director will lead and work with a team of experienced, creative, and passionate staff while building a sustainable, desirable community. This Department Director is appointed by the County Manager and serves on the executive leadership team providing leadership to the County's strategic urban planning and development efforts.

Challenges/Opportunities facing the CPHD Director:

- Leading the Department providing strategic direction to division managers in the effective implementation of County goals and policies and ensuring cohesive balanced services among the major functional areas;
- Serving as a spokesperson for the County for its planning, housing and community development policies at local, regional and national levels;
- Directing the planning and implementation of multiple programs, including the development of long-range plans to effectively meet County strategic goals and growth and development policies;
- Ensuring the fiscal stewardship of the Development Fund, which includes fees from developers, funds for staffing inspection and development services, and overseeing formulation and execution of the CPHD Budget;
- Enhancing the reliability and consistency of services provided to Arlington residents, visitors and businesses;
- Successfully engaging with and influencing a highly involved and informed community at the neighborhood, business, developer, civic association, and appointed board, commission and committee levels;
- Overseeing the implementation of Expanded Housing Opportunities (EHO) and ensuring that the County Board's Equity Resolution principles are a part of planning policies;
- Improving and preserving the quality of Arlington's neighborhoods, both low density residential and high density commercial and residential

neighborhoods located along the County's metro corridors and other areas within the County;

- Defining strategies, in collaboration with Arlington Economic Development and other County departments, to address the changing economic and demographic conditions and forces that are actively reshaping Arlington's traditional office, retail and housing markets;
- Providing input on a portion of the Capital Improvement Plan that will address the short- and long-term public investments necessary to support economic development and neighborhood needs;
- Ensuring that the County's development review, permitting, plan review, and inspection services are effectively managed, fully coordinated, and employ the best practices and technology necessary to provide the highest level of service; and
- Ensuring that the Implementation of Permit Arlington will provide easy and direct services to customers; working closely with partners in the Department of Environmental Services and the Department of Technology Services to streamline the building and land development and permitting process.

- An innovative and strategic thinker who sees the broader picture while simultaneously managing complex community planning, housing and development issues and projects; and/or
- Ability to constructively engage with a community that is diverse, welleducated, knowledgeable, and highly involved in all aspects of local government, and to build consensus on highly controversial issues.
