

# DIRECTOR OF INFORMATION TECHNOLOGY

### **GENERAL DEFINITION**

This position performs management and leadership responsibilities for the planning, organizing, budgeting, and execution of all functions for the Department of Information Technology encompassing County departments, agencies, and/or clients. The Director will manage all technical and application support ensuring infrastructure availability, business continuity, network development & maintenance, disaster recovery, records retention, and the security of the County's software applications, hardware, networks, and telecommunications systems. Responsible for establishing a comprehensive technology program management framework for planning, budgeting, project management, process engineering, change & portfolio management in directing the department,

## **ORGANIZATIONAL RELATIONSHIP**

Work is performed under the general direction of the County Administrator or designee. Supervision is exercised over all departmental personnel.

#### TYPICAL RESPONSIBILITIES

- Plans, organizes, and directs the overall programs, budget, and activities of the Department of Information Technology; work involves formulating strategic long-range plans, preparing and managing a comprehensive budget and providing technical consultation to the County departments;
- Responsible for researching, recommending, and implementing technology to support key business applications including hardware, software, telecommunications, and infrastructure (network development);
- Prepares and maintains IT policies, reports, standards and best practices to ensure the integrity of all data and systems;
- Responsible for developing metrics, policies and standards to monitor the customer service components of Information Technology as an internal service provider;
- Coordinates and assists County departments and agencies in preparing, reviewing, evaluating, implementation, and oversight of technical specifications for the bid process for all equipment and software related projects;
- Manages IT staff including recruitment, performance management and evaluations, and professional development;
- Continued evaluation of the security of the IT infrastructure to ensure the safety and reliability of the County data and records entrusted to the IT personnel;
- Prepares, submits, and manages an annual operating and capital budget for technology needed to support the County's long-range technology plan;
- Keep abreast of new knowledge, research, products and services in technology that will benefit Franklin County and its citizens;
- Serves at a contact for local government partnerships in community technology issues, broadband deployment, state and local projects, and community technology development;
- Coordinate with the Virginia State CIO office to implement and enforce state technology requirements;
- Responsibilities include measurable cost effective results for the substance, efficiency, productivity, accountability, and quality of the County's technology programs and services.
- Performs other duties as may be assigned.

## ESSENTIAL KNOWLEDGES, SKILLS AND ABILITIES

• Comprehensive knowledge of the principles, practices and techniques of technology systems and how they support County operations;

- Knowledge of systems analysis, programming and computer/telecommunications operations, as well as business processes related to automated systems;
- Project management knowledge including familiarity with systems development methodologies;
- Ability to think logically, reason, negotiate and resolve conflicts;
- General knowledge of policies, procedures, and operations of Local Government and its departments, agencies, and clients;
- An understanding of cyber security threats and vulnerabilities in order to implement, manage, and enforce not only physical security but digital security policies and practices;

## TRAINING, EDUCATION AND EXPERIENCE

Any combination of education and experience equivalent to graduation from an accredited four-year college or university with major in computer science, information systems, public or business administration or related field. Master's degree preferred. A minimum of 10 years of progressively responsible professional experience in information technology field, including supervisory experience of technical staff, are required.
