# Virginia Counties Recognized for Model Programs



**RICHMOND (August 3, 2023)**—The Virginia Association of Counties (VACo) is pleased to announce the 33 recipients of the 2023 Achievement Awards, which recognize excellence in local government programs. VACo received 135 submissions.

Winning entries focused on addressing issues of addiction, education, and revitalization, as well as finding solutions to other challenges that counties face daily.

#### 2023 Achievement Awards Entries

"I want to thank all who participated in the 21<sup>St</sup> year of the Achievement Awards," VACo Executive Director **Dean Lynch** said. "I'm encouraged to see that we received 135 submissions, our highest total ever. This tells me that the VACo Achievement Awards' mission of identifying and celebrating the innovative work by local government officials continues to resonate with our counties. We thank all who participated and give special recognition those who won an award."

**Charles Hartgrove, ICMA-CM**, Director of the Virginia Institute of Government; **Dr. Sheryl Bailey**, Visiting Professor of Practice at Virginia Tech, and former Chesterfield County Deputy County Administrator; and **Larry Land**, retired VACo Director of Policy Development, served as judges for this year's statewide competitive awards program.

**Alleghany County** and its **Alleghany/Covington School Consolidation** program won this year's **Best Achievement Award**.

"What Alleghany County achieved is historic – a feat that has been accomplished only three times in the Commonwealth since 1982," Dr. Bailey said. "It took Alleghany County more than 50 years of conversation to complete the merger of the new Alleghany Highlands Public Schools. But Alleghany County got it done, and in its first year of operations saved more than \$450,000 in personnel costs without any involuntary layoffs. The consolidation assisted county leaders to navigate the nationwide teacher shortage. This Best Achievement Award program deserves a 'Go Alleghany Cougars!"

The judges also selected a Best Small County Achievement Award (50,000 or less population) and a Best Large County Achievement Award. **Dinwiddie County** and its **City Planning Project** program captured the **Best Small County Achievement Award** while **Chesterfield County** and its **Chesterfield Recovery Academy** program earned the **Best Large County Achievement Award**.

Hartgrove, who served his first year as judge, said Dinwiddie County's winning program reflects an important criterion for the VACo Achievement Awards. "We are inspired by innovative programs that connect students with local governments," Hartgrove said. "We think it's important for the future of local government to show the youth that serving at the local level can be a rewarding and successful career choice. This program is designed to spark a student's interest in planning or local government administration. Congratulations to Dinwiddie County for designing such an impactful program."

Land praised Chesterfield County for being a leader in the Achievement Awards program. "Chesterfield County again has developed a program that sets itself apart," Land said. "The Chesterfield Recovery Academy is the first recovery school in the state, and is a multi-community effort that can be replicated by other counties to help fight against adolescent addiction. Thank you, Chesterfield County, for creating an environment of support for families and those struggling with addiction."

**Chesterfield County** tops the all-time Achievement Awards list with 49. Chesterfield County has won an award in each year of the 21-year history of the program. **Henrico County** is second on the list with 42 Achievement Awards while **Loudoun County** is third with 30.

The VACo Achievement Awards is a competitive program open to local government members of the association.



## Visit Grayson County and the Grayson County Historic 1908 Courthouse

The Historic 1908 Courthouse serves as the Art & Cultural Center of Grayson County. The Foundation is a private non-profit corporation whose mission is to preserve the building and make it available to the people of Grayson county and the surrounding areas. The building served as the county courthouse for Grayson County from 1908, when it was built, until 1979 when the county government moved into the new courthouse. Located at the junction of highways US21 and US58 in far southwest Virginia, the 1908 Courthouse is in the center of Independence, the county seat. It is the second courthouse to be built on this spot and the third courthouse overall in the history of the county. Since the Grayson County government moved into their new quarters in the late 1970's, the 1908 Courthouse has been restored and now houses the Crossroads Museum, the Baldwin Auditorium, and the Treasury Gift Shop, as well as offices housing businesses and other non-profit organizations.

#### **Chesterfield Names New Chief Information Officer**



Scott Furman, previously Chesterfield's deputy chief information officer for the county's Information Systems Technology (IST) Department, has been promoted to chief information officer.

Furman, who has worked for Chesterfield IST since April 2022, will lead a team of 106 full-time employees. The IST team is responsible for ensuring information security governance, overseeing infrastructure and project management, and providing technology solutions. The department's important role extends to support forty-six different departments, as well as constitutional offices, housed within Chesterfield County.

Before joining the county team, Furman had a 19-year career with the Federal Reserve System. He held several high-ranking positions, including as Senior Vice President within the National IT organization and a three-year tenure as the System's Chief Technology Officer. His leadership in these roles led to transformative infrastructure programs that helped unlock millions in reinvestment dollars, achieved through highly productive strategic business and vendor partnerships.

Furman also had an additional 15-years of experience in the private sector, where he focused on designing technology strategies that enabled achievement of critical business goals. The outcomes of his efforts were consistently recognized for delivering crucial technology services and innovative digital solutions that produced significant value to the business functions he served.

"I am truly humbled by the trust and confidence placed in me by Dr. Casey, Mr. Bowles, and the many others involved in the extensive evaluation and selection process for the CIO position," Furman said. During my short time here, I've witnessed the IST team's hard work, dedication, and enduring commitment to excellence, and I am honored to have the opportunity to lead such an outstanding group."

# Mike Flagg retiring from Hanover County after distinguished 27-year career



Mike Flagg managed it all – solid waste and recycling, road construction, project management, compliance with environmental regulations, crisis response, flood mitigation and Hanover's airport, to name just a few. That might sound daunting, but for Hanover County's retiring Public Works Director, responsibility and initiative are fundamental parts of his character.

When he was a teenager, Mike operated his own cantaloupe and watermelon farm. He farmed about 30 acres of land owned by his grandmother. To harvest the fruits, he enlisted the help of several school kids even younger than himself. "I'd feed them and pay them a little," he recalls. He will always remember the kindness of a local merchant who refused repayment at the end of the growing season, since Mike needed the money for college. "So many people have helped me all my life," he acknowledges.

Graduating from Patrick Henry High School in 1981, Mike paid his own way to Virginia Tech, where he earned a degree in agricultural engineering. That set him up for a tenure with the State Department of Conservation and Recreation, where he worked for over eight years.

Mike's last year farming was 1985. "It's a nice lifestyle if you like to work outside and be independent but it's tough financially," he explains. He remained involved in agriculture with his work with the soil and water programs throughout the state and Soil and Water Conservations Districts such as the one in Hanover-Caroline.

In 1996 he returned to his native Hanover as a civil engineer, reviewing building permits, site plans and construction plans. During his 27 years with the County, Mike has managed or engineered the construction of nearly every new public facility in Hanover – including but not limited to fire stations and rescue squads, the County garage, libraries, parks, the Sheriff's Firing range and the Administration Building.

He also helped to grow the County's road program. Mike led efforts on such projects as the first leg of Lakeridge Parkway, the extension of Telegraph Road and the bridge over the Chickahominy River, and the construction of roundabouts at the intersections of Rural Point/Studley and Creighton/Cold Harbor. With the success of the roundabout program, several more could be built at appropriate intersections over the next few years.

Mike is most proud of paving all of the state-maintained gravel roads in the County, which up until 15 years ago were many. "We had very little money to pave these roads, we were entering an economic downturn and VDOT was getting ready to claw back some funds," he explains. "But we were able to bid them all in a package and we had a contractor that really wanted to do it and he gave us a great price." As a result, there are virtually no unpaved state roads anywhere in Hanover County anymore.

He is also proud that his department consistently provides exceptional service for the dollar to County residents. "My people are great," he says. "Because of them we have been able to meet all of the environmental regulations that we were concerned about not being able to meet. We've protected our citizens from flooding by and large because of the way we've managed development. When you look at communities that flood, Hanover is not one of them despite the fact that we've had some large rain events. My team spends a lot of time thinking about what could happen and who could be hurt if there is a flood."

Flagg has been out there with his team in ominous situations. He recalls how Tropical Storm Gaston created a 42-acre 'bowl' of water that had no way to drain; the floating of septic tanks might create an environmental hazard, he feared. With the approval of County Administration, he rented pumps and with the assistance of the Fire Department they manually drained the bowl for a week. "By the time we finished pumping at the end of the week, leeches were growing in the water," he recalls. The department later applied for and received a grant to help mitigate that hazard.

When the concrete at the Route 301 grinder needed to be expanded, but there wasn't enough money in the budget to hire a contractor, Mike gathered together several of his co-workers together and they poured the slab as a team. When the department faced a shortage of truck drivers after COVID, Mike obtained his Commercial Drivers License to assist with waste hauling on the weekends. "Mike never asks his staff to do anything he wouldn't do himself," said County Administrator John A. Budesky.

Always modest, Mike says the great thing about Hanover is the solidarity and team spirit not only within his department but between all departments. "Working here has been about the best thing that ever happened to me," he says, except for his wife Lisa, three children and two grandchildren.

But it's time to go, he concedes. Mike is retiring on July 31. "I realize I'm not going to live forever, and I need to change my focus," he explains. There are things to do at home – right now he's constructing an addition to his kitchen. His wife wants to travel. His children and grandchildren live nearby and he wants to spend more time with them.

"Who knows?" he says. "I might want to go back and raise some vegetables."



# Deadline for counties to complete housing policy survey is September 1, 2023



Pursuant to legislation adopted in the 2023 legislative session, Section 36-139.9 of the Code of Virginia directs the Department of Housing and Community Development (DHCD) to annually collect housing policy reports from localities with a population greater than 3,500. The reports shall summarize the adoption or amendment of any local policies, ordinances, or processes affecting the development and construction of housing during Fiscal Year 2023 (July 1, 2022 – June 30, 2023). DHCD has developed a survey tool, that incorporated recommendations from VACo and the Virginia Chapter of the American Planning Association (APA-VA), for localities to use in the preparation and submission of this required report. The link to the FY2023 Local Housing Policy survey is now live and available here: FY2023 Local Housing Policy Survey. The deadline for completing the survey is September 1, 2023.

According to DHCD, the intent of this survey is to collect information that highlights the efforts localities are making to increase accessibility, affordability, and attainability of housing within the Commonwealth. These efforts may include actions that affect the supply of available land for housing, the variety and availability of housing options, the cost of producing housing units, or the time it takes to go through the land use and permitting processes. Submitted survey responses will be used to generate a locality's report and will be made available to the public on the DHCD website.

The Virginia Department of Emergency Management (VDEM), in coordination with the Virginia Information Technologies Agency (VITA) and the Virginia Cybersecurity Planning Committee (VCPC), would like to inform you of an upcoming grant opportunity - the State and Local Cybersecurity Grant Program (SLCGP). The VCPC has been working to develop the new <u>Virginia Cybersecurity Plan</u>, which was approved on Monday, July 31 as a requirement of the SLCGP and will soon be developing grant priorities and application criteria.

The VCPC recognizes the broad range of prospective applicants who may be interested in learning more about this grant program - local governments (and their respective departments/authorities), tribal governments, public schools, and higher education. To ensure that all have access to this information, VDEM has set up a list serve that interested parties can use to register for updates on the coming funding opportunity. VDEM anticipates the application period to open soon and will use this list serve as a mechanism to provide grant guidance, communicate key deadlines, and to provide technical assistance and resources as interested parties consider applying for this funding.





# Best Practices for Local Governments in the Allocation of Opioid Settlement Funding

Tony McDowell, Executive Director | Virginia Opioid Abatement Authority

Virginia has already received settlements worth more than \$500 million from prescription opioid manufacturers and distributors, and that number could double. Most of these funds will flow to Virginia's cities and counties for efforts to abate the opioid crisis. As Virginia's cities and counties develop local and regional plans for the use of these funds, some best practices are beginning to emerge.

The first of these is **establishing a local abatement committee** comprised of various stakeholders including prevention and treatment specialists, public health, behavioral health, law enforcement, and people with lived experience.

Some communities are holding **town hall style public meetings** or listening sessions so that local leaders can hear from residents who have been directly affected by the prescription opioid epidemic, as well as from service providers and community-based organizations. The OAA's Board of Directors has been following this approach, and has already conducted six public listening sessions around the state. The feedback from these sessions has been instrumental in informing the Board's strategy for allocating grants.

Local governments are encouraged to **engage with community partners**, especially those that have already been fighting the opioid epidemic for years. This certainly includes the local Community Services Board, but in addition there are many non-profits, grassroot organizations, treatment providers, and recovery support organizations that want to be involved. During its listening sessions the OAA Board has heard numerous examples of such organizations that have been barely surviving financially, working off of donations and volunteer effort. These organizations often know exactly how to reach the people who are sick and suffering, and have a track record of stretching dollars for maximum impact. The OAA is only able to provide funding to cities, counties and state agencies. This means the opioid settlement funds will not reach these non-government organizations unless there is a partnership with the local government.

The OAA is committed to providing assistance to cities and counties in developing their abatement plans. We offer **planning grants** and are in the process of launching a series of best-practice webinars and workshops. 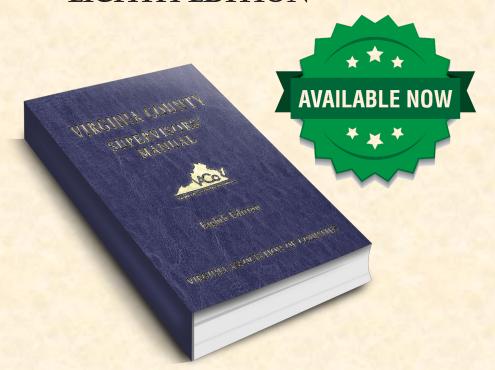
