Prepares and prosecutes cases in all courts, including complex felony cases. Work consists of case law research, preparation of legal briefs and motions, interviewing and preparing witnesses, and providing legal advice and expertise to law enforcement and other agencies during investigations. Conducts special investigations, as necessary. Work involves considerable public contact. Employee must exercise independent judgment, initiative, tact, and courtesy in various phases of work.

This position reports to the Commonwealth's Attorney and/or the Deputy Commonwealth's Attorney.
