The Fairfax County Park Authority (FCPA) is seeking an Engineer IV to be a part of one of the most highly regarded park systems in the country. As the county's largest landowner, with more than 425 parks, 23,000 acres of parkland, nine RECenters, eight golf courses, three lakefront parks, and more, FCPA is an exciting organization to be a part of and there are many opportunities for staff to make a difference at every level. Under the general direction of the branch manager, the Engineer IV is the resident professional engineer for land management issues in the Park Authority. This position leads, manages, and coordinates assignments that span all aspects of Park Authority land management programs, including easements, encroachments, and land records. The Engineer IV provides technical expertise and project and construction management leadership on work assignments that include plan review, land records review, and field inspections, to support the protection of FCPA land holdings, natural resources, and cultural resources. This position routinely works with agency staff and engineering and real estate professionals on land management and development issues to achieve negotiated solutions on infrastructure, private development, and telecommunications projects. In addition, the Engineer IV provides support for land acquisition, leasing, and other agency priorities. As needed, this position provides oversight in the branch, serving in an acting branch manager capacity in the absence of the branch manager. Must excel at working collaboratively with others, and contributing and leading in a team environment. Must be proficient with Microsoft Office Suite products (Word, Excel, PowerPoint, Outlook, etc.).
