Support <u>HB 600</u>, <u>HB 805</u>, & <u>SB 14</u>

HB 600 (Kilgore), HB 805 (Rasoul), and <u>SB 14 (McPike)</u> would permit any county or city to impose an additional local sales and use tax of up to 1 percent, if initiated by a resolution of the local governing body and approved by voters at a local referendum. The revenues of such local tax would be used solely for capital projects for the construction or renovation of schools. Any tax imposed shall expire when the costs for capital projects are to be repaid and shall not be more than 20 years after the date of the resolution passed.

Currently, this authority is limited to the qualifying localities of Charlotte, Gloucester, Halifax, Henry, Mecklenburg, Northampton, Patrick, and Pittsylvania Counties and the City of Danville. <u>HB 60 (Wright)</u> and <u>HB 193 (Cole)</u> would expand this authority to Prince Edward County and Stafford County respectively and are also supported by VACo.

These bills allow counties to exercise a local voter approved option to meet their community needs and are about creating parity between local governments.

House Version of Line of Duty Act (LODA) Benefits for Campus and Private Police Bill Falters

<u>HB 232 (Campbell)</u>, which provides employees of contributing nonprofit private institutions of higher education and contributing private police departments with the benefits granted to employees of participating employers under the Line of Duty Act, failed to recommend reporting in the House Public Safety Committee's Public Safety Subcommittee by a 4-2 vote. VACo supported the legislation.

The bill was drafted in response to the death of a Wintergreen Police Officer in the line of duty. There are currently less than 10 private police departments in the Commonwealth, though they provide the same services and duties of public departments. They are currently excluded from protection in LODA. VACo supports changes to LODA that would allow state authorized and trained private law enforcement agencies to participate in and contribute to the LODA program in a manner that does not create an unfunded mandate to local government and testified in support of the legislation.

The Senate companion to this legislation, <u>SB 466 (Obenshain)</u>, has been rereferred to the Senate Finance and Appropriations Committee.

VACo Supports Swatting Reimbursement to Localities

Legislation supported by VACo, which aims to allow localities to obtain a reimbursement of a "reasonable expense" for any cost incurred in responding to terrorism hoax incident, bomb threat, or malicious activation of fire alarm, was recommended to report from Subcommittee #2 of the House Counties, Cities, and Towns Committee by a vote of 7-1.

<u>HB 147 (Reid)</u> would allow a locality that has an ordinance requiring any person over 18 years of age convicted of false emergency communication to emergency personnel to reimburse such locality at the time of sentencing or in a separate civil action to bill a flat fee of \$2,500 or a minute-by-minute accounting of actual costs incurred. The bill also allows a locality that has an ordinance requiring any person under 18 years of age convicted of false emergency communication to emergency personnel to reimburse such locality at the time of sentencing or in a separate civil action to bill a flat fee of \$2,500 or a minute-by-minute accounting or in a separate civil action to bill a flat fee of \$2,500 or a minute-by-minute accounting of actual costs incurred, not to exceed \$2,500. Current law allows a flat fee of \$250 or a minute-by-minute accounting of actual costs incurred, in an amount not to exceed \$2,500.

VACo was happy to testify in support of this important update to enacted "swatting" <u>legislation</u> from last year. The senate companion for this legislation, <u>SB 656 (Favola)</u>, has been referred to the Senate Local Government Committee.

VACo Supports Photo Speed Enforcement in High-Risk Intersections

<u>SB 336 (Roem)</u> and <u>HB 521 (Laufer)</u> focus on the ability for localities to expand the use of photo speed monitoring within their jurisdiction but take different approaches in enabling the use of this public safety tool.

SB 336 would permit a state or local law enforcement agency to place and operate a photo speed monitoring device at a "high-risk intersection" segment located within the locality. A "high-risk intersection" is defined in the bill as, "... any highway or portion thereof that is part of or adjacent to an intersection identified in the manner provided in this section as one in which a traffic fatality has occurred since January 1, 2014." As the definition states, before operation of the photo speed camera, the state or local law enforcement agency must certify that a traffic fatality occurred in the "high risk intersection" looking to add photo speed enforcement, since January 1, 2014.

HB 521 would allow any locality to authorize, by ordinance, its local law enforcement agency to place and operate photo speed monitoring devices on "locality-designated highway segments." The bill defines a "locality-designated highway segment," as any highway or portion thereof designated in a local ordinance where photo speed monitoring devices may be placed and operated.

HB 521 lays out the qualifications that need to be met when localities move toward adopting such an ordinance and are as follows:

- The highway in question has a posted speed limit of 35 miles per hour or greater;
- The ordinance identifies the locality-designated speeding offense to be enforced by the photo speed monitoring device;
- Speeding, crash, or fatality data supports the need for stronger enforcement against speeding;
- In counties and towns whose roads are subject to the control and jurisdiction of the Department of Transportation, the locality-designated highway segment is in the secondary state highway system or is designated as a Virginia byway.

SB 336 and HB 521 are well tailored to localities and increase the ability for local governments to respond to constituent concerns regarding safety on local roadways. VACo is thankful to Senator Roem and Delegate Laufer as well as their respective staffs for bringing these bills forward. **VACo supports SB 336 and HB 521 as a public safety tool** and looks forward to speaking in favor of the bills when heard.

Visit King William County and the King William County Historic Courthouse

Location: 227 Courthouse Lane / Horse Landing Road Built: 1725 – 1726 Style: Georgian Architect: Unknown Contractor: Unknown

Description: The building faces south and is a one story red colored brick laid in Flemish bond and wood structure. The building is "T" shaped. The south front has five arches along the arcade. The recessed entrance is framed with white colored wood and with a small pediment above. The building has a steep hipped. In 1840, the building was enlarged with a unique stile and brick wall to enclose the court green.

Note: The courthouse is the oldest courthouse still in use in the United States. The second oldest courthouses is located in Salem County, New Jersey (1735). The third oldest is in Hanover County, Virginia (1737). The fourth oldest is in Charles City County, Virginia (1740). The fifth oldest is in Richmond County, Virginia (1748).

Gottschalk tapped as Mecklenburg County Administrator

Alex Gottschalk, who has served as Mecklenburg County deputy county administrator for the past two years, was appointed by the Mecklenburg County Board of Supervisors on Monday to fill the post of County Administrator. He takes over effective March 1.

Gottschalk succeeds Wayne Carter, who will retire Feb. 29 after working in the County Administration office for more than 34 years, nearly 20 of them as county administrator.

Gottschalk thanked the Board of Supervisors for the appointment. "I am so honored to be the next County Administrator for Mecklenburg County," he told board members at their monthly meeting in Boydton on Monday.

Gottschalk came to Mecklenburg in December 2021 as deputy

administrator to train under Carter. Prior to that, he was legislative policy and budget analyst for the City of Virginia Beach from 2017 to 2021.

Over the past year and a half, Gottschalk assumed greater responsibility for preparation of the county budget and finances as well as several special projects, among them the future use of the former Park View High School campus near South Hill.

He also took in the lead in crafting the county's legislative agenda for the past two years, which focuses on preserving the local sales tax options for counties, state education funding for new elementary schools, and funding for local libraries.

Other priorities which he identified include Lyngbya remediation for Lake Gaston, support for fire and EMS services and the Virginia Alcohol and Safety Program (VASP), and local representation on the Virginia Passenger Rail Authority Board which is charged with expanding high speed rail service between Richmond and Raleigh, N.C.

Gottschalk earned his undergraduate and graduate degrees from the University of North Carolina in Chapel Hill. He graduated in 2014 with a B.A. in American Studies with a concentration on Southern Studies and a B.A. in History. He earned a Master's of Public Administration in 2017.

"When I left the UNC School of Government, I set a goal to be a county administrator or manager in a small rural community. I am beyond humbled to achieve this dream," he said.

As the county's top executive, Gottschalk promised to maintain an open door policy. "I am thrilled to listen to your voices," he said. "Together, we will strive to ensure Mecklenburg is and will be a welcoming, thriving community, with a bright 21st Century existence."

State Revenues on Track as General Assembly Begins Consideration of Governor's Budget

Secretary of Finance Stephen E. Cummings <u>briefed</u> members of the House Appropriations Committee on January 15 on December revenues and is scheduled to provide a similar update to the Senate Finance and Appropriations Committee on January 16. Secretary Cummings reported that state General Fund revenues are in line with the forecast embedded in the Governor's budget proposals, with fiscal year-to-date General Fund revenues 2.8 percent, or \$363.2 million, ahead of projections. Setting aside nonwithholding collections and refunds, year-to-date revenue collections are \$85.8 million ahead of the forecast. As Secretary Cummings summarized the situation in his remarks, revenues are outperforming the forecast, but the extent of the overperformance is between \$85.8 million and \$363.2 million, with the uncertainty largely due to the timing of payments and refunds under the new Pass-Through Entity Tax. This mechanism allows certain business owners to elect to pay state income tax at the entity level (rather than the entity's income being passed through to the business owner and the owner paying individual income taxes on that income) and then to receive a corresponding refundable income tax credit. On a fiscal year-to-date basis, individual income tax collections are up 6.4 percent, and are ahead of projections by \$436.6 million, while sales and use taxes are slightly below projections.

Secretary Cummings noted that the revenue forecast incorporated into the Governor's budget proposal is intentionally conservative due to uncertainty surrounding domestic and foreign economic conditions. House Appropriations Committee Staff Director Anne Oman suggested that given the ongoing strength in FY 2024 revenue collections, a mid-session revenue reforecast might be possible, depending on January revenue collections; if the forecast were revised, that update would take place in February, in time for legislators to incorporate it into budget deliberations. January collections will provide additional information on holiday season sales tax collections, as well as withholding and nonwithholding income tax collections.

Following Secretary Cummings's presentation, the House Appropriations Committee staff provided an overview of the introduced budget; the presentation may be found at <u>this link</u>. The Senate Finance and Appropriations Committee staff will provide their budget briefing on January 17. The process of proposing amendments to the introduced budget is underway; legislators' deadline to submit amendments to the Governor's budget was January 12, and the full text of all members' amendments will be released later this week. VACo is working on a set of amendments to address county priorities, and will provide details in a future edition of *Capitol Contact* so that members can assist in advocating on behalf of these requests.


