General Assembly Considers Vetoes and Amendments at Reconvened Session, Sets the Stage for May 13 Special Session



Legislators met in Richmond on Wednesday to act on the Governor's vetoes and amendments to legislation from the 2024 regular session. In advance of the reconvened session, speculation ran rampant as to whether the legislature would reject the Governor's amendments to the FY 2024 "caboose" and 2024-2026 biennium budgets, potentially courting a rare veto of the budget bills, or if the legislature might accept some amendments and reject others. On Wednesday afternoon, the Governor and legislative leadership provided some answers by announcing a path forward to avert an impasse on budget revisions. Legislators will convene in a special session beginning on Monday, May 13, with a planned vote on a budget compromise on May 15. As part of this process, legislators took several procedural votes during the reconvened session to allow budget negotiations to continue, first by ruling the Governor's 242 amendments to the budget bills "not specific and severable," (thus barring any further consideration of the amendments during the reconvened session) and then by voting to take no further action on the underlying budget bills (allowing new bills to be proposed in the special session). Both chambers subsequently adopted a resolution applying to the Governor to call a special session and instructing budget negotiators to use the budget passed by the General Assembly in March as the basis for deliberations.

Governor's vetoes

The Governor issued vetoes for 153 bills, all of which were sustained by the legislature, so these bills will not become law at this time. VACo reported in last week's *Capitol Contact* on bills of interest to local governments that were vetoed by the Governor; that report may be found at **this link**. The veto for **HB 805 (Rasoul)**, which would have authorized all localities to impose up to a 1 percent sales and use tax for school capital needs, after approval in a referendum, was sustained by the House of Delegates without a recorded vote, as were all other vetoed bills in the House. The vote in the Senate to override the Governor's veto of the companion bill, **SB 14 (McPike)**, failed on a vote of **25-15**, as this fell two votes short of the 2/3 majority required in the Senate to override and advance to the House for consideration. VACo thanks all its members and those who advocated for these bills and the override effort.

Governor's amendments

The legislature agreed to the Governor's amendments for 60 bills and rejected amendments, in whole or in part, to 55 others. Bills for which the General Assembly rejected the Governor's amendments are now returned to the Governor for final action within 30 days; the Governor may sign or veto these bills, or take no action, in which case the bills would become law without his signature.

Following is an update on the General Assembly's actions on bills with gubernatorial amendments of interest to local governments.

Teacher salaries: HB 187 (Clark)/SB 104 (Lucas), as passed by the General Assembly, require the state to provide its share of salary increases over the next three legislative sessions sufficient to raise the average teacher salary in Virginia to at least the national average teacher salary by the end of the next biennium, with the increases phased in at increments specified in the bill.

The Governor's amendments instead would require an annual review of teacher compensation (rather than the current biennial review), and require the budget bills introduced in the next two sessions to propose funding for compensation incentives for Standards of Quality-funded instructional and support position salaries to remain competitive (at or above the national average).

General Assembly action: Rejected the Governor's amendments for both bills.

K-12 funding for At-Risk Program and English language learners: HB 624 (Rasoul)/SB 105 (Lucas) revise the At-Risk Add-On program to create a new At-Risk program and funding formula and require staffing for English language learners to be based on student proficiency levels, as well as revising the National Teacher Certification Incentive Program. The bills also direct the Department of Education to collect data on English language learner expenditures and student proficiency levels, and to develop a plan for revised special education staffing requirements that would address needs in each school division.

The Governor's amendments propose to add a reenactment clause and direct the Department of Education to collaborate with the Joint Subcommittee on Elementary and Secondary Education Funding to determine the impact of modifying the proxy used to estimate the number of at-risk students, as

well as the impact of eliminating the Standards of Quality Prevention, Intervention, and Remediation program.

General Assembly action: Rejected the Governor's amendments for both bills.

<u>Community schools</u>: <u>HB 625 (Rasoul)/SB 608 (Aird)</u> establish the Office of Community Schools within the Department of Education and direct the new Office to administer the Community School Development and Implementation Planning Grant in accordance with funding priorities set out in the bill.

The Governor's amendments propose to remove the provisions related to the grant program.

General Assembly action: Agreed to the Governor's amendments.

Building code enforcement for bus shelters: HB 285 (McQuinn) allows the local building official to enforce the Uniform Statewide Building Code for certain bus shelters and absolves the state from liability for any bus shelters built on state property in this situation. As passed by the General Assembly, the bill has a July 1, 2025, sunset date.

The Governor's amendment proposes to extend this sunset until July 1, 2027.

General Assembly action: Agreed to the Governor's amendments.

Local authority to reduce speed limits: HB 1071 (Carr) allows any locality to reduce the speed limit to less than 25 miles per hour (but not less than 15 miles per hour) on highways within its boundary that are located within a business or residence district, provided that signage and notice requirements are met.

The Governor's amendments propose to add a reenactment clause to the bill and require the Department of Transportation to study the issue.

General Assembly action: Rejected the Governor's amendments.

Skill games: SB 212 (Rouse) establishes a regulatory and tax framework for skill games, as defined in the bill.

The Governor's amendments make significant changes to the legislation, including the following revisions:

• Under the bill as passed by the General Assembly (the enrolled bill), up to four skill games machines would be allowed at any ABC retail licensee and up to ten would be allowed at a truck stop. The Governor's amendments would allow up to three "electronic gaming devices," as defined in the bill, at host locations that are licensed to sell lottery tickets (but are not truck stops) and up to seven of the machines at truck stops that are licensed to sell lottery tickets. The Governor also proposes a statewide cap of 20,000 electronic gaming devices statewide.

- SB 212 as enrolled would impose a monthly tax of 25 percent of gross receipts for each skill game machine. The Governor appears to propose a 35 percent tax on gross profits generated from the play of electronic gaming devices, with frequency of remittance to be determined by Lottery Board regulations.
- SB 212 as enrolled would distribute skill game tax revenue as follows: 2 percent to the Problem Gambling Treatment and Support Fund; 6 percent to the Department of Taxation or Virginia Lottery Board for administrative costs; 15 percent to the host localities; 1 percent to the local law enforcement agency in the host locality; 1 percent to the Department of State Police, and 75 percent to the PreK-12 Priority Fund to be used for public education purposes. The Governor's amendments would distribute revenue as follows: 5 percent of gross profits to the Gaming Regulatory Fund and 5 percent to the College Partnership Laboratory School Fund; from the remaining funding, 15 percent to the host locality; 2.5 percent to the Problem Gambling Treatment and Support Fund; 75 percent to the Elementary and Secondary Education Fund (which would be appropriated to local governments and school divisions for public education purposes); 2.5 percent to the Department of State Police, and 5 percent to the Interstate 81 Corridor Improvement Fund.
- The Governor's amendments would authorize the governing body of a county or city to hold a
 referendum or adopt a local ordinance on the question of whether electronic gaming devices
 should be prohibited in the locality.
- The Governor's amendments would bar electronic gaming devices within 35 miles of any casino gaming establishment or horse racetrack or satellite facility, or within 2,500 feet of any school, child day center, or place of worship.

General Assembly action: Rejected the Governor's amendments.

Recordation and property tax exemptions: HB 568 (Askew)/SB 517 (Williams Graves) eliminate the recordation tax exemption for the Virginia Division of the United Daughters of the Confederacy and eliminate the real and personal property tax exemption for this group and several other entities.

The Governor's amendments propose to add reenactment clauses to the bills and direct the Department of Taxation to study the effect of recordation tax exemptions and property tax exemptions granted prior to 1971 on state and local government revenues.

General Assembly action: Rejected the Governor's amendments.

Pole attachments and telecommunications services: Among other provisions, **HB 800 (Herring)**/ **SB 713 (Marsden)** direct the State Corporation Commission to resolve disputes involving pole access within 90 days, and all other related matters within 120 days.

The Governor's amendments propose to allow either period to be extended by up to 60 days by Commission order.

General Assembly action: Agreed to the Governor's amendments.



2024 Stormwater Local Assistance Fund Needs Survey



In 2019, the Stormwater Management Act (Code of Virginia § 62.1-44.15:24 *et seq.*) was amended to require the Department of Environmental Quality (DEQ) to annually determine an estimate of the amount of Stormwater Local Assistance Fund (SLAF) matching grants expected to be requested by local governments for eligible projects related to planning, designing, and implementing stormwater best management practices.

As of April 16, the DEQ seeks local input to identify the future funding needs for SLAF eligible nutrient reduction projects in the Commonwealth. The DEQ has prepared a survey to solicit this input. **Linked here** is the survey document to facilitate the gathering of project details prior to survey completion. **Please open the survey link only when you are prepared to enter the information requested.**

Virginia Receives Over \$100 Million in Opioid Settlement Funds

~ The approximate total of \$108.4 million stems from seven different opioid settlements ~

RICHMOND, Va. – Attorney General Jason Miyares today announced that Virginia has received another round of payments from settlements with opioid manufacturers, major pharmaceutical distributors, and retail pharmacy chains totaling approximately \$108.4 million. This includes all of the shares in this round of payments that will be allocated to the Commonwealth of Virginia, the Opioid Abatement Authority, and localities.

"Thanks to the unwavering dedication of my Consumer Protection team, Virginia just received over \$100 million in opioid settlement funds that will enable us to more effectively prevent, reduce, and treat addiction at a localized level," said Attorney General Miyares.

The approximate amounts received from each settlement in this round of disbursements:

Teva: \$6.346 millionAllergan: \$7.033 million

• CVS: \$7.831 million

Walgreens: \$15.155 millionWalmart: \$61.621 million

• Cencora (formerly AmerisourceBergen): \$5.219 million

• Cardinal Health: \$5.243 million

Cencora and Cardinal Health, two major pharmaceutical distributors, began sending opioid settlement payments to Virginia in 2022. Additionally, Cencora and Cardinal Health elected to exercise an option in the Distributors settlement that allows them to prepay their settlement installments that are scheduled for 2027 at a discount in 2024.

Drug manufacturers Teva and Allergan, as well as retail pharmacy chains CVS, Walgreens, and Walmart, settled with Virginia in 2023. These are the first payments received from those settlements.

The approximate allocation of funds received:

• Commonwealth of Virginia: \$16.992 million

• Opioid Abatement Authority: \$59.178 million

• Localities: \$32.279 million

The Opioid Abatement Authority is the entity responsible for distributing opioid settlement funds to localities and state agencies on a grant-application basis.

To date, Virginia has secured over \$1.1 billion in opioid settlement funds.

The above article was released by the Virginia Attorney General's Office on April 17.

Local government billing on behalf of volunteer fire departments: HB 852 (Williams) allows a local governing body to enact an ordinance regarding billing on behalf of volunteer fire departments for the provision of emergency medical services.

The Governor's amendments propose to revise the bill to allow billing on behalf of volunteer fire departments for the support of a licensed emergency medical services agency.

General Assembly action: Agreed to the Governor's amendments.

<u>Utility disconnections</u>: <u>HB 906 (Shin)/SB 480 (Aird)</u> limit utility disconnections for nonpayment under certain circumstances and require certain notices prior to disconnection.

The Governor's amendments propose to require notice to be provided via at least one method listed in the bill (as passed by the General Assembly, notice must be provided through at least two methods), and bar disconnection for residential customers until an account is 45 days in arrears (rather than 60 days, as in the enrolled bills).

General Assembly action: Agreed to the Governor's amendments.

Regulation of liquid nicotine and nicotine vapor products: HB 1069 (Willett)/SB 550 (Deeds) ban the sale of liquid nicotine and nicotine vapor products that are not certified to the Attorney General as authorized for marketing by the Food and Drug Administration (or meeting certain other requirements as spelled out in the bill). Under the bills, the Attorney General may bring a court action to enjoin a violation and a Commonwealth's Attorney, or a county, city, or town attorney would have the same authority with the concurrence of the Attorney General.

The Governor's amendments propose to remove the Attorney General's authority to bring the court action or to concur with such an action by a Commonwealth's Attorney or local government attorney. The amendments also propose to allow the Commonwealth's Attorney or local government attorney to recoup costs of investigation and attorney fees and would provide that civil penalties in an action brought in the name of a locality would be paid into the local general fund.

General Assembly action: Agreed to the Governor's amendments.

Penalty for demolition of historic structures: HB 1415 (McQuinn) authorizes any locality to establish a civil penalty for the razing, demolition, or moving of a building or structure located in a historic district or designated as a historic structure or landmark in violation of local ordinance; the civil penalty would be limited to the market value of the property (to include the value of the building or structure and the value of the underlying real property).

The Governor's amendments would revise the limitation on the civil penalty to provide that the penalty would be limited to twice the market value of the razed, demolished, or moved building or structure.

General Assembly action: Agreed to the Governor's amendments.

Procurement: SB 260 (DeSteph) provides that in case of a tie bid, preference would first be given to goods produced in Virginia, and then to goods produced in the United States.

The Governor's amendments propose to add a process for a preference for Virginia-produced goods in the procurement of goods by manufacturers, and add language exempting a project or procurement from the bill's requirements in the case of a conflict with federal law or regulation. The Governor also proposes to add a July 1, 2027, sunset date, and to require a report from the Department of General Services.

General Assembly action: Agreed to the Governor's amendments.

Resilient Virginia Revolving Fund: HB 673 (Feggans) directs the Department of Conservation and Recreation to weight projects in low-income geographic areas and projects incorporating nature-based solutions when making loans and grants to local governments from the Fund.

The Governor's amendments would revise the bill to weight projects in low-income geographic areas and projects in a locality designated as having a very low community resilience rating, as determined by the Department.

General Assembly action: Agreed to the Governor's amendments.

Crisis receiving center/crisis stabilization unit regulations: SB 569 (Deeds) directs the State Board of Behavioral Health and Developmental Services to revise its regulations to authorize the appropriate and safe use of seclusion in crisis receiving centers and crisis stabilization units, and directs a workgroup to propose additional regulations allowing for evidence-based and recovery-oriented seclusion and restraint practices and alternative behavior management practices to limit the use of seclusion and restraint.

The Governor's amendment would add an emergency clause to the bill.

General Assembly action: Agreed to the Governor's amendments.



You are VAcorp

You are not merely a customer of VAcorp; you *are* VAcorp! We are both owned and governed by you – our members! VAcorp is created under 15.2-2700 of the local government code where all assets and surplus belong to the members. In addition, VAcorp is controlled by a Supervisory Board that is elected from and by our members. The Board determines and approves all major risk pool decisions, and as a voting member, you have a voice in the decisions that matter most.

Know Who You Are

Because you are VAcorp itself, we think it is critical that you understand exactly what VAcorp is and why it exists. Many simply think of us as their "insurance carrier" – writing customized coverages and handling claims when they occur – but we are so much more!

Our History

The Birth of Risk Pools

VAcorp is not an insurance company, but rather a Risk Pool.

Unstable economic conditions in the mid-1980s led to a commercial insurance crisis with ballooning premiums and widespread policy cancellations. As a result, Risk Pools began to form as an alternative to volatile traditional carriers, allowing Pool members to exert more control over their coverages and costs. Today, almost all public sector entities throughout the country get their coverage from Risk Pools rather than from commercial insurance companies.

VAcorp's Origin

VAcorp was founded by a handful of Virginia counties in 1993. The ultimate goals of the program were to provide **cost stability**, the most **comprehensive coverages** possible, and **custom services** tailored specifically to the unique needs of our members. While we are pleased by how well our prices compare against the competition, our goal was never to guarantee the lowest cost. Instead, we promised to avoid the wild price swings that we've seen in other providers and provide stable pricing year after year, and that is exactly what we have delivered. VAcorp rates are actually **lower today in 2024 than they were in 1993!**

VAcorp's Growth

Today, VAcorp is the **largest self-insurance risk pool** for public sector entities in the Commonwealth with a membership retention rate of better than 98%. Over the years, we have expanded beyond counties to include municipalities, school divisions, authorities, volunteer fire & rescue companies, state agencies, and non-profits funded by taxpayer dollars. **Over 560 members** have joined VAcorp, including 8 of the 10 largest counties, 8 of the 10 largest cities, and 8 of the 10 largest school divisions. We believe that the extraordinary success of the program can be attributed to our unwavering commitment to our founding principles.

VAcorp Exists to Serve You

VAcorp was created solely to serve Virginia's public sector entities, and from day one until now, we have never lost sight of that purpose. Because we answer only to our members, every decision is designed to benefit the group over the long haul.

VAcorp advocates for local government through a myriad of partnerships with affiliated associations including: VACo, VSBA, VLGMA, VASS, VFGOA, VASBO, LGA, Regional Jail Association, PDC, etc. While there is a cost associated with these partnerships, they add value to the group by aiding in our ability to lobby the General Assembly on behalf of our members.

You may not always see the immediate payoff, but every VAcorp decision is made in alignment with our vision to serve our members and promote the health and longevity of your program.

Take a look at a few of VAcorp's milestones over the years:

- 1993 VAcorp is established with 12 founding members and less than \$700,000 in annual contribution.
- **1998** VAcorp terminates service contract with claims administration vendor and hires staff to promote more control and efficiency.
- 1999 VAcorp offers coverage to K-12 Public Schools across the Commonwealth.
- 2001 VAcorp begins offering Public Officials Liability coverage in response to VArisk offering limited coverage.
- **2004** VAcorp begins providing Environmental Liability coverage to all members at no additional cost. Even in 2024, VAcorp is the only provider offering this coverage with a low \$25,000 deductible. Other providers offer this coverage with a \$250,000 deductible.
- **2008** VAcorp responded to the great recession by freezing rates and providing financial relief with over \$8,000,000 in dividends to members.
- **2011** VAcorp introduces Line of Duty Act (LODA) coverage, creates the only LODA trust in the state, and absorbs existing LODA losses in response to the state pushing this cost to the local level. VAcorp paid all of its members 2010 past liability for over \$1,000,000.
- 2013 VAcorp merges with the VSBA Self-Insurance Group and assumes their liabilities to prevent School Boards from being assessed. This action saves Local Governments in excess of \$5,000,000.
- **2013** VAcorp becomes the first to offer Cyber Risk coverage in Virginia offering the broadest coverage available to local governments anywhere in the US.
- 2016 VAcorp offers Student Accident and Catastrophic Accident coverage in order to fill VHSL coverage gaps.
- **2020** VAcorp provides over \$5,000,000 in rate credits during the COVID pandemic to assist members.
- **2023** VAcorp includes security risk management coverage (active shooter) for all members (coverage has been included for Schools since 2013).




