The position is responsible for coordinating, overseeing and evaluating a variety of planning/community development functions, activities, programs and services, to include planning studies, the comprehensive plan, land development ordinances, zoning, building permits/inspections, property maintenance and code enforcement; serves as an advisor to the City Manager, City Council, Planning Commission, and other City officials, residents, the business community and the general public on planning related issues.

Examples of Duties

Plans, organizes, and directs the activities and staff within the department. Provides leadership and strategic direction for the City's land use planning and redevelopment processes. Organizes and oversees development planning, small area plan development, zoning administration, historic preservation, and demographic/census analysis. Directs staff and activities related to building permits and inspections, property maintenance and code enforcement. Interprets and analyzes statistical and technical information in the formulation and presentation of long-range and short-range development and compliance plans. Serves as zoning administrator. Reviews and coordinates site plans. Conducts research related to City Code revisions. Serves as staff for the planning commission, board of zoning appeals, architectural review, wetlands review, and other boards and commissions as assigned. Sits on local and regional planning boards and councils. Reviews building permits from a zoning perspective and addresses concerns and questions. Performs field inspections to gather data relevant to the development review process and/or to verify development projects comply with approved plans. Develops and presents public education materials. Addresses public and professional inquiries.
