Director of Finance serves as a member of the agency's Executive Leadership Team and is responsible for collaborating with other agencies and community leaders to advance CBH's mission and strategic plans. Serves as agency representative on regional and state Finance Councils and work groups.

- Directs all agency accounting functions for CBH and component units
- Maintains compliance with applicable state, federal and local accounting and auditing requirements
- Directs, develops and implements fiscal policy and procedure
- Develops / supervises preparation of complex reports, reconciliations, and analyses to Board of Directors, internal management and external parties

- Oversees preparation of the agency's 990 tax filing
- · Coordinates with management of the agency's property and liability insurance program
- · Directs compliance with third party billing requirements and client accounts receivable management
