Qualification Requirements

Basic knowledge of planning and zoning activities, development principles, and code enforcement practices; Ability to prepare budgets and bookkeeping documents; Ability to read and interpret government codes, blueprints, plans and architectural designs; Ability to gather, interpret and prepare technical information and reports; Ability to pay attention to detail and ask questions as needed; Ability to establish and maintain effective working relationships with County, State and Federal officials, contractors, architects, land developers, attorneys and the general public.

Special Requirements

Associate's/Technical degree with coursework in planning, public policy, engineering, surveying or a related field, and experience in urban planning, zoning administration/enforcement, community development, or equivalent combination of education and experience. A Bachelor's degree is preferred.

Requires the possession of an appropriate driver's license valid in the Commonwealth of Virginia and certification as a Certified Zoning Officer (CZO) by the Virginia Association of Zoning Officials (VAZO) is required within 2 years of hiring date.
