### Essential Functions/Typical Tasks

Prince George County is currently seeking qualified applicants for the position of Senior Real Estate Appraiser. This position will be responsible for conducting field data collection and appraisal work; analyzing market data; developing appraisal procedures and schedules; preparing and maintaining computerized records and files; assisting the public with real estate appraisal questions. The incumbent will also be responsible for researching appeals, reviewing records, contacting owners, visiting property and updating records. Additional responsibilities will include, checking assessments and sales and adjusting values as needed, collecting data relative to land valuations and applying such data in appraising specific parcels of land and maintaining network databases and various software programs including VISION/CAMA, a variety of Access databases and GIS. The position will serve as the Real Estate Assessor's Office Database Administrator.
